evidence available, that the total allowable catch for the purpose of limiting the quantity of rock lobster, which may be harvested during the period of 1 November 2009 to 30 April 2010 is as specified in the third column of the table below opposite the period specified in column two thereof and for area specified directly opposite that period in the first column of that table:
