NOTIFICATION OF CANDIDATES, POLLING DAY AND POLLING STATIONS: BY-ELECTION FOR A MEMBER OF THE CAPRIVI REGIONAL COUNCIL IN RESPECT OF THE SIBBINDA CONSTITUENCY: ELECTORAL ACT, 1992

In terms of section 64(5) of the Electoral Act, 1992 (Act No. 24 of 1992), it is made known that –

- (a) a poll shall take place on 14 September 2012, from 07h00 until 21h00 for the election of a member of the Caprivi Regional Council in respect of the Sibbinda Constituency;
- (b) the persons whose names, registration numbers and residential addresses appear in Column 1 of the Schedule have, in terms of section 64(1) of the Act, been declared to be duly nominated in respect of the election of a member referred to in paragraph (a), with an indication of the political party by whom each candidate was nominated; and
- (c) in terms of section 73 of the Act, polling stations in respect of the election, referred to in paragraph (a), have been established at the places mentioned in Column 2 of that Schedule.

MEETING OF THE SELECTION COMMITTEE TO INTERVIEW CANDIDATES FOR APPOINTMENT AS MEMBER OF THE ELECTORAL COMMISSION

In terms of subsection (9) of section 5 of the Electoral Act, 1992 (Act No. 24 of 1992), I convene a meeting of the Selection Committee, established by subsection (12) of that section, to be held on Thursday, 13 September and Friday, 14 September 2012 in the Electoral Commission Training Centre, at the Headquarters of the Electoral Commission of Namibia, 67 - 71 Van Rhijn Street, Windhoek from 09h00 for the purpose to interview the applicants, who's names and date of birth are set out in the Table below, for appointment as a member of the Electoral Commission.

Any registered voter may, under subsection (19) of section 5 of the Electoral Act, 1992 (Act No. 24 of 1992), at any time before the commencement of the meeting of the Selection Committee, convened in terms of subsection (9) of that section, in writing lodge with the secretary of the Selection Committee an objection against the appointment of any person listed below in the Table, as a member of the Commission and must, if so directed by the Selection Committee in writing, appear before the Selection Committee, where such registered voter must answer questions put to him or her by the members of the Selection Committee and by the person against whose appointment he or she objected.
