DECLARATION OF ORANGEMUND TO BE AN APPROVED TOWNSHIP: KARAS REGIONAL COUNCIL

In terms of section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance 11 of 1963) as amended, I declare the area situated on Portion 17 (a portion of Portion 1) of the Farm Oranjemund Townlands No. 165 in the Karas Region, Registration Division "N" and represented by General Plan No. N86 (No. A321/2008), to be an approved township.

The conditions, subject to which the application for permission to establish the township concerned has been granted, are set forth in the Schedule below in terms of the said section 13.

SCHEDULE

1. Name of township:

The township shall be called Oranjemund.

2. Composition of township:

The township comprises 310 erven number 1 to 310 and the remainder streets as indicated on General Plan N86.

3. Reservation of erven:

- (1) The following erf is reserved for the State: for a police station purposes: Erf 226
- (2) The following erven is reserved for Local Authority:
 - for Local Authority purpose: Erf 1; and
 - for Public Open Spaces: Erven 280 to 310.

4. Conditions of title:

The following conditions shall be registered in favour of the Local Authority against the title deeds of all erven, except the erven referred to in paragraph 3:

- (1) The erf is subject to the reservation for the Local Authority of the right of access and use without compensation of the area three meters parallel with any boundary of such erf, for the construction and maintenance of municipal services in respect of water, sewerage, drainage, electricity and gas, which right includes the right to place on such erf temporarily any material that may be excavated during such operation on their erf or any adjacent erf.
- (2) No offensive trade whatsoever shall be established or conducted on the erf.

For the purpose of this paragraph, "offensive trade" means any of the businesses, trades, works or institutions mentioned in regulation 1 (a) of the regulations promulgated under Government Notice 141 of 1926.

- (3) The following conditions shall, in addition to those enumerated in paragraph 4 (1) be Registered in favour of the Local Authority against the title deeds of Erven 3 to 225, 233, to 235 to 279:
 - (a) the erf shall only be used for residential purposes.
 - (b) the building value of the main building, including the outbuildings, to be erected on the erf shall be at least four times the valuation of the erf.
- (4) The following conditions shall, in addition to those enumerated in paragraph 4 (1) be registered In favour of the Local Authority against the title deeds of Erven 227 to 232, 236 and 237:
 - (a) the erf shall only be used for flats and business purposes other than factory as defined in section 3 of the Factories, Machinery and Building Works Ordinance, 1952 (Ordinance 34 of 1952): Provided that where a building is erected for business purposes the ground floor of main building, shall be contracted on the same floor as any business or office.
 - (b) the main building value of the main building, including the outbuildings, to be erected on the erf shall be at least three the valuation of the erf.
- (5) The following conditions shall, in addition to those enumerated in paragraph 4 (1) be registered in favour of the Local Authority against the title deed of Erf 2:
 - (a) The erf shall only be used for private open space or club grounds for sport,
 - (b) The building value of the main building, including the outbuildings, to be erected on the erf shall be at least equal to the valuation of the erf.

It is hereby made known -

- (a) that in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), the Minister has, in the district of Windhoek:
 - (i) under section 22(1)(b) of the said Ordinance:
 - (aa) declared a portion of trunk road 9/1 as described in Schedule I, shown by coordinates in Schedule II and indicated on sketch-map P2337 by the symbols A-B-C-D-E-I-J-K-L-M-N be proclaimed; and
 - (bb) declared main road 53(b) as described in Schedule III and shown on sketchmap P2337 by the symbols F-G-H-E be proclaimed.
 - (ii) under section 22(1)(c) of the said Ordinance closed the roads described in
 - (aa) the Schedule to Government Notice 213 of 1974 and shown on sketch-map P535; and

- (bb) the Schedule to Government Notice 214 of 1995 and shown on Sketch-map P1559.
- (b) in terms of section 23(3) of the said Ordinance the Minister has:
 - (i) under section 23(1)(a) of the said Ordinance the road described in paragraph (a)(i) (aa) above be declared a portion of trunk road 9/1; and
 - (ii) under section 23(1)(b) the road described in paragraph (a)(i)(bb) above be declared main road 53 (b).
