### MINISTRY OF URBAN AND RURAL DEVELOPMENT

No. 33

DECENTRALISATION OF CERTAIN FUNCTIONS OF MINISTRY OF LAND REFORM TO ALL 14 REGIONAL COUNCILS: DECENTRALISATION ENABLING ACT, 2000

Under section 2 of the Decentralisation Enabling Act, 2000 (Act No. 33 of 2000), and after consultation with the Minister of Land Reform, I decentralise, in consultation with Cabinet, by way of delegation the functions as defined in Column 2 of the Schedule -

- (a) from the Line Ministry as identified in Column 1 of the Schedule; and
- (b) to the regional councils as identified in Column 3 of the Schedule,

The decentralisation by delegation of the functions of the line Ministry to regional councils as indicated in the Schedule is -

- (a) made in respect of the entire area of such regional council;
- (b) not subject to any terms or conditions; and
- (c) effective from 1 March 2016.
