PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

No. 1 of 2016: Appropriation Act, 2016.

Act No. 1, 2016

APPROPRIATION ACT, 2016

ACT

To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2017.

(Signed by the President on 9 May 2016)

BE IT ENACTED as passed by the Parliament, and assented by the President, of the Republic of Namibia, as follows:

Appropriation of amounts of money for financial requirements of State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated for the financial requirements of the State during the financial year ending 31 March 2017 as a charge to the State Revenue Fund.

Short title

2. This Act is called the Appropriation Act, 2016.
