PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

- 1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.
- 2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the Government Gazette office, Private Bag 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than **12h00** on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.
- 3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.
- 4. Only legal advertisements shall be accepted for publication in the *Government Gazette* (Estates) and are subject to the approval of the Permanent Secretary, Ministry of Justice, who may refuse the acceptance of further publication of any advertisement.
- 5. The Ministry of Justice reserves the right to edit and revise copy and to delete there from any superfluous detail.
- 6. Advertisements must as far as possible be typewritten. The manuscript of advertisements must be written on one side of the paper only and all proper nouns plainly inscribed. In the event of any name being incorrectly printed as a result of indistinct writing, the advertisement can only be reprinted on payment of the cost of another insertion.

- 7. No liability is accepted for any delay in the publication of advertisements/notices, or for the publication of such on any date other than that stipulated by the advertiser. Similarly no liability is accepted in respect of any editing, revision, omission, typographical errors or errors resulting from faint or indistinct copy.

- The forfeiture order dated 22 January 2016 is varied as follows:
 - 1.1. By replacing paragraph 2 (2A) with the following:
 - 1.1.1 Detective Inspector Hendrick Mukudesa Mulele ("Inspector Mule") of Rundu Police Station in Rundu or, (in Inspector's Mulele absence, a authorised member of the Rundu Police Station in Rundu), who is currently in control of the properties in terms of the forfeiture of property order, is authorised to destroy 1130 boxes of cigarettes seized under Rundu CR 33/05/2015 in conjunction with Customs officials.
- 2. The order will take effect 30 days after publication of this order in the Government Gazette unless there is an application made under section 65 or section 66 of POCA.
- Inspector Mulele must within 30 days after the destruction of the cigarettes file a with the Registrar of this Court explaining the steps that was taken in the destroying of the cigarettes.

- 1.  - 2.1 deposit the positive balance in Standard Bank, business account nut 60001334785 held in the name of T and H Trading Close Corporation including any interest that may have accrued thereon into the Asset Recovery Account.
