**AMENDMENT OF REGULATIONS RELATING TO MEDICINES AND RELATED SUBSTANCES: MEDICINES AND RELATED SUBSTANCES CONTROL ACT, 2003**

Under section 44 of the Medicines and Related Substances Control Act, 2003 (Act No. 13 of 2003), after consultation with the Namibia Medicines Regulatory Council, I have amended the regulations set out in the Schedule.

## SCHEDULE

### Definitions

1. In these regulations “the Regulations” means the Regulations Relating to Medicines and Related Substances published under Government Notice No. 178 of 25 July 2008, as amended by Government Notices No. 28 of 27 February 2015 and No. 316 of 31 December 2015.

### Amendment of regulation 11 of Regulations

2. Regulation 11 of the Regulations is amended in subregulation (1) by the -
- (a) substitution for paragraph (1) of the following paragraph:
- “(1) in the case of a medicine classified as a scheduled substance as contemplated in section 29(1) of the Act, the letter “NS” followed by the number of the relevant Schedule, in a legibility of at least N.6, and surrounded by a square border;”;
- (b) deletion of paragraphs (n) and (p).

### Amendment of regulation 14 of Regulations

3. Regulation 14 of the Regulations is amended in subregulation (1) by the -
- (a) substitution for paragraph (a) of the following paragraph:
- “(a) the words “veterinary medicine”, “for animal use only”, or “for veterinary use only;”;
- (b) deletion of paragraph (f).
