CANDIDATES AND POLLING DAY OF BY-ELECTION FOR MEMBER OF OSHANA  
REGIONAL COUNCIL: OSHAKATI EAST CONSTITUENCY: OSHANA REGION:  
ELECTORAL ACT, 2014**

In terms of subsection (1) of section 64 of the Electoral Act, 2014 (Act No. 5 of 2014) I make known that on the recommendation of the Electoral Commission, I have under the powers vested in me by -

- (a) paragraph (a)(ii) of that subsection determined -
- (i) 15 July 2019 as the day on which submissions of nominations of candidates for the election of a member of the Oshana Regional Council, Oshakati East Constituency in the Oshana Region, must take place;

**DETERMINATION OF PERIOD FOR SUPPLEMENTARY REGISTRATION OF VOTERS  
FOR PRESIDENTIAL AND NATIONAL ASSEMBLY ELECTIONS IN RESPECT OF ALL  
CONSTITUENCIES IN NAMIBIA: ELECTORAL ACT, 2014**

Under the powers vested in me by section 25(2) of the Electoral Act, 2014 (Act No. 5 of 2014), read with section 38(1) of that Act and on the recommendation of the Electoral Commission of Namibia, I determine the period extending from 8 July 2019 to and including 27 July 2019 to be the period during which the supplementary registration of voters must take place in respect of all constituencies in Namibia.
