REGULATIONS RELATING TO PRICES FOR RESELLING OF PETROL AND DIESEL: PETROLEUM PRODUCTS AND ENERGY ACT, 1990

SCHEDULE

PRICES AT WHICH PETROL AND DIESEL MAY BE RESOLD

Definitions

1. In these regulations, a word or an expression to which a meaning has been assigned in the Petroleum Products and Energy Act, 1990 (Act No. 13 of 1990), bears that meaning and unless the context otherwise indicates -

“diesel” means a distillate oil which can be used as fuel for the operation of a compression ignition engine and which has an approximate boiling temperature of between 150 °C to 400 °C;

“fuel” means petrol or diesel;

“petrol” includes any mixture of petrol with any other substance, which mixture can be used as fuel for the operation of a spark ignition engine;

“reseller” means any person who, whether he or she has a fuel pump in operation in terms of an arrangement with a wholesale distributor or not, acquires fuel directly from a wholesale distributor and sells it to any other person in the course of or as part of the activities of a business carried on by him or her, but does not include any such person in relation to fuel which he or she sells in terms of an agreement with a wholesale distributor only in quantities of not less than 200 litres at a time; and

“wholesale distributor” means any person to whom a wholesale licence has been issued under the Petroleum Products and Energy Act, 1990 (Act No. 13 of 1990), including any person who is deemed to be a wholesaler under that Act and any of the licensed oil companies or traders referred to in regulation 2.

**IMPOSITION OF LEVIES ON GASOIL DIESEL 50PPM AND UNLEADED PETROL 95:
PETROLEUM PRODUCTS AND ENERGY ACT, 1990**

In terms of section 19(1) of the Petroleum Products and Energy Act, 1990 (Act No. 13 of 1990), after consultation with the National Energy Council, I -

- (a) impose levies on Gasoil Diesel 50ppm and Unleaded Petrol 95, as set out in the Schedule; and
- (b) repeal Government Notice No. 272 of 25 September 2019,

with effect from 5 May 2022.

SCHEDULE

Definitions

1. In this notice, a word or an expression to which a meaning has been assigned in the Act has the same meaning, and unless the context indicates otherwise -

“fuel” means petrol and diesel;

“fund” means the National Energy Fund established by section 11 of the Act;

“levy” means a levy imposed on petroleum products in terms of section 19(1)(a) and referred to in paragraph 2 of this notice; and

“the Act” means the Petroleum Products and Energy Act, 1990 (Act No. 13 of 1990).

Amount of levy

2. The Namibian Dollar (N\$) currency per liter for the levy imposed on petroleum products is set out in Table 1.

Energy source on which levy is payable

3. The energy sources in respect of which levies on petroleum products are payable are Gasoil Diesel 50ppm and Unleaded Petrol 95.

Person liable for levy payment

4. A consumer who purchases fuel at any licensed retail outlet anywhere in Namibia is liable for payment of the levies imposed on those petroleum products.

Person responsible for levy collection

5. The person or institutions that are responsible for the collection of levies on petroleum products is the National Energy Fund.

Times when, manner in which and person to whom levy is payable

6. (1) Levies collected on fuel are payable, at any time, to a licensed fuel retailer by a consumer who purchases fuel in Namibia.

(2) Levies collected on fuel by licensed fuel retailers are payable to licensed fuel wholesalers when a transaction for the purchase and selling of fuel takes place.

(3) Levies collected on fuel by licensed fuel wholesalers are payable to the National Energy Fund monthly, based on the consolidated fuel volumes that such licensed fuel wholesalers have imported into Namibia and sold to licensed fuel retailers, mining companies, farmers or any other client within Namibia.
