DETERMINATION OF DATE AND PLACE FOR SUBMISSION OF NOMINATIONS OF CANDIDATES, DETERMINATION OF POLLING DAY, AND NOTIFICATION OF NAME OF PERSON APPOINTED AS RETURNING OFFICER, FOR BY-ELECTION FOR MEMBER OF KHOMAS REGIONAL COUNCIL: MOSES //GAROEB CONSTITUENCY, KHOMAS REGION: ELECTORAL ACT, 2014

In terms of section 64 of the Electoral Act, 2014 (Act No. 5 of 2014) I make known, with respect to the by-election for a member of the Khomas Regional Council, Moses //Garoeb Constituency in the Khomas Region, that -

- (a) under the powers vested in me by subsection (1)(a)(ii) of that section, I have, on the recommendation of the Electoral Commission of Namibia, determined -
- (i) Wednesday, 23 November 2022 as the day on which the submission of nominations of candidates must take place; and
 - (ii) the place and time for the submission of the nominations referred to in subparagraph (i) to be ECN Head Quarters, Room 126, First Floor during the hours 09h00 until 11h00;
- (b) under the powers vested in me by subsection (1)(b) of that section, read with section 10(3) of the Regional Councils Act, 1992 (Act No. 22 of 1992), I have, on the recommendation of the Electoral Commission of Namibia, determined Friday, 6 January 2023 as the polling day on which the by-election must take place; and
- (c) in terms of subsection (1)(c)(i) of that section, Mr. Rakondjerua Kavari has been appointed in terms of section 65(1)(a) of that Act as a returning officer for the by-election.
