AMENDMENT OF CUSTOMS AND EXCISE RULES OF DESIGNATION OF PLACES OF ENTRY, AUTHORISED ROADS AND ROUTES, AND RELATED ISSUES: CUSTOMS AND EXCISE ACT, 1998

SCHEDULE**Definitions**

1. In this notice “the Rules” means the Customs and excise rules of designation of places of entry, authorised roads and routes, and related issues published under Government Notice No. R. 1771 of 5 October 1973 as amended by Government Notice No. 222 of 16 December 2002.

Amendment of Schedule to Chapter XII of Rules

2. The Schedule to Chapter XII of the Rules is amended -

(a) by the substitution for paragraph (1) of the following paragraph:

“(1) Places of entry

(a) The roads or routes including railways by which persons, imported goods or goods intended for export or transit carriage may enter or leave Namibia or may be carried from one point to another point, or the means of carriage of such goods.

(b) Second hand motor vehicles as specified in the Government Notice No. 253 of 23 September 2013 may be carried from Walvis Bay only on a car carrier trailer on a road or any other route authorised by the Commissioner for Customs and Excise.”;

- (b) by the substitution for paragraph (2) of the following paragraph:

“(2) Warehousing places
