BY-ELECTION FOR MEMBER OF OSHANA REGIONAL COUNCIL:
OKAKU CONSTITUENCY: OSHANA REGION: ELECTORAL ACT, 2014**

In terms of section 82(5) of the Electoral Act, 2014 (Act No. 5 of 2014), it is made known that -

- (a) a poll will take place on 17 March 2023 from 07h00 until 21h00 for the election of a member of the Oshana Regional Council in respect of the Okaku Constituency;
- (b) the persons whose names, sex, residential addresses and voter registration numbers appear in Column 1 of the Schedule have, in terms of section 82(1), been declared to be duly nominated in respect of the by-election of a member referred to in paragraph (a), with an indication of the political party by whom each candidate was nominated; and
- (c) in terms of section 89 of that Act polling stations have been established, and mobile polling stations under section 89(5) of that Act have been provided, in respect of the election referred to in paragraph (a), at the places mentioned in Column 2 of the Schedule;
- (d) and the places in terms of section 89(7) of that Act to be visited by the mobile polling stations during the polling period and the times at which the mobile polling stations will visit the places will be made known by a returning officer in a manner that he or she thinks fit and practical.
