**AMENDMENT TO REGULATIONS RELATING ON IMPLEMENTATION OF  
SECURITY COUNCIL DECISIONS: PREVENTION AND COMBATING  
OF TERRORIST AND PROLIFERATION ACTIVITIES ACT, 2014**

Under section 61 of the Prevention and Combating of Terrorist and Proliferation Activities Act, 2014 (Act No. 4 of 2014), I amend the regulations set out in the Schedule.

**SCHEDULE****Definitions**

1. In these regulations “the Regulations” means the Regulations Relating on Implementation of Security Council Decisions published under Government Notice No. 163 of 16 September 2014.

**Amendment of regulation 1 of Regulations**

2. Regulation 1 of the regulations is amended by the deletion of the definition “without delay”.

**Amendment of regulation 2 of Regulations**

3. The Regulations are amended by the substitution for regulation 2 of the following regulation:

“2. Every person, body, authority, or institution referred to in section 24(2) or 45(5) of the Act must inform the Centre within 24 hours of any asset freeze or any action taken in terms of sections 22(1), 25(1) or 45(1) of the Act.”.

**Amendment of regulation 3 of Regulations**

4. Regulation 3 of the Regulations is amended the by the substitution for the opening sentence of subregulation (1) of the following sentence:

“3. (1) Every person and institution referred to in sections 24(2) or 45(5) of the Act who has frozen assets or has taken any action in terms of sections 22(1), 25(1) or 45(1) of the Act may apply –”.

**Amendment of regulation 7 of Regulations**

5. Regulation 7 of the regulations is amended by the deletion of subregulation (4).

**Amendment of regulation 10 of Regulations**

6. Regulation 10 of the regulations is amended by the deletion of subregulation (1).
