PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

Act No. 3, 2024

APPROPRIATION ACT, 2024

ACT

To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2025.

(Signed by the President on 7 May 2024)

BE IT ENACTED as passed by the Parliament, and assented to by the President, of the Republic of Namibia, as follows:

Appropriation of amounts of money for financial requirements of State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated for the financial requirements of the State during the financial year ending 31 March 2025 as a charge to the State Revenue Fund.

Short title

2. This Act is called the Appropriation Act, 2024.
