No. R. 2443 21 December 1973

**STATE AIRPORT REGULATIONS, 1963**

The Minister of Transport has, in terms of section 22 of the Aviation Act, 1962 (Act 74 of 1962), as amended, made the regulations contained in the Schedule hereto.

**SCHEDULE 10**

The State Airport Regulations, 1963, as promulgated under Government Notice R. 1974 of 20 December 1963 and as amended\*, are hereby further amended as follows:

In regulation 12 (2)—

(a) delete the words “(other than a student pilot’s licence)”;

(b) add the following proviso:

“: Provided that a student pilot who is not the holder of a student pilot licence, may move an aircraft in the terminal area while undergoing training with and accompanied in the aircraft by the holder of a flight instructor rating”.

**STAATSLUGHAWEREGULASIES, 1963**

Die Minister van Vervoer het, kragtens artikel 22 van die Lugvaartwet, 1962 (Wet 74 van 1962), soos gewysig, die regulasies in bygaande Bylae vervat, uitgevaardig.

**BYLAE 10**

Die Staatslughaweregulasies, 1963, soos afgekondig by Goewermentskennisgewing R. 1974 van 20 Desember 1963 en soos gewysig\*, word hierby soos volg verder gewysig:

In regulasie 12 (2)—

(a) skrap die woorde “(uitgesonderd ’n leerling-vlieënierslisensie)”;

(b) voeg die volgende voorbehoudsbepaling by:

“: Met dien verstande dat ’n leerlingvlieënier wat nie die houër van ’n leerlingvlieënierslisensie is nie, ’n lugvaartuig in die eindpuntgebied mag beweeg, terwyl hy opleiding ontvang van en in die lugvaartuig vergesel is van die houër van ’n vlieginstruktorsgraad”.
