

Republic of Namibia Annotated Statutes

Appropriation Act 5 of 2013

(GG 5207) came into force on date of publication: 31 May 2013

ACT

To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2014.

(Signed by the President on 16 May 2013)

BE IT ENACTED as passed by the Parliament, and assented to by the President, of the Republic of Namibia, as follows:

Appropriation of amounts of money for financial requirements of State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated for the financial requirements of the State during the financial year ending 31 March 2014 as a charge to the State Revenue Fund.

Short title

2. This Act is called the Appropriation Act, 2013.

The Namibian Constitution Second Amendment Act 7 of 2010 (GG 4480) altered the term "prison service" in the Constitution to "correctional service", and the term "Commissioner of Prisons" to "Commissioner-General of Correctional Service".
