Honourable Minister in 2009 Cabinet approved the creation of a Special Medical Fund to finance Specialist Surgeries such as transplants that could not be performed in Namibia and cater for special cases such as that of the

late Booysen. Notwithstanding the fact that your predecessors in that Ministry are on record to have criticised Namibians requiring special medical treatment who run to the Media for donation instead of asking for State assistance. - 5. to provide for the automations and the use of information, technology in electronic comments;
- 6. to accommodate the one stop border post concept by providing for places of entry and exiting in terms of international agreements with SADC Member States and adjourning countries;

- 8. to facilitate the functioning of the national single window concept;
- 9. to change the time frame for the report of arrival and launching of declarations to Customs and Excise;
- 10. to permit or require the declarations of goods import over land to be launched electronically and prior to its importation;
- 11. to simply provisions requiring export to produce documents and pay duties;
- 12. to provide for the registration of legal persons as authorised economic operators;

- 13. to provide for the impositions of an environmental levy in respect of certain goods manufacturers and imported into Namibia;

**HON KANDUMBU**: Thank you Honourable Speaker, Honourable Members, I rise to withdraw my contribution on this Motion. Thank you.

**HON SPEAKER**: Thank you. Yes the Honourable Pendukeni Iivula-Ithana.

**HON MINISTER OF HOME AFFAIRS AND IMMIGRATION**: Yes Comrade Speaker. Honourable Members, as you have been well aware I have been away for some time and if I may do something that may contradict what was done or said before I seek your indulgency to pardon me.

Honourable Speaker, the item under discussion is of great interest to me because it talks about me, my daughter, my granddaughter and all the shes of Namibia therefore, I feel I have an obligation to add my voice. The issue raised by the Honourable Member if it was not in the age of computer and other developmental debates going on I would have said the mover has crossed the borders or the boundaries because these are issues we do not normally discuss in public. For him to have done so maybe there was something that really forced him to do so and I have asked myself a question, what is it that probably has forced the Honourable Member to raise this in the National Assembly.

I looked at what we have. The systems we have in the country, that are aiming at alleviating at some of the problems afflicting the vulnerable. I want to believe that the category of persons dealt probably the Honourable Member has in mind to be assisted in this fashion is the same category that this Government has also made provision to cater for through the Ministry of Gender, Equality and Child Welfare (intervention).

HON SPEAKER: Yes on the point of order.
HON DIENDA: May I ask the Honourable Minister a question?
HON MINISTER OF HOME AFFAIRS AND IMMIGRATION: Pardon.
HON DIENDA: May I ask the Honourable Minister a question, please?
HON SPEAKER: You want to pose a question?
HON DIENDA: Yes.
HON MINISTER OF HOME AFFAIRS AND IMMIGRATION: I am just on the introductory part of what I want to say (intervention).
HON DIENDA: Honourable Minister, you said that normally these matters are not being discussed in public – this is what you said am I right?

Honourable Minister where do you want us to discuss this matter, in the

church, at malls, in shebeens or where because I think that as Members of Parliament this is the right place to discuss issues like this.

The reason why I am saying this is my grandchild is 9 years old and she is talking about menstruation, pads and everything and they are watching us here so they know exactly what we are talking about so if Members of Parliament can discuss these things it is very important for them so that they can see we have their interests in us. I asked the question, where did you want us, this is the question? Thank you.

**HON SPEAKER**: Honourable Member, you may continue.

#### HON MINISTER OF HOME AFFAIRS AND IMMIGRATION:

Thank you very much, Honourable Dienda. The question is irrelevant, it is not precisely what I said. I said if it were not meaning I have qualified my statement so which means the world has changed to such an extent that nowadays we can even talk about such issues in public, that is what I meant. Maybe my NamLish did not bring it out clearly. Just be patient and listen carefully.

Honourable Speaker, I have missed the debate in a larger part of it probably, not probably but more so the statement of the mover. Probably he had stated the category of girls this Parliament would like to be assisted with such facilities and I am asking this question because I now the Government has put in place, measures to assist vulnerable children including girls I suppose, orphans and other vulnerable children are taken care of unless if my information is not correct.

Now, if we are talking about this other assistance to be given is it going to be given to every girl in school? Is it going to be given to a certain category of girls in school or what is really what we are aiming at

achieving? Is this just brought here for us to talk about some of these things that are not talked about in public for the sake of it or we really mean business?

I do not see the need for us to debate such an issue here. Yes, I do not see it. Probably we run out of issues to such an extent that we even bring to Parliament issues that we can deal with at home levels. I want to know the category for those who have been here who have listened to the debate I want to know the categories of girls we want to assist in this manner because I know the vulnerable are assisted?

That is my problem, Comrade Speaker, when I saw this item on the agenda, therefore, I have not much to say other than to leave what I have here probably for further elucidation. Thank you.

**HON SPEAKER**: Thank you very much. The next is the Honourable Jennifer Van Den Heever.

HN VAN DEN HEEVER: Thank you, Honourable Speaker. Honourable Members, I also rise to contribute to the deliberation of this Motion of Honourable Venaani regarding the urgent provision of sanitary pads to girls in need.

I really like to thank him for being a caring father and being outspoken. It is because he was caring that is why he brought the issue to the House. In fact it was us as women who have to bring this Motion to the House to debate on it because there is a need.

If Members of Parliament are really turning a blind eye and a deaf ear and saying that there is no need then I do not know but it is in fact sometimes one has to be outspoken on issues which we regarded previously as

sensitive, private and as a taboo. Leaders have to rise above that fear of taboos and respond to the realities that the fact that people if we as leaders are not talking about it who is going to talk about it and how will we address it at the end of the day.

It is our duty to raise awareness in all sectors and I would like to quote, there is an advocacy by the UNICEF Cooperation Plan for Namibia which is titled A Namibia Fit for Children and the UNICEF Representative in Namibia Michaela Marcos De Sausa said and I quote, "We need to empower communities with knowledge on better hygiene behaviours and instil these practises into their everyday lives. Simple techniques can be taught that go a long way in preventing diseases and keeping children and women healthy".

We also have to look at the national Human Rights Action Plan dated from 2015 to 2019 where we have different focus areas. Focus area one is the right to health in which it is stipulated that we strive for the improvement of all aspects of environmental and industrial hygiene.

Honourable Speaker the point I would like to make is that we should make sure that our children's dignity is upheld. We know that due to the challenge of widespread poverty that we face not all families and girls can afford to have the necessities required to maintain good hygiene and prevent the spread of diseases.

This morning in the New Era there was that message line and so many women and children expressed themselves that it is a real need because it is an embarrassment for them coming to school, having their menstruation at school and not having a pad. So it is really important for us to do something about it.

Honourable Members, I would like to support the Motion and I support and add that the Ministry of Health and Social Services and the Ministry of Education, Arts and Culture should cooperate and try to create an intervention whereby we will embark upon a comprehensive programme

to assist our girls and to keep their dignity. I thank you.
HON SPEAKER: Thank you. Honourable Muharukua.
HON MUHARUKUA: Honourable, I say thank you. Yes, Honourable Speaker, I, just like my mother the Honourable Minister of Home Affairs and Immigration, was not around when this was tabled and neither do I really know what the (laughter). How the conversation went, full conversation but I want to, yes I do have lack of experience I admit, I want to perhaps make a contribution in a very different (intervention).
HON SPEAKER: On a point of order yes.
HON DEPUTY MINISTER OF LAND REFORM: Thank you, Honourable Speaker. I am just very concerned about hearing from what my mother said and issues of age and so on whether perhaps there is no parental guidance for the Honourable Muharukua who is clearly below the age to experience these matters.
HON SPEAKER: The Honourable Muharukua wishes to continue.

**HON MUHARUKWA**: I think the NBC does advise that Parliamentary things are PG so it is okay. Yes, I want to and my contribution wants to

perhaps focus on something linked to the issue but also different before I perhaps come to the issue at hand and that is when one was growing up there was this subject at school (indistinct) home economics now in English you see I am from the other era.

In this subject our young girls were taught to become to behalf as ladies. This is now hygiene so to speak. Yes, as a nation we are striving towards economic emancipation such that we prioritise and we curtail and not curtail but we streamline our school curricula to fit those aspirations so much that sometimes we forget what is morally important.

I tell you if you look at the old nurses, if you walk into the hospitals and you look at the old nurses the way that nurse is wearing her skirt, the way her shoes are polished, the way she is walking, shoulders out brought you can actually hear her from 100 metres away walking, properly taught to behave like a lady. What it does, not only does it preserve the morals of our society but it also compels forces men to respect our ladies.

Perhaps it is time that we do that introspection and say yes maybe we want to economically advance but what is it that we are teaching our children and one will always revert to that? What is it that we are teaching our children at school? How are we teaching our girls to behave?

Now, when one is talking about behaviour, one is also talking about hygiene because the way you carry yourselves and treat yourselves is the way you are going to behave outwardly.

Let me come back to the issues, I am actually very disappointed and now I understand why the Honourable Kandumbu refused to comment or to withdraw her contribution I understand and it is embedded in, no I will not go as far as saying she made her choice.

**HON KANDUMBU**: (Not on microphone).

**HON MUHARUKUA**: No, I am not speaking on your behalf, I am talking about you. It is embedded in the contribution of the Honourable PendukeniIthana and I understand. I understand we are an African society and that some things are taboo to discuss with our children let alone in public. Well, some things area taboo to discuss even with our children like some things a man would not discuss with his daughter and some things a woman or a mother will not discuss with her son because we are an African society, it is quite true.

But there is also one reality. The reality that we are leaders, as leaders we do not bring to the floor of this Parliament what things that fits us individually. I am sure the Honourable Venaani can afford his household needs with regards to this specific Motion and I am sure he does. I am sure he can and I am sure the majority of us here can and it is just profoundly wrong simply because you can afford to argue that if someone is speaking on behalf of a young lady who just cannot make ends meet has lost issues.

It is profoundly disappointing for me to hear a mother to say that if one is speaking of sanitary needs of a person that cannot afford that person has no issues, that is just wrong.

**HON SPEAKER**: Yes, point of order.

HON MINISTER OF HOME AFFAIRS AND IMMIGRATION: A point of correction Honourable Speaker. The Honourable son of mine is taking me wrong totally. Completely wrong because what he is attributing

to me is not what I said. I talked about the vulnerable children in our society whom I know this Government is catering for the vulnerable. If the child is not falling under vulnerable then it should be yourself and myself and therefore have no place in this debate. Put what I said in context.

**HON MUHARUKUA**: If I have paraphrased the Honourable Member wrongly I shall apology and I will duly withdraw. However, this is what I wanted to say in this regard that we provide assistance for the vulnerable children, that is true. Last time I checked it was N\$250,00 that is quite correct but we also know that there is one reality, the wrong nonetheless it is there but sometimes this money does not even get to buying the children shoes, it does not. People/adults are abusing this money. The Honourable Kawana would now that some of us would pay maintenance and this money would never get to the children, it is true so what do we do as leaders?

**HON MEMBER**: (Indistinct).

**HON MUHARUKUA**: Yes I know you want to tie us. It is quite, what we do as leaders do we leave it to the Courts to punish or do we assist whilst we are trying to come with a solution? We are forgetting one thing when we are choosing morality you must choose real morality and not choose selective morality.

The very kids, vulnerable kids that we are talking about that are getting these funds are the very kids that we are feeding at school. Why do we feed them if we give them money in any event? Because there is that specific need to feed and because we know that the money does not

necessarily get to the kids it is the very same arguments that necessitates the sanitary needs of girls if need be.

In my conclusion, Honourable Speaker, perhaps it would be a more prudent, a more compelling, a more responsible argument for Government to say that people we do not have money let us look at this issue later, that to me would be more responsible than to say there is no need. We cannot discuss. Of course there is need. Of course if there is a need they need us to discuss. We discuss rape in this august House, it is discussed. Things that are done oh (intervention).

**HON DEPUTY MINISTER OF FINANCE**: I just want to correct my colleague that Government has never said there is no need to discuss this matter. Myself when the discussion was tabled here said we have a programme in schools.

We have this First Aid kits, emergency kids and they are there at school and they are at Government schools and what we are discussing is supposed to be in those emergency kits. I even said if they are not there schools that do not have them should make sure they should have them. These are things that are there. It is not to say Government has no programme of this nature we do and we should appeal to the schools that do not have them to have them.

**HON SPEAKER**: Thank you. You may continue, Honourable Member.

HON MUHARUKUA: Well, in that event perhaps you are informing me that Government is already having that programme in place, if I am hearing you correctly? Perhaps not at all schools and it must be rolled out

to cover where it should cover, if that is what Government is saying to me that is responsible but I also do not buy (intervention).

**HON SPEAKER**: Are you on a point of order?

**<u>HON DIENDA</u>**: I am on the First Aid kit that the Honourable Deputy Minister is talking about. Yes on a point of information (intervention).

**HON MEMBER**: On a point of order I am informing you, you are out of order.

**HON DIENDA**: No I am not out of order, I am in order. As a former teacher myself I can tell you now, I can come and go back whatever I have the qualification to teach any time.

Honourable Speaker, the First Aid was stopped at all schools. We are not allowed in schools even to give a headachetablet to a child anymore. Not even anything so there is no First Aid kit. Honourable how long ago were you attending school because I know this thing is long time where they said sorry no more First Aid kits at schools. If there is a need call the parents to come and address the problem so besides that even if we have First Aid kits at school you will only have one packet of pads in that First Aid kits and we are talking about 1,500 learners at school and one pack of pad, so Honourable Deputy Minister your information is outdated. Thank you.

**HON SPEAKER**: Yours was on a point of information so the Honourable Muharukwa should continue please.

**HON MUHARUKUA**: I forgot I was on the floor. Honourable Speaker, maybe just to conclude and AG it is not legal matters. While we know what our society is and knowing what our morals are we must not choose selective morality. This House, I was still a child but I knew that this House is discussing (indistinct) sorry and I say the word lightly but it does discuss. A thing that goes at the places the other one that is being discussed and so the other one is fine and this other one is not fine. As leaders let us really be true with ourselves. Thank you, Honourable Speaker.

**HON SPEAKER**: Thank you. On that note I wish not draw the attention of the Honourable House to – let me say I have a great pleasure to acknowledge the presence of colleagues, Parliamentary Delegation from a sister Parliament of the Republic of Zimbabwe that consist of Members of the Senate and Members of the National Assembly who are currently visiting us representing the Parliament and the Women Caucus Group and they are here to consult with their counterpart. They have been here for some time now and I wish to introduce them one by one:
