MINISTERIAL STATEMENT INTERMS OF RULE 98 OF THE STANDING RULES AND ORDERS

ON THE RESCHEDULING SECOND NATIONAL CONFERENCE ON LAND REFORM

HON MINISTER OF LAND REFORM: Honourable Speaker, Honourable Members, I rise this afternoon to give a brief to this August House and to the nation on the circumstances leading to the decision to reschedule the whole thing of the second national conference on land reform and land question.

12 October 2016 ON THE RESCHEDULING SECOND NATIONAL CONFERENCE ON LAND REFORM HON NUJOMA

The Ministry feels compelled to immediately inform the nation about this decision especially as it closely follow the successful launch of the preparations for this conference held on the 24th of August 2016.

Additionally, the Ministry has also undertaken to inform the nation on the date of the commencement of the planned conference. While the nation is still waiting for an announcement to this effect, anticipation has been building up since the decision by the Ministry to proceed with regional consultations before hosting the second national land conference.

Honourable Speaker, Honourable Members on the 24th of August 2016 our nation witnessed the officially launch of the hosting of the second national land conference at the Windhoek Country Club. A successful launch was preceded by comprehensive technical presentation on the status of the 24 resolutions that emanated from the 91 land conference also presented was a synopsis of the policy and legal framework specifying the various achievements and challenges as experienced by the Ministry during the implementation in the past 25 years. The resolutions of this water-shed conference in conjunction with the constitution of the Republic of Namibia provide a solid foundation for the Ministry's policies and legislations on the redistributed land reform program.

At this juncture, Honourable Speaker, Honourable Members a further elaboration on the background of this issue is imperative. On the 5th of April 2016 His Excellency Doctor Hage Geingob the President of the Republic of Namibia delivered the state of the nation address which was followed by the release of the Harambee Prosperity Plan 2016-2017, 2019- 2020. The plan outlined the nation policies in the next four years within the Harambee Prosperity Plan.

The Ministry of Land Reform is tasked with the important mandate to host the second national land conference in order to take stock of the achievements so far and to establish what still has to be done to speed and improve the implementation of the recommendation of the 1st national conference and land reform and land question of 1991. Furthermore, the

Harambee Prosperity Plan direct the Ministry to hold the second land conference before December 2016.

Therefore, the Ministry immediately started to work towards the attainment of this set target. This is reflected in the Ministerial annual plan and by the numerous consultative platforms and engagements that took place prior to the official function on the 24th of August 2016. Honourable Speaker, Honourable Members the whole thing was an event of such as the land conference has major economic implications especially in the context of the current financial constraints.

In addition to the economic challenges, our country has been experiencing, severe successive drought that has left our productive sector sunder threats and agricultural initiatives and disarray. They have most or compromise and in need to assistance. The situation is further compounded by the continued low levels of water in all our national dams and water shortages in most rural and urban centres. This is focusing our Government to reprioritise and direct available resources to critical sectors.

We as a land sector has also not been spared the necessary budgetary cuts which has ultimately impacted on our overall capacity to delivery on set targets. The whole things of a conference of this magnitude requires considerable working budget. Given the budgetary concern the Ministry does not have such funding at its disposal in the current Financial Year thus after consultation the decision has been taken to postpone the whole thing of the second national land conference until such time that the required resources are available.

However, although the Ministry is postponing the actual hosting of the conference, other platforms will be made available to continue engagement on this very important matter with our various stakeholders.

Honourable Speaker, Honourable Members the initiative to host the second land conference is ultimately an important intervention that will

immensely benefit the country after 25 years of implementing the agreed 24 resolutions.

The Ministry has articulated in the spirit of Harambee Prosperity Plan considers important once again lead the process of consulting the Namibian nation on future direction of the land reform and to review the progress made, the challenges encountered and to propose ways to expedite land reform program.

Honourable Speaker, Honourable Members having said the above, the Ministry will continue to systematically work in order to further advance the land reform program in an orderly manner in line with the current policy and legal framework. To support some of the critical policy proposals, the Ministry has finalised the draft Land Bill that is currently under final scrutiny by legal drafters at the Ministry of Justice.

It is anticipated that the draft Land Bill will be tabled in the National Assembly in its current form thus whilst awaiting the eventual resuscitation of the discussion pertaining to the second national conference on land and the land question, the Ministry will focus on the tabling of the Land Bill.

To conclude, Honourable Speaker, Honourable Members despite the many challenges, the Government through the Ministry of Land Reform is aware of the acute demand for land for agricultural purposes. It is committed to a transparent, fair and equitable land reform process that is guided by our policy and legal framework.

I repeat that is guided by our policy and legal framework. Simultaneously, as a Ministry we are proud of the honour bestowed upon us to lead and host the conference of such important and magnitude. We reiterate our support to the Harambee Prosperity Plan and will continue with firm commitment to further strengthen the said initiatives as articulated under the land reform process.

HON SPEAKER: Thank you. A quick one from Honourab	le Maamberua

HON MAAMBERUA: Thank you, Comrade Speaker. Allow me to thank the Honourable Minister for updating the nation about the status of the process of hosting the second national land conference. I think that is cardinal and important.

As we all know, the issue of the land is at the very core and heart of the SWANU of Namibia, I just want to make a small observation and perhaps seek small clarification also and that is it appears as if the postponements of the hosting of the second national land conference is now indefinite because the Minister did not give an indication as to it is postponed until when apart from stating that until resources permit and that we do not know because we seem to be facing a precarious financial future and so it is possible that this second national land conference could be postponed for another 25 years. I hope not but maybe the Minister will give an indication as to when is the situation going to improve in order to have.

The second aspect to that is that I can hardly believe that hosting a national land conference should be so expensive to the extent that such an important and cardinal conference should actually be postponed on the issue of the country not affording at the moment. I do not even think we are talking about N\$100 Million. It is probably less than that maybe only N\$20 Million or something like that. Could the Minister perhaps give an indication as to how much were you looking for? Maybe you could find some resources to assist to close that gap because it is very important.

HON SPEAKER: Honourable Maamberua, can I ask Minister to respond quickly because we want to continue?

HON MAAMBERUA: Yes, those two issues maybe I can follow up. Thank you.

HON SPEAKER: The timeframe – do you want to add a quick one? I am assuming you have the money.

<u>HON MUHARUKUA</u>: Honourable Minister, I think given the timeframe between the launch and the promised time of the said conference and the reasonable Namibian perhaps or perhaps some of us thought we were sceptics to think that it was not going to happen given what needs to happen in between the preparation.

Perhaps the question that I want to ask is when the Minister it is similar to the question of Honourable Maamberua, when Honourable Minister talks about until such resources are available are we talking about Government?

Are we talking about the next budgetary allocation and the state or are we talking about your Ministry actively involved in being seeking some additional fund or funds somewhere to cover for the hosting of the conference and therefore Namibian should perhaps expect that maybe even before the next Financial Year this conference could happen maybe just that clarity.

HON SPEAKER: Thank you very much, those two questions Honourable Members. HON MINISTER OF LAND REFORM: Comrade Speaker, I said in my statement until resources becomes available, and that is what I said and that is what I am saying. I cannot say otherwise because the land conference would be a national land conference and I do not foresee that we will ask donors or some outsiders to come and sponsor us. Until resources become available, it is a national issue and until resources becomes available, then we will host the conference. Thank you Comrade Speaker. **HON SPEAKER**: Thank you very much. I think we leave it at that. HON MAAMBERUA: Thank you, Comrade Speaker. I had a second question and that was how much are we talking about. How much was budgeted for that? **HON SPEAKER**: Can we how much is expected the conference to cost? **HON MAAMBERUA**: Exactly.

RESPONSE TO QUESTIONS ON MINISTERIAL STATEMENT HON NUJOMA

HON SPEAKER: Minister, do you have a figure in mind?

HON MINISTER OF LAND REFORM: I cannot provide figures now, because I do not have those figures but I have checked in my budget and I know the resources are very limited given the fact that we have budgetary cuts. What must I do if we have to prioritise this to other areas such as drought as I said even today we read Omaruru is almost running dry? Windhoek is almost running dry. Where will the people will come here to drink what? **HON SPEAKER**: I think we leave it at that, yes. HON MAAMBERUA: My good friend Comrade Minister, was the cost of hosting the second national land conference budgeted for and then the Ministry of Finance instructed a cut and that is why you cannot afford to continue with the conference or what exactly are you saying? HON MINISTER OF LAND REFORM: ...and satisfy yourself. Thank you very much, Comrade Speaker. HON SPEAKER: Thank you. We move on to the next Honourable Nghimtina. You have the floor.

INFORMATION PERTAINING TO SOCIAL SECURITY DEVELOPMENT FUND

HON MINISTER OF LABOUR, INDUSTRIAL RELATIONS AND EMPLOYMENT CREATION: Thank you Honourable Speaker, Honourable Speaker I want to provide information pertaining to the Social Security Development Fund.

The background and the purpose of the Social Security Commission Development Fund, the Development Fund was established through section 37 of the Social Security Act, Act number 34 of 1994 and was officially launched in March 2011 by the then Minister of Labour and Social Welfare.

It is a known contributory fund, which focus on getting unemployed Namibians from social economic disadvantaged background into the labour market. In line with the Act subsection 4(a) and (b), it is objective or main mandates are:

- 1. The conducting of training theme and employment theme approved by the Treasury for the benefit of social economic disadvantaged persons who are unemployed.
- 2. The granting of bursaries, loans and other forms of financial aid to students enrolled at any technical or academic institution of higher education, therefore, Social Security Development Fund operates around the following four core functions:

The provision of bursary scheme and low interest study loans schemes which advantage students studying towards under and post graduate

qualifications, the provision of financial assistance to the training scheme of unemployed Namibians include of strategic importance to the country and the provision of financial assistance as establishment of community development projects across all sector of the economy or employment creation and income generation.

Funding models of the Social Security Development Fund the Act further states how the fund is to be funded. There shall be faith into the fund. Such portion of the said contributions payable to any other fund as maybe determined by the Commission with the concurrency of the Minister monies appropriated by the Parliament for the purpose of the fund, any interest or dividend earned in defence of the section 16 of the Act, any monies received by way of donation and any other money which may accrue to the funds from any other sources.

Accordingly, the fund has been receiving its funding mainly from the Commission and the Government through the line Ministry. Funding from the Commission is done as follows.

Each year any independent accrual valuation is carried out on the maternity leave, sick leave and death benefit fund. This is after considering all obligations against the fund and its sustainability determines the value of three reserved under the maternity leave and death benefit fund. At percentage currently, 2% of these three reserves is then transferred to the Social Security Development Fund after obtaining Ministerial approval.

On the other hand funding from the Government is determined based on the availability of resources and competing priorities. Therefore, there is no set formula for this funding. Therefore, the funding ratio has on average between roughly 85% from the Commission and 15% from the Government.

Beneficiaries of the Social Security Development Fund the excess stated above entitle social economical disadvantaged persons who are

unemployed to benefit from the various schemes administered by the Social Security Development Fund especially under the employment and training schemes. This is a line with its mandate of assisting unemployed Namibians to enter the job market. On a day-to-day basis the operations of the fund are guided by the regulations and approved policy, which set out the rules of entitlement.

Under the training scheme Social Security Development Fund has to date since 2013 had at least 1 500 unemployed Namibians to get training in fields such as hospitality, office administration, household operations, training of domestic workers, operating both literacy and other statements of vocational training.

These training interventions were carried out at a cost of N\$10 Million. At least 36% of these trainees are in the job market. How would beneficiaries access funding, periodically Social Security Development Fund runs a call or proposals and training providers, registered and accredited by the Namibian Training Authority NCA and the Namibian Qualification Authority NQA are invited to apply for the funding to provide training on behalf of the Social Security Development Fund?

Training is conducted in fields such manufacturing, value addition to produce mineral or natural resources, domestic workers, fashion design, attire making, hairdressing, manicure and pedicure, electrical repairs, brick making, construction and maintenance operating heavy duty vehicles, entrepreneur training and office skills, trans-office and customer care, practical food preparations, food service and housekeeping, woodwork, carpentry and welding.

The Commission upon receiving proposals from training providers evaluates these and makes recommendations to the line Minister who then request the Head of State to approve this for funding in line with subsection 4(a) of the Act stipulated above. Once approval is obtained from the Head of State, Social Security ensures that services level agreements are entered into with the training provider, which set out rules of engagements. This then allows the training providers to invite qualified

trainees to take part in the training programs as approved. The Social Security Development Fund pre-approves the list of the trainees before training commences. Financial status of the Social Security Development Fund, the Fund value is N\$222 Million of which N\$202 Million is reserved. It has a liability of N\$19 Million, which are commitments to its fund programs across all the scheme.

In conclusion, the Social Security Development Fund in 2010 availed N\$10 Million to the Ministry of Labour and Social Welfare at the time. The funds were intended to assist the Ministry to set an integrated employment system, which has a crucial intervention that assist job seekers to get access to available job opening in the centralised manner. It also allows employers access to available pools of job seekers.

The system is currently up and running. The financial assistance was made in a form of a once off donation for the benefit of unemployed Namibians.

Similarly, assistance towards the training of the children of liberation struggle was a one off donation approved by the Head of State in line with the Act.

The ultimate goal through this form of assistance is that those trends will enter the labour market and become new contributors to the existing contributory funds of the Commission.

Its element across subversion is a key basis on which social protection scheme and systems are built. I thank you, Honourable Speaker.

HON SPEAKER: Thank you. That concludes Ministerial Statements. We move on the first Notice of Motion, that of Honourable Minister of Finance. Does Honourable Minister Move that the Bill be introduced?

HON MINISTER OF LABOUR, INDUSTRIAL RELATIONS AND EMPLOYMENT CREATION: Honourable Speaker, Honourable Members in terms of Section of 4 of the Affirmative Action Employment Act number 29 of 1998 the ruling party and the official opposition party are required to nominate representative for the previously rationally disadvantaged on the employment equity Commission.

The official opposition party, which is DTA it is, true its candidate Mr Vincent Kanyetu this withdrawal led to a vacancy in the Commission.

Another position of the Commission became vacant as a result of the death of late Miriam Thomas Jefta may her soul rest in peace who used to represent persons with disabilities on the Commission. Section 9(2) of the Affirmative Action employment Act provides as follows a vacancy on the Commission arising from any circumstances referred to in a subsection 1

The organisation representing the interest of the designated groups were consulted in terms of section 6(4) of the Affirmative Action Employment Act to nominate candidates to fill these positions.

The official opposition party this year nominated Tjamarine Tjirare who is currently serving on the Commission as an alternative member to serve as the main member and Mr Tale Peter as her alternate.

The national federation of people with disabilities in Namibia nominated Mr Trumb Daniel Tjiremo to take over from the late Ms Miriam Thomas Jefta who served as the main member on the Commission representing persons with disabilities.

I am, therefore, presenting to you, Honourable Members, the following persons as nominated by the DTA and by the national federation of people with disabilities in Namibia to serve as members of the Employment Equity Commission for the unexpired portion of the period of office of the 5th Employment Equity Commission ending the 30th of April 2018 as approved, Ms Charmaine Ngirare, Mr Tale Peter and Mr Trumb Daniel Tjiremo as the members of the Equity Commission.

HON JAGGER: Thank you very much Honourable Speaker. I rise to motivate the reports on the familiarisation visit by the Parliamentary Standing Committee. Thank you so much, Honourable Speaker.

I do not know why the system reject kind of for me to report on the Kunene visit. Is it because I am from Kunene. Is it not allowed that I should speak on Kunene issues?

However, I rise to motivate a report on the familiarisation visit by the Parliamentary Standing Committee on Human Resources and Community Development to the Ondawo mobile primary school unit and some schools in Opuwo in Kunene region from the 30th of May to the 3rd of June 2016.

This report Honourable Speaker, Honourable Members has already been tabled in this August House. Honourable Speaker, Honourable Members it is not my intention to delve into the details of the report that is before the House today. I have no doubt that Honourable Members has had the opportunity to peruse the report and will therefore be able to discuss the report in detail. However, there are a number of issues contained in this report, which requires attention and action from the Ministry of Education, Arts and Culture.

I should however hasten to point out here that some issues raised in this report might have already been addressed and attended to by the Ministry. That notwithstanding, I wish to highlight some of the issues Honourable Speaker, Honourable Members which the Standing Committee consider

being of great importance and as it has an impact on the welfare of our learners and teachers at the mobile units.

These issues deal greatly with general school administration as well as infrastructural development at schools. Ondawo Mobile Primary School in the Kunene region was an initiative of the Norwegian Government. The school has its administrative office in Opuwo with three Principals and three HODs Heads of Department. It has 37 units that are to provide education to marginalised children of the nomadic population.

I must however report here Honourable Speaker, Honourable Members that these units are no more so mobile. The Principal and the HODs are all based in Opuwo, and are not teaching as their colleagues at conventional schools are doing. They only take time to visit the units when opportunities are created. The mobile units were mostly mobile in response to the nomadic lifestyle of Himba people as they migrate from one place to another in search for better grazing for their livestock and as a result the teachers of the units had to follow in the past whenever they go.

The units' physical structures are predominantly ten, which are used as classroom and also as sleeping quarters. The fathers unit is more than 220 kilometres away from the town of Opuwo.

Most of the teachers are Grade 10 and 12 graduates but the encouraging part is that some register themselves for furthering their studies in education. They are more than 127 teachers employed to teach and learn approximately 3 279 children in the units. The teachers endure the hardship of staying far away from the township life and live to see the harshness of nature every day.

During the rainy season, mobility is almost impossible due to the flowing rivers. As a result, the units are left on its own. The classroom is a tent with in many instances no chairs, desk and teacher table, lack of textbooks and stationery. Quality teaching and learning is compromised beyond

doubt. The challenge the children face is the distance from home villages to the schools tothe units a distance of 50 kilometres will take you almost two hours to drive on the rough road.

Many teachers are not professionally trained to teach and have little or no access to in-service training. The learners sit on logs in some units and use few tables to write on. The tendered classroom makes it difficult for teachers to produce teaching and learning material due to whether condition.

Distances and rough road also make it also difficult for the senior education officers that the advisory teachers and inspectors and also the Ondawo Mobile Primary School management to visit the units for capacity building and support. Under normal circumstances, it would take the Principal and the HOD one full year to visit all the units. The tendered classrooms mostly accommodate multi Grade teaching, combined Grade 1 and 2, combined Grade 3 and 4 due to few learners or rather inconsistency in attending classes.

Parents who have more than three children would send them to school on a rotational basis and parents threatened to remove all their children from school until a consensus is reached in that regard. When the pastures for animal is poor, communities move in search for better grazing and the units have to follow them making sure their children are not denied access to education.

Honourable Speaker, Honourable Members at times of water scarcity, animals come first and then the community. The delegation was informed that many learners have graduated from the mobile units and went to conventional schools who are now playing a significant role in the country after having finished their studies at secondary and tertiary level.

The delegation under-pined a need to engage education officers in Kunene region through the Ondawo Mobile Primary School Indaba so as to outline

and find practical ways that would enhance not only access to education for the children in the marginalised communities but indeed to ensure quality education as well in general.

The delegation was also sensitised that international donors and well-wishers are assisting schools with infrastructural development. Since there are many lodges, lodges are also contributing in assisting the schools and the units in the most rural parts of the region.

These schools have numerous challenges that needs to be addressed shortage of water is a big problem, poor sanitation, insufficient ablution facility which at time unreliable water supply which at times disrupt the school programs. Some conventional schools experience shortage of teachers and institutional workers, lack of furniture, lack of classrooms as well as lack of parental involvement.

Other challenges, Honourable Speaker, Honourable Members are reported are teenage pregnancies and early child marriages among school going girls that compromised quality education.

Honourable Speaker, Honourable Members I wish to thank the Colleagues who have gone with me on this familiarisation visits for their support and their inputs. I would equally thank the educational authorities who have accompanied us on our visit and with their honest inputs and reports.

With these few remarks, and not wanting to pre-empt the discussion due to take place on this report, please allow me to make a humble request to the Ministry of Education, Arts and Culture to deal with the recommendation as suggested by the Parliamentary Standing Committee on Human Resources and Community Development.
