

ADVOCACY

Civil Registration and Identification Bill



This Bill covers a range of important issues, including the registration of births, deaths, marriages and divorces; protection against statelessness; and access to information in the government databases. GR&AP worked in partnership with the Ministry of Home Affairs, Immigration, Safety and Security (MHAISS) and the legal drafters in the Ministry of Justice to polish the provisions in the draft bill, particularly to ensure that it improves birth registration of marginalised groups by providing for the registration of children born to undocumented parents. We hope this Bill will be passed in 2023.

Amendments to the Combating of Rape Act

GR&AP supported the proposed amendments aimed at fine-tuning this law, by sharing a presentation explaining the proposed amendments on our website and in various workshops, and by popularising the proposals on the *Parliamentary Brief* programme on Desert Radio and publishing an article on the amendments in *The Namibian* newspaper.

The proposed amendments were passed by Parliament in late 2022. While these amendments are very welcome we believe that future amendments should clarify the definition of "sexual act" to ensure that child rapists do not escape conviction on the basis of technicalities.

Amendments to the Combating of Domestic Violence Act

The Combating of Domestic Violence Amendment Bill was introduced in Parliament in February. We supported all of the proposed amendments, which were based on part on past GR&AP research findings. However, in conjunction with other civil society groups, we lobbied for an additional amendment that would address the exclusion of same-sex couples from the coverage of the law.

A variety of lobbying materials were shared with Parliamentarians and partners concerned with LGBTIQ+ issues.

This advocacy effort was unsuccessful. The amendments ultimately passed by Parliament did *not* include the proposed change on same-sex couples. We hope that this issue can still be taken forward in the future, through additional law reform or by means of a constitutional challenge.

7 REASONS TO PROTECT SAME-SEX COUPLES UNDER THE COMBATING OF DOMESTIC VIOLENCE ACT

The current Combating of Domestic Violence Act 4 of 2003 is about to be amended. Section 3(1) of the Act lists several forms of domestic relationships. The assistance for victims of domestic violence applies only to these listed types of relationships. Currently, the section is worded so that it covers only people "of different sexes" who are cohabiting or in dating relationships. Thus, same-sex couples are excluded from any protection under the Act. The LAC suggests removing the phrase "being of different sexes" from the Act, so as to extend protection against domestic violence to same-sex couples, for the following reasons:

- 1. Failing to protect persons in same-sex relationships from domestic violence may violate the Namibian Constitution, which is Namibia's Supreme Law. This could violate the constitutional right to dignity and protection against cruel, inhuman or degrading treatment (Art 8) or the right to equality before the law (Art 10(1)). Even though the Supreme Court of Namibia ruled in the 2001 Frank case! that the existence of a same-sex relationship was irrelevant to an application for permanent residency, the Court explicitly stated: "Nothing in this judgment justifies discrimination against homosexuals as individuals, or deprive[s] them of the protection of other provisions of the Namibian Constitution."
- 2. All persons living in Namibia, regardless of their sexual orientation, deserve the same protection from violence. Protecting same-sex couples from domestic violence does not necessarily mean that the government approves of or encourages such relationships. It merely fulfils government's obligation to protect all persons in the Namibian house. It is a reality that some Namibians are living in same-sex relationships. Protecting same-sex couples against violence will not lead to more people living in such relationships; conversely, failing to protect same-sex couples from domestic violence will not discourage them from staying together.
- 3. Namibia's National Human Rights Action Plan 2015-2019 proposes as a key intervention the need to "research and review laws and policies to identify provisions that discriminate against vulnerable groups", including "sexual minorities". The exclusion of same-sex couples from the protection from domestic violence is an example of such discrimination against "sexual minorities" and on the issue of discrimination against vulnerable groups, the Plan includes a commitment to implement legal reform as necessary to implement "the right not to be discriminated against" (Focus Area 7).

Combating of Sexual Exploitation Bill & Combating of Harassment Bill


GR&AP has expressed concern in numerous forums about the inadequacy of the provisions in the draft Cybercrime Bill regarding harassment and child sexual exploitation and grooming. We favour a more comprehensive and detailed approach that covers both online and offline manifestations of these harms. which often occur in tandem. We have also pointed out the need to carefully balance protection with freedom of speech and expression. During 2022, we promoted a draft Combating of Sexual Exploitation Bill and a Combating of Harassment Bill prepared by LAC - which are designed to form a trio of legislation along with the Prohibition of Unfair Discrimination, Discriminatory Harassment and Hate Speech Bill which has been prepared by the Office of the Ombudsman. This set of proposed bills would provide for quick and accessible remedies similar to domestic violence protection orders, as well as new crimes aimed at all aspects of sexual exploitation of children and persons with severe mental disabilities.



During 2022, we gave presentations on the proposed bills to the Namibia National Child Online Protection Taskforce, the School Health Task Force, and a consultative meeting on the Cybercrime Bill convened by the Ministry of Information and Communications Technology (MICT) and the Ministry of Gender Equality, Poverty Eradication and Social Welfare (MGEPESW) in October 2022.

What is the Draft Combating of Sexual Exploitation Bill?

- A proposed law creating offences for child pornography, voyeurism, non-consensual distribution of intimate images, grooming and other forms of sexual exploitation
- It gives particular attention to the protection of children and persons with severe mental disabilities
- It addresses all forms of sexual exploitation, online and offline in one law
- It provides remedies mainly in the form of criminal sanctions, plus procedures for quick removal of illegal online material



What is the draft Combating of Harassment Bill?

- Harassment encompasses physical, verbal, and online harassment behavior that causes physical or mental harm such as following a person or lurking outside a person's home or place of business, or sending repeated unwanted or frightening messages.
- This proposed law prohibits all forms of harassment, both online or offline, and in all situations, regardless of the existing relationship between perpetrator and victim.
- It aims to create an accessible legal approach for providing quick protection to a victim, particularly in situations where there is no act of violence or overt threat of violence, meaning that the issue is not addressed by existing criminal laws.




Law reform on family issues

We provided research and input to the relevant ministries on the Marriage Bill, Divorce Bill and Uniform Matrimonial Property Regime Bill. We discussed these Bills at numerous workshops and information sessions, including a consultation on the Divorce Bill convened by the Ministry of Justice in June.

While some groups worry that the proposed change to a no-fault system might encourage divorce, research shows that making divorce difficult does not keep couples together – for the most part, it just pushes them to separate informally while remaining legally married, creating difficulties down the line when one partner dies. Moreover, making it hard for spouses to separate in the Namibian context of widespread domestic violence amplifies the danger for vulnerable women.


GR&AP also opposed the idea of retaining "forfeiture of patrimonial benefits" under the new Divorce Act, since this often disadvantages women who typically earn less; we suggest a system that would give the court discretion to adjust the division of property where appropriate, in light of the contributions of each spouse (taking into account financial contributions as well as the work of child-rearing and caring for the household).



Future amendments to the Child Care and Protection Act

GR&AP has compiled some suggestions for fine-tuning the Child Care and Protection Act and its

accompanying regulations, based on issues which have come to our attention while preparing educational materials and working with clients and service providers. We made presentations on some of the concerns which have come to light at meetings attended by magistrates and staff from the Office of the Ombudsman and the Ministry of Gender Equality, Poverty Eradication and Social Welfare (MGEPESW). We hope to continue to support the Ministry as it takes forward the process of refining the law.

Sex offender register

One issue that inspired a great deal of debate during 2022 is a proposal for a sex offender register, which refers to a list of persons who have committed certain criminal offences, often with information about their current place of residence and employment. GR&AP supports the alternative of expanding on the existing system of police clearance certificates, expanding on the

existing scheme under the Child Care and Protection Act aimed at protecting children from sexual

predators by extending it to persons who seek to work with persons with mental disabilities, in care homes

for the elderly, or in other settings where they would have access to vulnerable persons. We also proposed emphasis more on targeted rehabilitation programmes as a means of reducing re-offending. We made presentations on this issue at various including stakeholder forums, а consultation organised by the Ministry of Justice in March. We also produced a ProBono article and a PowerPoint presentation on this topic, which are both available on the LAC website.

Repeal of Obsolete Laws Bill

GR&AP provided research and information to the Law Reform and Development Commission as background to this law. LAC's input was acknowledged by the Minister of Justice in her Parliamentary speech introducing this Bill, which was passed by Parliament in late 2022.

REPEAL OF OBSOLETE LAWS BILL

... the second phase of the Repeal of Obsolete Law Project was reinforced by the submission of proposals by various organisations, ministries, agencies and civil societies in Namibia... In particular, I want to single out the Legal Assistance Centre (LAC) for their role in identifying some obsolete laws and assisting with some research...

We further found that there is some confusion as to whether a particular statute does or does not find application in Namibia. The Namlex resource maintained with regular updates by the LAC is valuable in this regard, as it provides information that clarifies the correct position....

Honourable Deputy Speaker, Honourable Members, members of the public, the Repeal of Obsolete Laws Bill will provide for the repeal of certain obsolete laws many of which are discriminatory on the grounds of gender, race, colour, ethnic origin, religion, creed, as well as social and economic status.

Trafficking

GR&AP has for some years now been compiling information on trafficking cases from press reports and court cases, to inform our understanding of this issue. We recently updated this information and have shared it with the Ministry of Gender Equality, Poverty Eradication and Social Welfare (MGEPESW) and other interested stakeholders.

Draft Data Protection Bill

GR&AP submitted comments to the Ministry of Information and Communications Technology (MICT) on the draft Data Protection Bill, as a supplement to the ACTION Coalition submission which LAC joined.

NGO registration

In October, GR&AP gave input at a consultative meeting on the government's attempt to revive a 2005 "Civic Organisation Partnership Policy" aimed at NGO registration. The input focussed on how registration schemes in other countries in Africa have evolved into government control and suppression.






Advocacy Advice for Civil Society



In 2021, we published summaries of statutes on three themes: (1) Citizenship; (2) Crime, corruption and policing; and (3) Public protests.




In 2022, we added another volume pf statute summaries on the three branches of government: (1) **Executive branch** (2) **Legislative branch** (3) **Judicial branch**.

LAC prepared submissions on the concept of NGO registration for a consultation around the government's Civic Organisations Partnership Policy. We produced a background paper on the experience of other countries in African with "voluntary registration", which often evolves into "mandatory registration" that is often used to restrict civil society space. The paper includes a discussion of the links between NGO registration and allegations of money-laundering and terrorism financing by NGOs.

The Child Care and Protection Act 3 of 2015 is Namibia's key legislation on children. It came into force in early 2019. This law covers a wide range of topics, including the respective rights and duties of parents of children born outside marriage, procedures to assist children in need of protective services, the registration of various facilities for the care of children, consent to medical interventions involving children, kinship care, foster care, adoption and social grants for children. The materials described below have been prepared by the Legal Assistance Centre in partnership with the Ministry of Gender Equality, Poverty Eradication, and Social Welfare.



In January, Dianne Hubbard discussed research on **vaccine mandates** on NBC's *Covid-19 Update*.

In February, Dianne gave a talk on the *Parliamentary Brief* programme on *Desert Radio* on the **Combating of Rape Amendment Bill** (along with James Ithana from Regain Trust). This programme was used as the basis for an article in *The Namibian*.

In April, a Parliamentary discussion on **rape in marriage** inspired a great deal of public debate. GR&AP contributed remarks for articles in *The Namibian* and *Namibian Sun*, and put brief posts on the issue on Twitter and Facebook.



NAMLEX LEGAL DATABASES

NAMLEX: NAMLEX is a list of the laws in force in Namibia organised by topic, with brief descriptions of each law and its subsidiary regulations, rules, notices etc.

NAMLEX APPENDIX: NAMLEX APPENDIX contains information on international treaties applicable to Namibia.

ANNOTATED LAWS: This database contains the full text of all statutes and post-independence regulations in force in Namibia, with consolidated amendments.

During 2022, we completed three updates of NAMLEX and two updates of **NAMLEX** APPENDIX, with all amendments and reported court cases incorporated as well as references to legal commentary published in Namibia.

The annotated statutes and regulations are upto-date, and we have managed to add information about pre-independence regulations in respect of most of the statutes.

The process of scanning all of Namibia's preindependence Official Gazettes is continuing, with the help of Assens Siloka.

Anèl Stegmann developed the **NAMLEX Pocket** Law app for LAC, which provides optimal access

to the databases on cell phones and other mobile devices. It is available for free on the Apple and Google Play stores.

Stock Theft Act 12 of 1990

ACT

To consolidate and amend the laws relating to the theft of stock and produce.

(Signed by the President on 20 August 1990)

ARRANGEMENT OF SECTIONS

- Failure to give satisfactory account of possession of stock or produce Absence of reasonable cause for believing stock or produce properly acquired
- Entering enclosed land or kraal, shed, stable, or other walled place with intent to steal
- stock or produce
- Delivery of stock or produce between sunset and sunrise Document of identification to be furnished by person who disposes of stock
- Acquisition of stock or produce from persons whose places of residence are unknown
- Stock or produce driven, conveyed or transported on or along public roads Arrest and search without warrant
