





2. Elenga oli na okutsilika etseyitho poombelewa dhoshilongo, tali holola uukwatya weindilo, ngashi edhina lyanakuninga eindilo nosho tuu. Kehe ngoka e li ompinge ne indilo lyoye ota vulu oku li kondjitha. Etseyitho ndika oli na okutsilikwa uule womasiku gaheyali.
3. Elenga otashi vulika li kale lya hala okukonakona mule eindilo, unene ngele opu na mboka ye li ompinge nalyo.
4. Ngele elenga olya koleke eindilo, ota li li tumu pamwe nuukwatya wehala ndyoka wa peva kolaatawiliki yevi lyaayehe. Otashi vulika elenga li tinde eindilo.
5. Ngele elenga olya koleke eindilo, olaatawiliki yevi lyaayehe otayi konakona ngele elenga olya landula oveta sho lya koleke eindilo. Olaatawiliki otayi vulu wo oku ka konga uuyelete kaantu yalwe.
