#### MARTIAL LAW REGULATIONS.

Regulations Nos 92 and 93 issued under Martial Law by and with the approval of the Administrator,

#### REMOVAL OF LIVESTOCK,

- 92. (1) Martial Law Regulation No. 6, published iu Gazette No. I of the 13th August, 1915, shall be and is hereby amended by the deletion from the sixth and seventh lines thereof of the words "and/or livestock".
- (2) Any person who removes or attempts to remove, or causes, counsels, aids or abets the removal of livestock across the borders of the Protectorate without a permit shall be guilty of an offence and shall upon conviction be liable to a fine not exceeding one thousand pounds sterling, or in default of payment to imprisonment with or without hard labour for a period not exceeding five years or to both such fine and such imprisonment.

Upon conviction the court may order the confiscation of the livestock forming the subject of the charge.

(3) For the purposes of any martial law regulation regarding the removal of livestock the term "livestock" and the term "stock" shall mean cattle, sheep, goats, horses, mules, donkeys, pigs and any other animal which the Administrator may indicate by notice published in the Gazette.

#### REMOVAL OF LIVESTOCK.

- 93. Martial Law Regulation No. 87 published in Gazette No. 16 of the 28th February, 1918, shall be and is hereby amended by the addition thereto of the following paragraph, which shall be taken and read as one therewith.
  - 10. Notwithstanding any existing provision of law, within the districts of WARMBAD and AROAB no person shall move or attempt to move, or assist any other person to move any livestock beyond the borders of any farm, municipal commonage, native location or other property to any other place, save under a permit issued by the Military Magistrate of WARMBAD or AROAB as the case may be.
