REGISTRATION OF VOTERS.

For the purpose of compiling a general register of voters for the first election of elective members for the Legislative Assembly and to enable the electoral divisions to be delimited in accordance with section twelve of the South Africa Constitution Act 1925 of the Parliament of the Union of South Africa, I do hereby under and by virtue of the powers vested in me by section three of the Schedule to the said Act, enjoin and direct that every person described in the first and second columns of the schedule annexed hereto shall be and is hereby appointed to make out in and for the magisterial district the name of which is set opposite to the name of each such person in the third column of the said schedule an alphabetical provisional list of all persons who are qualified to be registered as voters and who are bona fide residing in such district.

And I do further enjoin and direct that the date of the commencement of the framing of every such alphabetical provisional list shall be the 1st October 1925 and the date of the completion of every such list shall be the 31st October, 1925.
