REGULATIONS.

ROADS: SPECIFICATIONS FOR SIGNPOSTS.

2. Every owner of land, which is not situate within the area of jurisdiction of a roads board, a municipality or a village management board, shall, before a date to be fixed by the magistrate of the district in which the land is situate, and stated in a letter addressed to the owner and sent to him by registered post, erect and maintain at any point on such land at which any road shall turn off from a public road a signpost in accordance with the following specifications:—

- (a) The signpost shall consist of a stout metal standard to which is affixed, eight feet from the ground, a metal sheet fifteen inches by nine inches, not less than one-sixteenth of an inch thick.
- (b) The destination of the road which turns off from the public road at that point shall be painted on the metal sheet in white letters not less than one and a half inches high.

3. Every owner of land, which is not situate within the area of jurisdiction of a roads board, a municipality or a village management board, on which any road has been closed by the construction of a fence across it or otherwise, shall, before a date to be fixed by the magistrate of
