## ORDINANCE

To apply a sum not exceeding twenty thousand pounds towards the service of the Territory of South West Africa for the financial year ending on the thirty-first day of March, 1929.

(Assented to 27th February, 1929.)  
(English text signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

Administration  
Account charged  
with £20,000 on  
loan account.

1. The Administration Account of the Territory of South West Africa is hereby charged with such sums of money as may be required for the service of the Territory (and chargeable to loan account) during the year ending on the thirty-first day of March, 1929, not exceeding in the whole the sum of twenty thousand pounds in addition to the sums charged by the Appropriation (1928—'29) Ordinance, 1928 (Ordinance No. 16 of 1928) and by Governor-General's Proclamation No. 197 of 1928.

How money to be  
applied.

2. The money appropriated by this Ordinance shall be applied to the services detailed in the Schedule hereto and more particularly specified in the Estimates of Additional Expenditure to be defrayed from Loan Funds (S.W.A. 1—'29) as approved by the Legislative Assembly, and, to no other purpose.

Short title.

3. This Ordinance may be cited as the Additional Appropriation (1928—'29) Ordinance, 1929.

DIT WORD VERORDEN deur die Wetgewende Vergadering vir die Gebied van Suidwes-Afrika as volg:—

1. Die Administrasierekening vir die Gebied van Suidwes-Afrika word hiermee belas met sodanige somme geld as wat benodig mag wees vir die diens van die Gebied (en wel ten laste van die leningsrekening) gedurende die finansiële jaar wat eindig op die een-en-dertigste dag van Maart 1929, maar gesamentlik nie meer as twintig duisend pond nie, buiten en behalwe die somme uitgetrek by die Middele (1928—'29) Ordonnansie 1928 (Ordonnansie No. 16 van 1928) en by die Proklamasie van die Goewerneur-generaal No. 197 van 1928.
