KEETMANSHOOP MUNICIPALITY.

1. In the construction of these regulations the following terms shall have the meanings herein respectively assigned to them, namely:—

- (a) "Council" shall mean the Council of the Municipality of Keetmanshoop;
- (b) "Municipal Area" shall mean the area under the jurisdiction of the Council.

2. No Native shall be in any street, public place or thoroughfare within the Municipal Area, exclusive of those portions thereof set aside as Native Locations, between the hours of 9 p.m. and 4 a.m. without a written pass or certificate from—

- (a) his employer; or
- (b) a Magistrate, Assistant Magistrate, Police Officer, Native Affairs Official, Superintendent of a Municipal Native Location, or
- (c) a person duly authorised thereto by the Council.

Such pass or certificate shall bear the date of issue thereof and shall be valid only for the period commencing at 9 p.m. on such date and ending at 4 a.m. on the following day.

3. These regulations shall not apply to any Native who is in the employ of the Council or of any Contractor to the Council while engaged upon work for the Council between the hours of 9 p.m. and 4 a.m. and who shall wear a distinctive badge of a pattern prescribed by the Council showing that he is an employee of the Council or of such Contractor.
