WHEREAS it is expedient to make provision for the discontinuance of the payment of a local allowance to the Judge of the High Court of South West Africa;

NOW THEREFORE, under and by virtue of the powers in me vested I do hereby proclaim, declare and make known as follows:—

1. Section *three* of the Administration of Justices Proclamation, 1919 (Proclamation No. 21 of 1919), as amended by section *one* of the Administration of Justice Proclamation Amendment Proclamation, 1930 (Proclamation No. 16 of 1930), is hereby further amended by the deletion of the words “and in addition a local allowance not exceeding two hundred and fifty pounds per annum” occurring in sub-section (2) thereof.

2. This Proclamation may be cited as the Administration of Justice Amendment Proclamation, 1933.
