- (2) Niemand mag binne die Dorpsbestuursraadsgebied enige motorvoertuig of motorfiets drywe of laat drywe nie tensy dit voorsien is van 'n doelmatige geruisdemper soos dat, wanneer die masjien daarvan in werking is, die gas deur sodanige geruisdemper gaan op sodanige manier dat die geraas van die ontploffings faamlik gedemp word.
- (3) Enige persoon wat enige van voorafgaande regulasies oortree, is by skuldigbevinding blootgestel aan 'n boete van hoogstens vyf pond of by wanbetaling aan gevangenisstraf met of sonder harde arbeid vir 'n tydperk van hoogstens een maand.

VILLAGE MANAGEMENT BOARD AREA: MARIENTAL.

The Administrator has been pleased, in terms of Section *three* of the Village Management Boards Proclamation, 1925 (Proclamation No. 2 of 1925), to make the following regulations to be of force and effect within the Village Management Board Area of Mariental:—

STREET AND TRAFFIC REGULATIONS.

- (1) Every person driving a motor vehicle or riding a motor cycle shall have affixed on the front part thereof a bell, horn or other apparatus capable of giving sufficient warning of the approach or position of such motor car or motor cycle; and the person driving such car or riding such cycle shall sound such bell, horn or other apparatus when overtaking any other vehicle, horse, or other animal, or pedestrian, and when turning.
- (2) No person shall within the Village Management Board area drive or cause or allow to be driven any motor vehicle or motor cycle unless it be provided with an efficient silencer, in such a way that when the engine thereof is in motion the exhaust will pass through such silencer in such a manner as reasonably to deaden the sound of the exhaust explosions.
- (3) Any person contravening any of the foregoing regulations or any order made thereunder shall upon conviction be liable to a fine not exceeding five pounds or in default of payment to imprisonment with or without hard labour for a period not exceeding one month.
