WHEREAS it is desirable to make provision for an increase in the salary of the Judge of the High Court of South West Africa;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. Sub-section (2) of section *three* of the Administration of Justice Proclamation 1919 (Proclamation No. 21 of 1919), as amended by the Administration of Justice Proclamation Amendment Proclamation, 1930 (Proclamation No. 16 of 1930), and by the Administration of Justice Amendment Proclamation, 1933 (Proclamation No. 4 of 1933), is hereby further amended by the deletion of the figures "£2250" occurring therein, and the substitution therefor of the figures "£2750".

2. This Proclamation may be cited as the Administration of Justice Further Amendment Proclamation, 1934, and shall be deemed to have come into force on the first day of April, 1934.

Dit het die Administrateur behaag om, kragtens die bepalings van artikel 4 van Proklamasie No. 15 van 1931, onderstaande regulasies wat van toepassing is op Inluisteraars van en Amateur-proefnemers met Draadloos, goed te keur:—

1. No person shall be entitled to be in possession of any Wireless receiving gear in excess of 14 days unless there has previously been obtained from the Director of Posts and Telegraphs a licence for the use thereof.

Such licence shall be obtainable upon application and upon payment of the sum of 5/-.

Radio apparatus operated from a private Motor Car is covered by the licence issued in connection with a residential Wireless licence provided the car is registered in the name of the party in possession of the residential wireless licence.

2. No person shall be entitled to experiment in Wireless Communication, unless he is a bona fide student and experimenter in the science of Wireless Communication, and has satisfied the Director of Posts and Telegraphs of his competency. The Director of Posts and Telegraphs, if he is satisfied of the bona fides of such person, may issue a licence to experiment for one year on payment of a fee of 20/-.
3. All dealers in Wireless apparatus are required to take out a licence at a fee of 5/-. Dealers in Wireless apparatus shall furnish to the Director of Posts and Telegraphs details of all Wireless equipment sold by them together with the name and address of the purchaser within 14 days of the transaction being effected.

Wireless Licences expire on the 31st March of each year and require to be renewed within 30 days thereof.

The Director of Posts and Telegraphs may nominate one or more persons to act as inspectors of licences.

2. Niemand is geregtig om te eksperimenteer in verband met draadlose Kommunikasie nie, tensy hy 'n bona fide student en proefnemer in die wetenskap van draadlose Kommunikasie is en die Direkteur van Pos- en Telegraafwese oortuig het van sy bevoegdheid om dit te doen. As die Direkteur van Pos- en Telegraafwese oortuig is van die bona fides van sodanige persoon, kan hy 'n lisensie uitrek om een jaar lank te eksperimenteer na betaling van 'n bedrag van 20/-.
3. Alle handelaars met draadloos-toestelle moet 'n lisensie verkry waarvoor 'n bedrag van 5/- betaalbaar is. Handelaars met draadloos-toestelle moet aan die Direkteur van Pos- en Telegraafwese alle besonderhede verskaf in verband met alle draadloos-uitrusting wat deur hulle verkoop word tesame met die naam en adres van die koper binne 14 dae nadat die transaksie plaasgevind het.

Lisensies vir draadloos-toestelle verval op 31 Maart van elke jaar en moet binne 30 dae daarna hernuwe word.

Die Direkteur van Pos- en Telegraafwese kan een of meer persone aanstel om op te tree as inspekteurs van lisensies.
