ORDONNANSIE 1934: UITVAARDIGING VAN.

His Honour the Administrator has been pleased to assent in terms of Section *thirty-two* of the South West Africa Constitution Act, 1925 (Act No. 42 of 1925), to the following Ordinance which is hereby published for general information in terms of Section *thirty-four* of the said Act:—

**ORDINANCE**

To apply a further sum not exceeding twelve thousand five hundred and forty-eight pounds towards the service of the Territory of South West Africa for the financial year ending on the 31st day of March, 1935.

(Assented to 13th December, 1934.)  
(English text signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. The Administration Account of the Territory of South West Africa is hereby charged with the sum of twelve thousand five hundred and forty-eight pounds on Revenue account to meet certain expenditure over and above the amounts appropriated for the service of the financial year ending on the 31st March, 1935, as specified in Ordinance No. 2 of 1934. Such expenditure is set forth in the Schedule to this Ordinance.

2. This Ordinance may be cited as the Additional Appropriation (1934-'35) Ordinance, 1934.
