PROCLAMATION

By HIS HONOUR DAVID GIDEON CONRADIE,
ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 16 of 1936.]

WHEREAS it is desirable to amend the law relating to Public Health;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. Sub-section (2) of section *seventy-one* of the Public Health Act, 1919 (Act No. 36 of 1919), of the Parliament of the Union of South Africa, as applied to the Territory and modified for the purpose by the Public Health Proclamation, 1920 (Proclamation No. 36 of 1920), is hereby further amended by the addition of the following words at the end thereof:—

"The port health officer shall be responsible for the granting of pratique as aforesaid, and if the port health officer is not available on the arrival of any vessel at any port or place in the Territory, any officer duly authorised thereto by the Administrator may grant pratique."

2. This Proclamation may be cited for all purposes as the Public Health Amendment Proclamation, 1936.

His Excellency the Governor-General has been pleased to approve of the grant of provisional recognition to Mr. JOHN JOSEPH KEMSLEY as Consul for Peru at Port Elizabeth.

The Administrator has been pleased under and by virtue of the powers in him vested by Sections *four* and *twenty-three* of the Diseases of Stock Proclamation (Proclamation No. 28 of 1920) to make the following regulations:—

REGULATIONS GOVERNING THE INTRODUCTION OF STOCK AND PRODUCE FROM THE BECHUANALAND PROTECTORATE.

1. Government Notice No. 53 of 22nd April, 1931, and Government Notice No. 143 of 24th October, 1934, are hereby amended by the deletion of the words "and/or the Bechuanaland Protectorate" wherever they occur in the said notices.

NADEMAAL dit wenslik is om die wet met betrekking tot publieke gesondheid te wysig;

SO IS DIT dat ek, onder en kragtens die bevoegdhede aan my verleen, hiermee proklameer, verklaar en bekend maak as volg:—

1. Subartikel (2) van artikel *een-en-sewentig* van "De Publieke Gezondheids Wet 1919" (Wet No. 36 van 1919, van die Parlement van die Unie van Suid-Afrika), soos toegepas op die Gebied en vir die doel gewysig deur die "Publieke Gezondheids Proklamatie, 1920" (Proklamasie No. 36 van 1920), word hiermee verder gewysig deur die toevoeging van die volgende woorde aan die end daarvan:—

"De haven-gezondheidsbeampte is verantwoordelik voor het verlenen van die voormalde praktiek, en indien die haven-gezondheidsbeampte niet beskikbaar is bij die aankomst van enig vaartuig in een haven of plaats in het Gebied, mag enig daartoe behoorlike beampte van die Administrateur gemachtigde beampte verlenen."

2. Hierdie Proklamasie kan vir alle doeleindes aangehaal word as die Publieke Gesondheids Wysigingsproklamasie 1936.

Dit het Sy Eksellensie die Goewerneur-Generaal behaag om sy goedkeuring te heg aan die voorlopige erkennung van Mn. JOHN JOSEPH KEMSLEY as Konsul vir Peru in Port Elizabeth.

Dit het die Administrateur behaag om, ingevolge en kragtens die bevoegdhede aan hom verleen by artikels *vier* en *drie-en-twintig* van "De Veeziekten Proklamatie" (Proklamasie No. 28 van 1920), die volgende regulasies vas te stel:—

REGULASIES BETREFFENDE DIE INVOER VAN VEE EN PRODUKTE UIT DIE BETSJOEANALAND-PROTEKTORAAT.

1. Goewermentskennisgewing No. 53 van 22 April 1931 en Goewermentskennisgewing No. 143 van 24 Oktober 1934 word gewysig deur die woorde "en/of die Betsjoeanaland-Protektoraat", waar hulle in genoemde kennisgewings voorkom, te skrap.

2. *Cattle:* The introduction of cattle is prohibited.
3. *Equines:* The introduction of equines is permitted provided:
- The animals enter South West Africa at the Police Station at Sandfontein on the Bechuanaland—Gobabis border and the entry is reported to the South West Africa Police Station Commander there.
 - The animals are accompanied by a certificate under the hand of a Bechuanaland Government Veterinary Officer testifying that they have passed the Mallein test, that all stallions and mares have passed the appropriate test for Dourine, that all animals are free from infectious and contagious disease and originate from a clean area.
4. *Small stock:* The introduction of sheep and goats is permitted provided:
- The animals enter South West Africa at the Police Station at Sandfontein.
 - The animals are inspected by an officer of the South West Africa Police at Sandfontein and are found to be visibly free from scab and other contagious or infectious disease.
 - The animals receive two dippings at Sandfontein at the owner's expense and under Police supervision, in an approved dip. The owner must arrange to quarantine the sheep at Sandfontein during the interval between the two dippings.
- Pigs:* The introduction of pigs is permitted provided:
- The animals are purebred and under six months old.
 - The animals are accompanied by a certificate under the hand of a Bechuanaland Government Veterinary Officer testifying that they are free from infectious and contagious disease and that they have been under the direct supervision of the Government Veterinary Officer for a period of not less than one month immediately preceding their introduction into South West Africa.
 - The animals are conveyed from their place of origin by motor transport to Sandfontein Police Station where their entry must be reported to the South West Africa Police Station Commander.
- Dogs and Cats:* The introduction of dogs and cats will be permitted provided:
- The animals enter South West Africa at Sandfontein.
 - The animals are accompanied by a certificate under the hand of a Bechuanaland Government Veterinary Officer testifying that they are free from infectious and contagious disease and originate from a clean area.
- Animal Products:*
- A. Skins, hides, horns, karosses, furs, riems, game biltong. The introduction of these articles will be permitted provided:
- The articles are brought into South West Africa at Sandfontein, and the entry is reported to the South West Africa Police Station Commander at that Post.
 - The articles are accompanied by a certificate under the hand of a Bechuanaland Government Veterinary Officer testifying that they have been inspected and found to be properly dried or cured and that they originate from disease-free areas in Bechuanaland and have not been introduced from adjoining territories.
- B. *Dairy Produce:* The introduction of cream will be permitted provided:
- The cream is contained in proper cans securely closed.
 - The cream is conveyed by motor transport via Sandfontein Police Station and is consigned direct to the Creamery at Gobabis.

- Die diere Suidwes-Afrika by die Polisiestasie op Sandfontein binnekum.
 - Die diere deur 'n beampie van die Suidwes-Afrika Polisie op Sandfontein ondersoek word en hy bevind dat die diere sigbaar vry is van brandsiekte en ander besmetlike en aansteeklike siektes.
 - Die diere tweemaal op Sandfontein op die eienaar se onkoste in 'n goedgekeurde dip onder toesig van die polisie gedip word. Die eienaar moet reël dat die diere op Sandfontein in kwarantyn geplaas word tussen die tye wat hulle gedip word.
- Varke:* Die invoer van varke word toegelaat mits:-
- Die diere opreg geteel en ten uiterste ses maande oud is.
 - 'n Sertifikaat deur 'n veearts van die Betsjoeanalandse Goewerment onderteken, saam met die diere gestuur word ter verklaring dat hulle vry is van besmetlike en aansteeklike siektes en dat hulle onder die regtreetse toesig van die Goewermentsveearts was vir minstens een maand voor hulle invoer in Suidwes-Afrika.
 - Die diere per motorvoertuig van die plek waar hulle vandaan kom na die Polisiestasie op Sandfontein gebring word, en hulle aankoms aldaar aan die stasiebevelvoerder van die Suidwes-Afrika Polisie bekendgemaak word.
- Honde en Katte:* Die invoer van honde en katte word toegelaat mits:-
- Die diere Suidwes-Afrika by Sandfontein binnekum.
 - 'n Sertifikaat deur 'n veearts van die Betsjoeanalandse Goewerment onderteken, saam met die diere gestuur word ter verklaring dat hulle vry is van besmetlike en aansteeklike siektes en dat hulle uit 'n suiwer gebied kom.
- Dierlike Produkte:*
- A. Velle, huide, horings, karosse, pelse, rieme, wildsbiltong. Die invoer van hierdie produkte word toegelaat mits:
- Die artikels in Suidwes-Afrika by Sandfontein ingebring en die stasiebevelvoerder van die Suidwes-Afrika Polisie aldaar van die invoer verwittig word.
 - Die artikels vergesel word van 'n sertifikaat deur 'n veearts van die Betsjoeanalandse Goewerment onderteken, ter verklaring dat hulle ondersoek is, dit bevind is dat hulle behoorlik gedroog en gesout is, en dat hulle uit streke in Betsjoeanaland kom wat vry is van siektes en nie uit die aangrensende gebiede ingevoer is nie.
- B. *Suiwelprodukte:* Die invoer van room word toegelaat mits:
- Die room in gesikte kanne bevat word wat sorgvuldig toegemaak is.
 - Die room per motorvoertuig oor die polisiestasie op Sandfontein gebring word en regtreetks na die suiwel-fabriek op Gobabis versend word.

RULES.

1. Order VI, Rule 10 of the Second Schedule to the Magistrates' Courts Proclamation, 1935, is hereby amended by the addition of the following paragraph as paragraph (4):-

"(4) A certificate by a postal official to the effect that such registered letter has been tendered to the addressee or to any person purporting to sign for the addressee as stated in paragraph (2), or to the effect that it has been placed in the addressee's private post-bag, shall be a sufficient warrant for the Messenger to make a due return of service."

2. The fees and charges allowed under Table A of the Second Annexure to the Second Schedule of the Magistrates' Courts Proclamation, 1935 (Proclamation No. 31 of 1935), shall be increased by ten per cent, except in regard to items 70 to 75 inclusive, relating to fees to Counsel.
