**PROKLAMASIE**

VAN SY EDELE DAVID GIDEON CONRADIE,  
ADMINISTRATEUR VAN SUIDWES-AFRIKA.

No. 4 van 1937.]

NADEMAAL dit wenslik is om die Wet betreffende verhoeding van oortreding op Kroongrond in die Gebied te wysig, en om met sake in verband daarmee te handel;

SO IS DIT dat ek, kragtens en ingevolge die bevoegdheid my verleen, hierby proklameer, verklaar en bekendmaak as volg:-

1. Artikel een van die "Kroonlanden (Overtreding Proklamatie, 1919)" (Proklamasie No. 7 van 1919) word hierby gewysig deur die volgende woorde aan die end daarvan toe te voeg:-

"Met dien verstande dat tydelike verblyf op Kroongrond gemagtig kan word kragtens en ingevolge 'n permit uitgereik deur die magistraat van die betrokke distrik of enige ander beampete behoorlik daartoe gemagtig deur die Administrateur.

Die Administrateur kan regulasies, algemeen of spesifiek vir bepaalde gebiede, opstel in verband met die fees betaalbaar vir sulke permitte, benewens die algemene voorwaardes waarvolgens sulke permitte uitgereik kan word. Die verbreking van enige bepaling in sulke regulasies vervat, sal 'n oortreding wees en strafbaar wees soos bepaal by artikel ses."

2. Hierdie Proklamasie kan vir alle doeleindes aangehaal word as die Kroongrond- (Oortreding) Wysigingsproklamasie, 1937.

**PROCLAMATION**

By HIS HONOUR DAVID GIDEON CONRADIE,  
ADMINISTRATOR OF SOUTH WEST AFRICA

No. 4 of 1937.]

WHEREAS it is desirable to amend the law relating to the prevention of trespassing on Crown land in the Territory, and to deal with matters incidental thereto;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:-

1. Section one of the Crown Lands (Trespass) Proclamation, 1919 (Proclamation No. 7 of 1919), is hereby amended by the addition of the following words at the end thereof:-

"Provided that temporary residence upon Crown land may be authorised under and by virtue of a permit issued by the Magistrate of the district concerned, or any other official duly authorised thereto by the Administrator.

The Administrator may make regulations, generally or specifically for particular areas, in regard to the fees payable for such permits, and the general conditions under which such permits may be issued. A contravention of any provision contained in such regulations shall be an offence and punishable as provided in section six".

2. This Proclamation may be cited for all purposes as the Crown Lands (Trespass) Amendment Proclamation, 1937.

The Administrator has been pleased, under the powers vested in him by Section *twenty* (2) of the Natives (Urban Areas) Proclamation, 1924 (Proclamation No. 34 of 1924), to approve of the subjoined regulations framed by the Native Commissioner, Grootfontein, under sub-section (2) of Section *twenty* of the aforesaid Proclamation to be of force and effect from the 1st day of August, 1936, in respect of the area known as SMALL SETTLEMENT OTAVI No. 102 and farm SWAPS No. 755.

**LOCATION REGULATIONS.**

Framed under section twenty (2) of the Natives (Urban Areas) Proclamation, 1924.

1. A Registering Officer shall be appointed and he shall carry out such instructions as he may receive from time to time from the Secretary for South West Africa or from the Magistrate at Grootfontein.
