ALGEMENE VRYSTELLING: BASUBIA- EN MAFUE-(BAYEYI)-STAMHEFFING: OOSTELIKE CAPRIVI ZIPFEL.

Hierby word vir algemene informasie bekendgemaak dat Sy Edele die Minister van Naturellesake ooreenkomsdig paraaf (b) van subartikel (11) van artikel *twoe* van die Caprivi Zifel Aangeleenthede Proklamasie, No. 27 van 1930, uitgevaardig deur die Administrateur van die Mandaatgebied Suidwes-Afrika, soos gewysig deur artikel *een* van die Proklamasie ter wysiging van die Oostelike Caprivi Zipfel-trustfondse, No. 73 van 1940, alle persone wat aanspreeklik is vir die betaling van die heffing, vir die jaar 1941, opgelê by Goewermentskennisgewing No. 616 van 19 April 1940 op die lede van die Basubia- en Mafue- (Bayeyi)-stamme in die Oostelike Caprivi Zipfel, in die algemeen vrygestel het.

GENERAL EXEMPTION: BASUBIA AND MAFUE-(BAYEYI) TRIBAL LEVY: EASTERN CAPRIVI ZIPFEL.

It is hereby notified for general information that the Honourable the Minister of Native Affairs has, in terms of paragraph (b) of sub-section (11) of section two of the Caprivi Zipfel Affairs Proclamation No. 27 of 1930, issued by the Administrator of the Mandated Territory of South West Africa, as amended by section one of the Eastern Caprivi Zipfel Trust Funds Amendment Proclamation No. 73 of 1940, generally exempted all persons liable to pay the rate for the year 1941, levied under Government Notice No. 616 dated the 19th April, 1940, upon the members of the Basubia and Mafue (Bayeyi) Tribes, in the Eastern Caprivi Zipfel.
