PROKLAMASIE

VAN SY EDELE PETRUS IMKER HOOGENHOUT,
ADMINISTRATEUR VAN SUIDWES-AFRIKA.

No. 24 van 1945.]

NADEMAAL dit in die openbare belang wenslik is om voorsiening te maak vir die opname van 'n sensus van woonhuise;

SO IS DIT dat ek, kragtens die bevoegdheid my verleen, hierby soos volg proklameer, verklaar en bekendmaak:—

1. Die Administrateur mag van tyd tot tyd in sodanige gebiede as wat hy mag bepaal en na bekendmaking in die *Offisiële Koerant*, Sensusbeampes aanstel met die doel om 'n sensus in die aldus bepaalde gebied op te neem.

2. (1) 'n Sensusbeampte mag met die doel om sy plig ingevolge hierdie Proklamasie na te kom enige grond, perseel of woonhuis binnegaan en toegang daartoe verkry.

(2) 'n Sensusbeampte mag, in die behoorlike vervulling van sy pligte ingevolge hierdie Proklamasie alle vrae stel waarvoor in die vorm voorsiening gemaak is wat in die Bylae van hierdie Proklamasie voorgeskryf is, en elke bewoner van of persoon wat toesig het oor 'n woonhuis, aan wie sodanige vraag gestel word, moet dit na sy beste kennis en wete beantwoord.

3. (1) 'n Sensusbeampte mag die vorm wat in die Bylae van hierdie Proklamasie voorgeskryf is, by enige woonhuis in 'n gebied wat deur die Administrateur vir die opname van 'n sensus van woonhuise bepaal is, agterlaat.

(2) Die bewoner van of persoon wat toesig het oor 'n woonhuis by wie die voorgeskrewe vorm agtergelaat is, moet dit binne agt-en-veertig uur in elke besonderheid invul, aan die sensusbeampte wat dit invoerder, aflewer.

4. Elke sensusbeampte wat—

(a) aan 'n persoon 'n aanstootlike of onbehoorlike vraag stel; of

(b) van 'n persoon, behalwe 'n gemagtigde amptenaar van die Administrasie, betaling of beloning vra, ontvang of aanneem; of

(c) enige inligting wat hy by die vervulling van sy pligte as sensusbeampte ingewin het, openbaar maak;

is skuldig aan 'n oortreding en, by skuldigbevinding, onderwerp aan 'n boete van hoogstens vyf-en-twintig pond.

PROCLAMATION

BY HIS HONOUR PETRUS IMKER HOOGENHOUT,
ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 24 of 1945.]

WHEREAS it is desirable in the public interest to make provision for the taking of a census of dwellings;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. The Administrator may from time to time and in such areas as he may determine and after notification in the *Gazette* appoint census officers for the purpose of taking a census of dwellings in the area so specified.

2. (1) A census officer may for the purpose of performing his duties under this Proclamation enter upon any land, premises or dwelling and obtain access thereto.

(2) A census officer may, in the due performance of his duties under this Proclamation ask all such questions as are provided for in the form prescribed under the Schedule to this Proclamation and every occupier or person in charge of a dwelling of whom any such question is asked shall answer the same to the best of his knowledge and belief.

3. (1) A census officer may leave the form prescribed under the Schedule to this Proclamation at any dwelling within an area determined by the Administrator for the taking of a census of dwellings.

(2) The occupier or person in charge of any dwelling at which the prescribed form has been so left, shall within forty-eight hours, deliver the same duly completed in every particular to the census officer who calls for the form.

4. Any census officer who —

(a) puts an offensive or improper question to any person; or

(b) asks, receives or takes from any person, other than an authorised officer of the Administration any payment or reward; or

(c) divulges any information obtained by him in the performance of his duties as a census officer;

shall be guilty of an offence and liable on conviction to a fine not exceeding twenty-five pounds.

- (a) versuim om na sy beste kennis en wete enige vraag te beantwoord wat deur 'n sensusbeampte aan hom gestel word en wat hy wettiglik vereis word om te beantwoord, of sodanige vraag vals beantwoord met wete dat die antwoord vals is; of
- (b) 'n valse of onjuiste vorm soos voorgeskryf in die Bylae van hierdie Proklamasie maak, onderteken of aflewer of laat maak, onderteken of aflewer met wete dat dit vals is; of
- (c) 'n sensusbeampte sodanige betreding van of toegang tot enige woonhuis of perseel soos deur hierdie Proklamasie omskryf en waarop so 'n beampte geregtig is, weier, of wat 'n sensusbeampte by die vervulling van sy pligte as sulks belemmer of hinder of wat nie die vorm in die hierin gemelde tydperk voltooi of aflewer nie;

is skuldig aan 'n oortreding en, by skuldigbevinding, onderhevig aan die boetes wat in die laaste voorafgaande artikel vermeld is.

6. „Woonhuis” beteken enige huis of gebou of bouwerk en sluit in enige kamer of plek wat vir menslike inwoning geskik is;
„Offisiële Koerant” beteken die Offisiële Koerant van die Gebied.

7. Hierdie Proklamasie heet die Proklamasie op die Sensus van Woonhuise, 1945.

5. Any occupier or person in charge of any dwelling who —

- (a) fails to answer to the best of his knowledge and belief any question asked of him by a census officer, which he may be lawfully required to answer or makes a false answer to such question, knowing the answer to be false; or
- (b) makes, signs or delivers, or causes to be made, signed or delivered any false or incorrect form as prescribed under the Schedule to this Proclamation, knowing the same to be false; or
- (c) refuses a census officer such entry on or access to any dwelling or premises as by this Proclamation that officer is entitled to have, or obstructs or hinders a census officer in the performance of his duties as such or fails to complete or deliver the form within the period specified therein;

shall be guilty of an offence and liable on conviction to the penalties mentioned in the last preceding section.

6. “Dwelling” means any house, building or structure and shall include any room or place occupied or capable of occupation as a human habitation;
“gazette” means the Official Gazette of the Territory.

7. This Proclamation shall be called the Census of Dwellings Proclamation, 1945.
