ORDONNANSIE 1947: UITVAARDIGING VAN.

ORDINANCE, 1947: PROMULGATION OF.

Dit het die Administrateur behaag om sy goedkeuring te heeg, ooreenkomstig artikel *twee-en-dertig* van „De Zuidwest-Afrika Konstitusie Wet 1925” (Wet No. 42 van 1925), aan d'e volgende Ordonnansie, wat hiermee vir algemene inligting gepubliseer word, ooreenkomstig artikel *vier-en-dertig* van gemelde Wet —

His Honour the Administrator has been pleased to assent in terms of section *thirty-two* of the South West Africa Constitution Act, 1925 (Act No. 42 of 1925), to the following Ordinance which is hereby published for general information in terms of section *thirty-four* of the said Act:—

ORDONNANSIE

ORDINANCE

Tot aanwending van 'n verdere geldbedrag van hoogstens tweehonderd-en-veertigduisend agthonderd pond vir die diens van die Gebied Suidwes-Afrika vir die boekjaar eindigende op die een-en-dertigste dag van Maart 1947.

To apply a further sum not exceeding two hundred and forty thousand eight hundred pounds towards the service of the Territory of South West Africa for the financial year ending on the thirty-first day of March, 1947.

Die Welgenode Vergadering van die Gebied Suidwes-Afrika verorden as volg:—

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Die Administrasie rekening van die Gebied Suidwes-Afrika word hiermee belas met die bedrag van tweehonderd en veertigduisend pond op die Inkomsterekening en vyftien honderd pond op die Leningsrekening tot dekking van sekere uitgawes bo en behalwe die bedrag beskikbaar gestel vir die diens van die boekjaar eindigende op 31 Maart 1947, soos in Ordonnansie No. 4 van 1946 vermeld is.

1. The Administration Account of the Territory of South West Africa is hereby charged with the sum of two hundred and forty thousand three hundred pounds; on Revenue Account and five hundred pounds on Loan Account to meet certain expenditure over and above the amounts appropriated for the service of the financial year ending on the 31st March, 1947, as specified in Ordinance No. 4 of 1946.

2. Die geld wat deur hierdie Ordonnansie beskikbaar gestel word, moet aangewend word vir die dienste in besonderhede vermeld in die Bylae tot hierdie Ordonnansie en omstandiger uiteengesit in die Begroting van Bykomende Uitgawes wat gedek moet word uit Inkomste- en Leningsfondse (S.W.A. 1—1947) soos deur die Wetgewende Vergadering goedgekeur.

3. Hierdie Ordonnansie heet die Addisionele Middele (1946—'47) Ordonnansie 1947.

2. The money appropriated by this Ordinance shall be applied to the services detailed in the schedule hereto and more particularly specified in the Estimates of the Additional Expenditure to be defrayed from Revenue and Loan Funds (S.W.A. 1—1947) as approved by the Legislative Assembly.

3. This Ordinance may be cited as the Additional Appropriation (1946—'47) Ordinance, 1947.
