Tot aanwending van 'n verdere geldbedrag vir die diens van die Gebied Suidwes-Afrika vir die jaar wat op die een-en-dertigste dag van Maart 1948 geeeindig het, tot bestryding en dekking van sekere ongemagtige uitgawes.

(Goedgekeur 6 Julie 1949.)

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN soos volg:—

1. Die Administrasierekening van die Gebied Suidwes-Afrika word hierby belas met die bedrag van eenhuisend-seshonderd-en-vyf pond, veertien sjellings en sewe pennies tot dekking van sekere uitgawes bo en behalwe die bedrag beskikbaar gestel vir die diens van die Gebied Suidwes-Afrika vir die jaar wat op die een-en-dertigste dag van Maart 1948 geeeindig het. Hierdie uitgawes word uiteengesit in die Bylae tot hierdie Ordonnansie en word nader omskryf in paragraaf 8, bladsy 10 van die Verslag (aan die Wetgewende Vergadering voorgelê) van die Kontroleur en Ouditeur-Generaal oor die rekenings vir vermelde boekjaar en in die Eerste Verslag van die Gekose Komitee oor Openbare Rekenings 1949.

ORDONNANSIE

Om die wet betreffende die registrasie van karakoelstambome te wysig.

(Goedgekeur 6 Julie 1949.)

Die Wetgewende Vergadering vir die Gebied Suidwes-Afrika VERORDEN soos volg:—

1. Die onderstaande nuwe artikel word hierby in die Ordonnansie van 1932 op die Registrasie van Karakoelstambome (Ordonnansie 11 van 1932) na artikel vyf ingevoeg:

Vrystelling van inkomstebelasting. (1) Die inkomste van die vereniging word van inkomstebelasting vrygestel.

(2) Hierdie artikel tree vir die eerste keer in werking ten opsigte van die aanslagjaar eindigende op die dertigste dag van Junie 1949."

2. Hierdie Ordonnansie heet die Wysigingsordonnansie op Registrasie van Karakoelstambome 1949.

ORDINANCE

To apply a further sum of money towards the service of the Territory of South West Africa for the year ended on the 31st day of March, 1948, for the purpose of meeting and covering certain unauthorised expenditure.

(Assented to 6th July, 1949.)
(Afrikaans text signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. The Administration Account of the Territory of South West Africa is hereby charged with the sum of one thousand six hundred and five pounds, fourteen shillings and seven pence to meet certain expenditure over and above the amount appropriated for the service of the Territory of South West Africa for the year which ended on the thirty-first day of March, 1948. Such expenditure is set forth in the Schedule to this Ordinance and is referred to in paragraph 8, page 10 of the Report (which has been presented to the Legislative Assembly) of the Controller and Auditor-General on the Accounts of the said year and in the First Report of the Select Committee on Public Accounts, 1949.

2. This Ordinance shall be called the Unauthorized Expenditure (1947—'48) Ordinance, 1949.

ORDINANCE

To amend the law relating to the Registration of Karakul Pedigrees.

(Assented to 6th July, 1949.)
(Afrikaans text signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:—

1. The following new section is hereby inserted in the Registration of Karakul Pedigrees Ordinance, 1932 (Ordinance No. 11 of 1932), after section five:

"Exemption 5 bis. (1) The income of the association shall be from income exempt from income tax."

(2) This section shall first take effect in respect of the year of assessment ending the thirtieth day of June, 1949."

2. This Ordinance shall be called the Karakul Pedigree Amendment Ordinance, 1949.
