Ek, ERIC HENDRIK LOUW, Minister van Ekonomiese Sake, handelende kragtens die bevoegdheid my verleent by Oorlogsmaatregel No. 146 van 1942, gelees met Oorlogsmaatregel No. 75 van 1945, wysig hierby verder Bylae B van Goewermentskennisgewing No. 431, gedateer 4 Maart 1949, op die manier soos hieronder aangedui.

I, ERIC HENDRIK LOUW, Minister of Economic Affairs, acting under and by virtue of the powers conferred upon me by War Measure No. 146 of 1942 read with War Measure No. 75 of 1945, do hereby further amend Schedule B to Government Notice No. 431, dated 4th of March, 1949, in the manner indicated hereunder.

This notice will come into effect on the 9th January, 1950, and will apply to all goods mentioned hereunder shipped on and after that date.

BYLAE B.

Deur die *weglatting* van die volgende item daarvan:—

Ex Tariffitem 70 (b) Kouse met 'n vry-aan-boord-koste van meer as 65s. per dosyn.

en die *vervanging* daarvan deur die volgende item:—

Ex Tariffitem 70 (b) Kouse met 'n vry-aan-boord-koste van meer as 72s. per dosyn.

Deur die *toevoeging* van die volgende items:—

Ex 61 (d) * Kafferlakenlinne met en vry-aan-boord-koste van meer as 4s. per vierkante jaart.

Ex 73 (1) (b) * Geborduurde stukgoedere waarvan die vry-aan-boord-prys-meer as 6s. 6d. per vierkante jaart is.

* Stukgoedere.

Opmerking.—In die geval van stukgoedere wat meer as 30 duim breed is, beteken "jaart" 36 duim by 30 duim en die vry-aan-boord-prys of -koste word bereken eweredig met die breedte.

Ex Tariff Item Stockings of a free on board cost exceeding 70 (b) 65s. per dozen.

and the *substitution* of the following item therefor:—

Ex Tariff Item Stockings of a free on board cost exceeding 70 (b) 72s. per dozen.

By the *addition* of the following items thereto:—

Ex 61 (d) * Kaffir sheeting of a free on board price exceeding 4s. per square yard.

Ex 73 (1) (b) * Embroidered piece goods the free on board price of which exceeds 6s. 6d. per square yard.

Note.—In the case of piece goods exceeding 30 inches in width, "yard" shall mean 36 inches by 30 inches in width, and the free on board price shall be calculated proportionately to the width.

OPMERKING.

Ten opsigte van items, gemerk *, is die beperkings alleen van toepassing wanneer die goedere ingevoer word kragtens 'n peruit waarin goedere as volg beskryf word: „Algemene koopware, uitsluitende goedere aangegee in bylaes A en B van Goewerments-kennisgewing No. 2380, gedateer 5 November 1948, soos gewysig en soos dit van tyd tot tyd gewysig mag word, en bekend as die ,Verbode Lys'.”

Note.—Piece goods containing 50 per cent. of cotton and 50 per cent. of rayon shall be deemed to be of rayon.

Note.—Woollen (woven or knitted) containing more than 50 per cent. by weight of wool or hair, or wool and hair mixed:

(i) Worsted of a free on board price exceeding 12s. 6d. per yard.

(ii) Other (excluding worsteds) of a free on board price exceeding 6s. 8d. per yard.

(Note.—"Worsteds are defined as yarns and fabrics made from fibres which have been carded or prepared, combed and spun on worsted machinery, and which contain wool in the stated proportion."

(c) (i) * Woven rayon piece goods containing 50 per cent. or more by weight of rayon, the free on board price of which exceeds 5s. 5d. per yard.

(c) (ii) * Woven silk piece goods containing more than 50 per cent. by weight of silk.

(c) (iv) * Other woven piece goods n.e.v. the free on board price of which exceeds 5s. 5d. per yard.

(d) (i) * Knitted rayon piece goods containing 50 per cent. or more by weight of rayon, the free on board price of which exceeds 5s. 5d. per yard.

(d) (ii) * Knitted silk piece goods containing more than 50 per cent. by weight of silk; other knitted piece goods, n.e.v. the free on board price of which exceeds 5s. 5d. per yard.

NOTE.

In respect of items marked * the restrictions apply only when the goods are imported under permits bearing the following description of the goods: "General merchandise excluding goods listed in Schedules A and B to Government Notice No. 2386 dated 5th November, 1948, as amended and as may be amended from time to time and known as the 'Prohibited List'."
