His Excellency the Governor-General has been pleased to approve, by virtue of the powers in him vested by section eighty-eight of the Prisons and Reformatories Act, No. 13 of 1911, of the cancellation of Prison Regulation No. 165 and the substitution thereof for the following new regulation:—

Regulasie No. 165.—Skrap in sy geheel en vervang deur die volgende:

„Ingevolge artikel ses (4), Wet No. 13 van 1911, kan 'n blanke ondergeskekte beampete wat ongehuwd was toe hy in diens geneem is, ontslaan word as hy sonder toestemming van die Direkteur trou.

Geen sodanige toestemming word verleent alvorens die applikant se aanstelling bekragtig is nie.

Die getroude personeel bestaan uit alle blanke gehuude beampies, en weduwes, wewenaars en geskeide beampies wat geheel en al verantwoordelik is vir die onderhou van hulle gesinne soos bepaal in Regulasie No. 168.

Beampies sal nie op die getalsterkte vir gehuude geplaas word nie, tensy hul vroue en gesinne binne die Unie woonagtig is. As die vrou en gesin van 'n beampie op die getalsterkte vir gehuude die Unie verlaat, dan eindig die toelae en voorrecht wat gewoonlik op sodanige beampie van toepassing is, na ses maande, behalwe in buitengewone omstandighede volgens oordeel van die Direkteur.”

Regulation No. 165.—Cancel the whole and substitute the following:

“In terms of section six (4), Act No. 13 of 1911, a European subordinate officer who was unmarried when enrolled shall be liable to dismissal if he marries without the consent of the Director.

No such consent shall be given until the applicant has been confirmed in his appointment.

The married strength shall consist of all European married officers, and widows, widowers and divorced officers who are solely responsible for the maintenance of their families as defined in Regulation No. 168.

Officers will not be placed on the married establishment unless their wives and families are resident in the Union. Should the wife and family of an officer on the married establishment leave the Union, the allowances and privilege ordinarily applicable to such an officer will not be continued for a longer period than six months, save in exceptional circumstances at the discretion of the Director.”

Kragtens Regulasie 3 van Oorlogsinnaatreel No. 49 van 1946, bepaal ek, Frederick Viljoen Ashpole, Pryskontroleur, hierby vir die hele Mandaatgebied Suidwes-Afrika en die Hawe en nedersetting Walvisbaai, as volg:—

(1) Onderworpe aan die bepaling van paragraaf (4) hiervan is die maksimum prys waarteen die landbougereedskap in die Bylae hiervan vermeld verkoop mag word deur —

- (a) 'n handelaar aan 'n ander handelaar, die prys daarvoor vermeld in kolom 1 van die Bylae;
- (b) 'n handelaar aan iemand anders as 'n handelaar die prys daarvoor vermeld in kolom 2 van die Bylae.

- (c) 'n handelaar wat die ploegskaar direk van die fabrikant daarvan bekom het aan iemand anders as 'n handelaar, die koste van die ploegskaar vir die handelaar plus 55 persent van sulke koste.

(3) Onderworpe aan die bepaling van paragraaf (4) hiervan is die maksimum prys waarteen enige onderdeel, vervaardig deur The South African Farm Implement Manufacturers, Limited, behalwe 'n ploegskaar waarna in paragraaf (2) hierboven verwys is, verkoop mag word deur —

- (a) 'n handelaar wat die onderdeel direk van die fabrikant daarvan bekom het aan enige ander handelaar, die koste van die onderdeel vir cergenoemde handelaar plus 44 persent van sulke koste;
- (b) 'n handelaar wat die onderdeel bekom het van 'n handelaar wat dit direk van die fabrikant daarvan bekom het aan iemand anders as 'n handelaar, die koste van die onderdeel vir cergenoemde handelaar plus 25 persent van sulke koste;
- (c) 'n handelaar wat die onderdeel direk van die fabrikant daarvan bekom het aan iemand anders as 'n handelaar, die koste van die onderdeel vir die handelaar plus 80 persent van sulke koste.

(4) Met dien verstande dat die prys soos vermeld in paragrafe (1), (2) en (3) hiervan verhoog mag word, met die spoorvrag vanaf Upington en/of padinotroldienskoste noodsaklik deur die handelaar aangegaan vir die vervoer van die gereedskap of onderdele van sy eie pakhuis of van die pakhuis van die distribuutier of groothandelaar van wie hy dit verkry het na die koper.

PRICE CONTROL.

MAXIMUM PRICES OF FARMING IMPLEMENTS AND SPARE PARTS MANUFACTURED BY THE SOUTH AFRICAN FARM IMPLEMENT MANUFACTURERS, LIMITED.

In terms of Regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby throughout the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

(1) subject to the provisions of Paragraph (4) hereof, fix the maximum price at which any of the farming implements specified in the Schedule hereto may be sold —

- (a) by a dealer to another dealer at a price specified therefor in Column 1 of such Schedule;
- (b) by a dealer to any person other than a dealer at the price specified therefor in Column 2 of such Schedule;

(2) subject to the provisions of Paragraph (4) hereof, fix the maximum price at which any plough share, manufactured by the South African Farm Implement Manufacturers, Limited, may be sold —

- (a) by a dealer who acquired such plough share direct from the manufacturer thereof to any other dealer at the cost of such plough share to such first-mentioned dealer plus 28 per cent. of such cost;
- (b) by a dealer who acquired such plough share from a dealer who acquired it direct from the manufacturer thereof to any person other than a dealer at the cost of such plough share to such first-mentioned dealer plus 21 per cent. of such cost;
- (c) by a dealer who acquired such plough share direct from the manufacturer thereof to a person other than a dealer at the cost of such plough share to such dealer plus 55 per cent. of such cost;

(3) subject to the provision of paragraph (4) hereof, fix the maximum price at which any spare part manufactured by the South African Farm Implement Manufacturers, Limited, other than a plough share referred to in Paragraph (2) above, may be sold —

- (a) by a dealer who acquired such spare part direct from the manufacturer thereof to any other dealer at the cost of such spare part to such first-mentioned dealer plus 44 per cent. of such cost;
- (b) by a dealer who acquired such spare part from a dealer who acquired it direct from the manufacturer thereof to any person other than a dealer at the cost of such spare part to such first-mentioned dealer plus 25 per cent. of such cost;
- (c) by a dealer who acquired such spare part direct from the manufacturer thereof to a person other than a dealer at the cost of such spare part to such dealer plus 80 per cent. of such cost;

(4) Direct that there may be added to the prices specified in Paragraph (1), (2) and (3) hereof any railage as from Upington and/or road motor service charges necessarily incurred by the dealer in transporting the implements or spare parts from his own warehouse or that of the distributor or wholesaler from whom he acquired them to the purchaser.

(5) Direct that for the purpose of this Notice “cost” means cost as determined in accordance with Government Notice No. 272 of 1st October 1949 (Determination of costs).

PRICE CONTROL.

MAXIMUM PRICES OF BICYCLE TYRES (COVERS) AND TUBES AND MAXIMUM CHARGES FOR THE FITTING OF TYRES AND TUBES TO BICYCLES.

In terms of Regulation 3 of War Measure No. 49 of 1949, I, Frederick Viljoen Ashpole, Price Controller, do hereby through the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:-

1. Fix the maximum prices at which the goods specified in the Schedule hereto may be sold by a dealer —

(a) to any other dealer the prices specified in column 1 of the said Schedule; and

(b) to any person other than a dealer the prices specified in Column 2 of the said Schedule.

2. Direct that the maximum prices specified in the said Schedule for any tyre (cover) or tube may be increased by the addition thereto of the cost necessarily expended by the seller in the transportation of such tyre (cover) or tube by road and/or rail from the place of business of the person from whom he acquired such tyre (cover) or such tube to his own place of business.

3. Fix the maximum charge that may be made by any person —

(a) for the service of fitting a tyre (cover) or tube or both to the front wheel of a bicycle at one shilling and three pence; and

(b) for the service of fitting a tyre (cover) or tube or both to the back wheel of a bicycle at two shillings.

4. Withdraw Government Notice No. 170 of 15th June, 1949. (Maximum Prices of Bicycle Tyres and Tubes and Maximum Charges for the fitting of Tyres and Tubes of Bicycles).
