PROCLAMATION

BY HIS HONOUR PETRUS IMKER HOOGENHOUT,
ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 15 of 1950.]

WHEREAS it is expedient to re-define the boundaries of the Magisterial districts of the Territory of South West Africa;

NOW THEREFORE, under and by virtue of the powers in me vested by section two of the Magistrates' Courts Proclamation, 1935 (Proclamation No. 31 of 1935), I do hereby proclaim, declare and make known as follows:—

- (1) The districts described in the First Schedule hereto are hereby created and the names of each district declared as indicated.
- (2) The local limits of each district shall be as defined in the First Schedule hereto.
- (3) Courts for each district are hereby established.
- (4) The name of the place within each district, appointed for the holding of the court and the place specified as the seat of each magistracy shall be as indicated in the First Schedule hereto.
- (5) The laws specified in the Second Schedule to this proclamation are hereby repealed.
- (6) This Proclamation shall be called the Redefinition of Magisterial Districts Proclamation, 1950.
