PROCLAMATIONS

BY HIS HONOUR PETRUS IMKER HOOGENHOUT,
ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 16 of 1950.]

WHEREAS it is desirable to suspend certain provisions of the Artesian Water Control Proclamation Amendment Ordinance, 1949;

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

1. From the taking effect of this Proclamation the provisions of the Artesian Water Control Proclamation Amendment Ordinance, 1949 (No. 7 of 1949) shall be suspended in as far as they relate to wells or boreholes on land which is within an artesian area and which is also situated within a municipality: Provided that no deep well as defined in the said Ordinance shall be sunk or excavated on such land except under authority of a licence the issue of which has been authorised by the Administrator in terms of the provisions of the Artesian Water Control Proclamation, 1921 (No. 49 of 1921).

2. Any person who sinks or excavates a deep well in contravention of section one of this Proclamation shall be guilty of an offence and shall be liable on conviction to the penalties prescribed in section thirteen of the Artesian Water Control Proclamation, 1921 (No. 49 of 1921).

3. This Proclamation shall be called the Artesian Water Control Suspension Proclamation, 1950.

WHEREAS it is desirable to confer certain powers upon the Commission appointed by the Administrator to enquire into and report upon the question of the rights and claims of owners of land within municipal areas to the use of water on such land, whether by means of wells or boreholes;

NOW THEREFORE, under and by virtue of the powers in me vested by section one of the Commissions' Powers Ordinance, 1927 (No. 6 of 1927) I do hereby proclaim, declare and make known as follows:—

NADEMAAL dit wenslik is om sekere bepalings van die Ordinasie ter Wysiging van die Artesiese Waterkontrole-Proklamasie 1949 op te skort;

SO IS DIT dat ek kragtens en ingevolge die bevoegdheid my verleen hierby proklameer, verklaar en bekendmaak:—

1. Vanaf die inwerkingtreding van hierdie Proklamasie word die bepalings van die Ordinasie ter Wysiging van die Artesiese Waterkontrole-Proklamasie 1949 (No. 7 van 1949) opgeskort namate hulle betrekking het op putte en boorgate op grond wat binne 'n artesiase gebied binne 'n munisipaliteit geleë is: Met dien verstande dat geen diep put soos omskryf in die gemelde Ordinasie op sodanige grond gegrawe of gedolwe mag word nie, buiten met die magtiging van 'n lisensie waarvan die Administrateur die uitreiking gelas het ingevolge die bepalings van die „Artesies Water Kontrole Proklamasie 1921" (No. 49 van 1921).

2. Elkeen wat 'n diep put strydig met die bepalings van artikel een van hierdie Proklamasie grawe of dolwe, is skuldig aan 'n oortreding, en is by skuldigbevinding onderhevig aan die strawwe wat voorgeskryf word by artikel dertien van die „Artesies Water Kontrole Proklamasie 1921" (No. 49 van 1921).

3. Hierdie Proklamasie heet die Opskortingsproklamasie insake die Beheer oor Artesiese Water 1950.

CIRCUIT COURTS.

(a) Under and by virtue of the powers conferred by sections two and three of the Further Administration of Justice Proclamation, 1920, the Administrator has divided the Territory of South West Africa into the following Circuit Districts:—

- (1) NORTHERN CIRCUIT DISTRICT, comprising the Magisterial Districts of Grootfontein, Kaokoveld, Karibib, Omaruru, Otjiwarongo, Outjo, Ovamboland and Swakopmund;
- (2) SOUTHERN CIRCUIT DISTRICT, comprising the Magisterial Districts of Bethanie, Gibeon, Keetmanshoop, Luderitz, Maltahöhe and Warmbad;
- (3) CENTRAL CIRCUIT DISTRICT, comprising the Magisterial Districts of Gobabis, Okahandja, Rehoboth and Windhoek.

and has directed that Circuit Courts shall be held in the towns and on the days and at the times set forth in the Schedule hereto, provided that in the event of the Judge being prevented by an unforeseen cause or delay from opening the Circuit Court at any of the said places on the day fixed for the purpose, such Circuit Court shall be opened on the day on which the Judge shall arrive at such place or as soon thereafter as conveniently may be.
