PROCLAMATION

BY HIS EXCELLENCY THE RIGHT HONOURABLE GIDEON BRAND VAN ZYL, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

No. 105 of 1950 (Union).]

REPORT OF THE COMMISSION APPOINTED TO DIVIDE SOUTH-WEST AFRICA INTO ELECTORAL DIVISIONS.

WHEREAS the Commissioners appointed under the provisions of sub-section (1) of section *twelve* of the South-West Africa Constitution Act, 1925, as substituted by section *seven* of the South-West Africa Affairs Amendment Act, 1949, have divided the Territory of South-West Africa into eighteen electoral divisions each electing one member to the Legislative Assembly of South-West Africa, and six electoral divisions each electing one member to the House of Assembly of Parliament, as provided by sub-section (2) of section *twelve* of the said Act;

AND WHEREAS such Commissioners have, as provided by sub-section (3) of section *twelve* of the said Act, submitted to the Governor-General a list of the electoral divisions into which they have divided the said Territory, together with the name given by them to, and a description of the boundaries of every such division;

AND WHEREAS by sub-section (6) of the section *twelve* of the said Act it is provided that the Governor-General shall publish in the *Gazette* and in the *Official Gazette* of the Territory of South-West Africa the names and the boundaries of the electoral divisions as finally settled;

NOW, THEREFORE, under and by virtue of the powers and authority vested in me as aforesaid, I do hereby declare that the names and boundaries of the several electoral divisions as finally settled and certified by the Commissioners aforesaid shall be those described in the Schedules to the Report annexed hereto.

NADEMAAL die Kommissarisse wat ingevolge die bepalings van subartikel (1) van artikel *twalf* van die „Zuid west-Afrika Konstitutie Wet, 1925“, soos vervang by artikel *seven* van die Wysigingswet op Aangeleenthede van Suidwes-Afrika, 1949, benoem is, die Gebied Suidwes-Afrika verdeel het in agtien kiesafdelings wat elkeen 'n lid van die Wetgewende Vergadering van Suidwes-Afrika kies, en in ses kiesafdelings wat elkeen 'n lid van die Volksraad van die Parlement kies, soos bepaal by subartikel (2) van artikel *twalf* van voormelde Wet;

EN NADEMAAL genoemde Kommissarisse, soos bepaal by subartikel (3) van artikel *twalf* van voormelde Wet, 'n lys van die kiesafdelings waarin hulle die voormelde Gebied verdeel het, en ook die naam wat hulle aan elke kiesafdeling gegee het en 'n beskrywing van die grense van elke kiesafdeling aan die Goewerneur-generaal voorgelê het;

EN NADEMAAL daar by subartikel (6) van artikel *twalf* van voormelde Wet bepaal word dat die Goewerneur-generaal die name en die grense van die kiesafdelings soos final vasgestel, in die *Staatskoerant* en in die *Offisiële Koerant* van die Gebied Suidwes-Afrika moet bekendmaak;

SO IS DIT dat ek, kragtens die bevoegdheid my verleen van voormelde Wet bepaal dat die name en grense van die verskillende kiesafdelings, soos final deur voornoemde Kommissarisse vasgestel en gesertifiseer, dié is wat beskryf word in die Aanhangsels van die Verslag wat hierby aangeheg is.

REPORT

TO HIS EXCELLENCY THE RIGHT HONOURABLE GIDEON BRAND VAN ZYL, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

May it please your Excellency:

1. In August, 1949, Your Excellency issued a commission to the undersigned, appointing them in terms of sub-section (1) of section twelve of the South-West Africa Constitution Act, 1925 (No. 42 of 1925), as amended by the South-West Africa Constitution Act, 1925, Further Amendment Act, 1931 (No. 38 of 1931), as substituted by the South-West Africa Affairs Amendment Act, 1949 (No. 23 of 1949), for the purpose of dividing the South-West Africa Territory into electoral divisions for the election of members of the Legislative Assembly of the Territory and members of Parliament.

2. The members of the Commission assembled in Windhoek on the 17th October, 1949, and on the 24th October, 1949, after due notice, held a meeting at which the representatives of the two political parties of the Territory and other interested members of the public were given the opportunity to submit schemes for the delimitation of the whole Territory or any portion thereof or to make suggestions calculated to be of assistance to the commission in pursuance of the mandate entrusted to it.

3. Your commission adopted the practice of earlier Delimitation Commissions of holding meetings at various centres and in order, as far as was practicable, to acquaint itself with the effect of certain alterations of existing electoral boundaries suggested by the political parties and others, held meetings at the following places:

Grootfontein on 2nd November, 1949,
Otjiwarongo on 15th November, 1949,
Outjo on 15th November, 1949,
Swakopmund on 18th November, 1949,
Lüderitzbucht on 21st November, 1949,
Keetmanshoop on 22nd November, 1949,
Mariental on 22nd November, 1949, and
Gobabis on 24th November, 1949.

There was little interest shown at any of these places but at each some persons attended and expressed their views as to the delimitation of their own electoral division. These views differed little, if at all, from the views already expressed by the representatives of the political parties at Windhoek.

4. On 10th June, 1949, the registration of all persons in the Territory entitled to vote was begun. This work was completed towards the end of September last and the list so compiled constituted the voters' list, upon which the Commission has based its delimitation, the number of registered voters being fixed at 20,508.

5. By section 12 of the Act, the Commission is directed to divide the Territory into eighteen electoral divisions, each electing one member to the Assembly, and into six electoral divisions (consisting in each case of three of the aforesaid electoral divisions), each electing one member of the House of Assembly of Parliament, and is further directed to divide the Territory in such a manner that there will be as far as possible an equal number of voters in each such division, such number constituting the 'quota' for each division, but allowing a margin not exceeding 15% more or 15% less than the quota.

6. As there are 20,508 registered voters to be allocated to eighteen electoral divisions, the 'quota' (ignoring fractions) for each division becomes 1,139 voters. Allowing for a 15% margin, the maximum number of voters permitted in any one Constituency is 1,309 and the minimum number 969. As in terms of the Act, each constituency for the Union Parliament must consist of three electoral divisions for the Legislative Assembly, the quota for the former constituencies is 3,418, the permissible maximum being 3,930 voters, and the minimum being 2,906 voters.

7. As the existing electoral divisions numbered twelve the duty of creating six additional divisions devolved upon the Commission and boundaries of existing divisions had perforce to be disturbed but insofar as was practicable former names were retained. Where a new division was created an appropriate name for it was derived from the name of one or other relatively important centre included in such division.

The new electoral divisions so created are named: Rehoboth, Aroab, Maltahöhe, Mariental, Usakos, Outjo, Otjikondo, Windhoek North, Windhoek East and Windhoek West, the existing electoral divisions of Gibeon, Stampriet, Windhoek Central and Windhoek District being absorbed into or divided between the proposed new divisions.

VERSLAG

AAN SY EKSELLENSIE DIE HOOGDELAGBARE GIDEON BRAND VAN ZYL, LID VAN DIE MEES EERVOLLE GEHEIME RAAD VAN SY MAJESTEIT, DOKTOR IN DIE REGTE, GOEWERNEUR-GENERAAL VAN DIE UNIE VAN SUID-AFRIKA.

Mag dit u Eksellensie behaag:

1. U Eksellensie het in Augustus 1949 die ondergetekendes 'n opdrag gegee, en hulle in gevolge subartikel (1) van artikel twaalf van die „Zuidwest-Afrika Konstitusie Wet, 1925 (No. 42 van 1925)“, soos gewysig by die „Zuidwest-Afrika Konstitusie Wet, 1925, Verdere Wysigingswet, 1931 (No. 38 van 1931)“, soos vervang deur die Wysigingswet op Aangeleenthede van Suidwes-Afrika, 1949 (No. 23 van 1949), benoem om die gebied Suidwes-Afrika in kiesafdelings vir die verkiesing van lede van die Wetgewende Vergadering van die Gebied en lede van die Parlement te verdeel.

2. Die lede van die Kommissie het op 17 Oktober 1949 in Windhoek byeengekóm, en op 24 Oktober 1949, na behoorlike kennisgewing, 'n vergadering gehou waarop die verteenwoordigers van die twee politieke partye in die gebied en ander belanghebbende lede van die publiek die geleentheid gegee is om skemas vir die afbakening van die hele Gebied, of 'n deel daarvan, voor te lê of om voorstelle te doen wat die Kommissie kan help in die uitvoering van die opdrag hom gegee.

3. U Kommissie het die beleid van vorige Afbakeningskommissies gevolg, nl. om byeenkomste in verskillende sentrums te hou, en het, ten einde hom so ver doenlik op hoogte te stel van die uitwerking van sekere veranderinge in bestaande kiesgrense wat deur die politieke partye en ander persone voorgestel is, vergaderings op onderstaande plekke gehou:

Grootfontein, op 2 November 1949,
Otjiwarongo, op 15 November 1949,
Outjo, op 15 November 1949,
Swakopmund, op 18 November 1949,
Lüderitzbucht, op 21 November 1949,
Keetmanshoop, op 22 November 1949,
Mariental, op 22 November 1949,
Gobabis, op 24 November 1949.

Geringe belangstelling is op hierdie plekke getoon, maar op elkeen het 'n paar persone opgedag wat hul sieniswees oor die afbakening van hul eie kiesafdeling uitgespreek het. Hierdie sieniswees het min, indien enigermin, van die sieniswees wat alreeds deur die verteenwoordigers van die politieke partye te Windhoek uitgespreek is, verskil.

4. Die registrasie van alle stemgeregtigdes in die Gebied het op 10 Junie 1949 'n aanvang geneem. Hierdie werk is teen die end van September 1949 voltooi, en die lys wat aldus opgestel is, het die kieserslys uitgemaak waarop die Kommissie sy afbakening gegrond het. Die getal geregistreerde kiesers is op 20,508 vasgestel.

5. Dit word by artikel 12 van die Wet aan die Kommissie opgedra om die Gebied te verdeel in agtien kiesafdelings wat elk een lid van die Wetgewende Vergadering kies, en in ses kiesafdelings (bestaande in elke geval uit drie van die eersgenoemde kiesafdelings), wat elk een lid van die Volksraad van die Parlement kies. Ook word die Kommissie opgedra om die Gebied op so 'n wyse te verdeel dat daar sover moontlik 'n gelyke getal kiesers, wat die kwota vir elke kiesafdeling uitmaak, in elke kiesafdeling sal wees, met dien verstande egter dat 'n speling van 15% bokant of 15% onderkant die kwota toegelaat word.

6. Met 20,508 geregistreerde kiesers om aan agtien kiesafdelings toegewys te word, is die kwota per kiesafdeling 1,139 kiesers (uitsluitende breuke). As rekening gehou word met die speling van 15%, is die maksimum getal kiesers in 'n kiesafdeling 1,309 en die minimum getal 969. Aangesien kragtens die Wet elke kiesafdeling van die Unie-parlement uit drie kiesafdelings van die Wetgewende Vergadering moet bestaan, kom die kwota vir eersgenoemde kiesafdelings op 3,418 te staan, terwyl die toelaatbare maksimum 3,930 kiesers en die minimum 2,906 kiesers is.

7. Daar die bestaande kiesafdelings twaalf tel, het dit die plig van die Kommissie geword om ses bykomstige kiesafdelings te skep en die grense van bestaande kiesafdelings moes noodwendig versit word. Virsover dit doenlik was, is die vorige name egter behou. Waar 'n nuwe kiesafdeling geskep is, is 'n passende naam daarvoor gevind deur dit na een of ander betreklik belangrike sentrum wat in sodanige kiesafdeling val, te vernoem.

Die nuwe kiesafdelings wat so gestig is, heet, Rehoboth, Aroab, Maltahöhe, Mariental, Usakos, Outjo, Otjikondo, Windhoek-Noord, Windhoek-Oos en Windhoek-Wes, terwyl die bestaande kiesafdelings Gibeon, Stampriet, Windhoek-Sentraal en Windhoek-Distrik in die voorgestelde nuwe kiesafdelings opgeneem of daaronder verdeel is.

8. According to the evidence placed before us it appears that the Territory's main activity consists in farming. Apart from the development of the diamond deposits at and around Orange Mouth and Lüderitzbucht, the mining for copper and lead at Tsumeb in the North, some very restricted undertakings for the mining of tin and gold, and some factories for the freezing and canning of fish at Walvis Bay and Lüderitzbucht, the predominant industry is farming which naturally falls into two types, each type being dictated by climatic and other conditions and predominant in its own particular area.

The southern part of the Territory, i.e. the part stretching from the Orange River in the South to the line across the Territory from West to East along the boundary of Rehoboth forms an area in which sheep farming, namely Karakul farming, is the main occupation of the inhabitants. In the north, that is the area extending from north of the town of Okahandja to the Etosha Pan, the main occupation is cattle farming, while the centre portion, excluding the town of Windhoek, seems to combine the two occupations of sheep farming and cattle farming. Community of interest, therefore, excluding the only large town in the Territory and the localized diamond and copper and lead and fishing industries, creates no real problem since farming constitutes the predominant interest of the inhabitants.

9. This similarity or community of interest has the result that the considerations which the Act requires the Commission to regard, are narrowed down to physical features, density of population and means of communication. In one or two suggested electoral divisions, particularly those for the Union Parliament, means of communication may be said to constitute a difficulty, but on the whole there is a network of roads and railways connecting the Northern part of the Territory to the Southern part and to a more limited extent the Eastern part and the Western.

10. The nature of the farming activities determines the density of the population: thus the southern area, consisting predominantly of sheep farms, is less densely populated than the central and northern areas, and due account requires to be taken of this feature when the problem of loading or unloading a particular division is raised.

11. The Commission has adopted the principle of an equal number of voters for each electoral division, but has given effect to the greater density of population in the northern and central areas by loading those areas, where necessary, and unloading the southern area. Some problem is raised by the existence of small urban areas within the predominantly farming areas, but as these areas may well be described as farming towns the Commission has not made the existence of such areas a factor of importance in determining the extent of the loading or unloading.

12. In the performance of its difficult task, the Commission has had the benefit of the very full and efficient addresses, supported by maps, of the representatives of the two political parties of the Territory. The maps and the reasons so given in elucidation of the respective suggested schemes have been of great assistance and have been much appreciated by the Commission.

Each representative stated that his organization, in drawing up their suggested delimitation, had borne in mind the existing polling districts, but obviously that principle could not be adopted throughout, as the existing twelve electoral divisions had to be divided into eighteen divisions and the disturbance of some existing polling districts became inevitable. The scheme of the Verenigde Party involved splitting eight existing polling districts, while that of the National Party involved the splitting up of thirteen or fourteen such districts.

The Commission has adopted a similar principle and has striven as far as possible the existing polling districts, but has not hesitated to disregard existing polling districts where it found it necessary to do so in order to arrive at a proper delimitation.

13. As the population in the south had not altered to the same extent as in the central and northern sections since the last delimitation of the Territory in 1931, it appeared convenient to postpone consideration of the predominantly urban areas, viz: Windhoek, Keetmanshoop, Swakopmund, Walvis Bay, Lüderitzbucht, Usakos and Orange Mouth, until the Commission had determined suitable divisions for the South, in respect of which latter area the Commission consequently commenced its deliberations.

There was a considerable measure of agreement between the political parties in respect of the area of the proposed southernmost division, namely Warmbad, as well as in respect of the proposed electoral divisions of Otjiwarongo and Gobabis. In the opinion of the Commission, however, certain

8. Uit die getuienis wat aan ons voorgelê is, blyk dit dat boerdery die Gebied se vernameste bedryf is. Afgesien van die bewerking van die diamanthoudende grond om en by Oranjermond en Lüderitzbucht; die ontginning van koper en lood te Tsumeb in die Noorde; 'n paar heperkte onderneemings in verband met die ontginning van tin en goud, en 'n paar fabriek vir die bevestiging en insaak van vis te Walvisbaai en Lüderitzbucht, is boerdery die oorheersende bedryf, wat natuurlik wissel in twee klasse val, na gelang die klimaat- en ander omstandighede verskil, en elkeen is oorgewig in sy eie bepaalde gebied.

Die suidelike deel van die Gebied, d.w.s. die deel wat strek van die Oranjerivier in die suide tot by die lyn wat van west na oos langs die grens van Rehoboth loop, maak 'n strek uit waarin skaapboerdery, n.l. die deel van karakoolskape, die vernameste bedryf van die inwoners is. In die noorde, d.w.s. die gebied wat noord van die dorp Okahandja tot by die Etoshapan strek, is beesboerdery die vernameste bedryf, terwyl in die middegeboelte, met uitsondering van die dorp Windhoek, die twee bedrywe (skaapboerdery en beesboerdery) blykbaar gesamentlik uitgeoefen word. Gemeenskaplike belang lewer dus geen werklike vraagstuk op nie, as die enigste groot dorp in die Gebied en die gelokaliseerde diaman- en koper- en lood- en visnywerheids buite rekening gelaat word, aangesien boerdery die oorheersende belang van die inwoners uitmaak.

9. Hierdie ooreenstemming of gemeenskaplikheid van belang is oorsaak dat die sake wat die Kommissie kragtens Wet in ag moet neem, beperk word tot natuurlike kenmerke, digtheid van bevolking en verkeersmiddele. In een of twee voorgestelde kiesafdelings, in die besonder dié van die Unieparlement, kan dit beweer word dat verkeersmiddele 'n vraagstuk skep, maar oor die algemeen is daar 'n netwerk van paaie en spoorweë wat die noordelike deel van die Gebied met die suidelike, en in mindere mate, die oostelike en die westelike deel verbind.

10. Die aard van die boerderybedryf bepaal die digtheid van die bevolking: die suidelike strek, bestaande in hoofsaak uit skaapplase, is minder digbevolk as die sentrale en die noordelike gebied, en hiermee moet behoorlik rekening gehou word wanneer die vraag van die belading of ontlading van 'n besondere kiesafdeling behandel word.

11. Die Kommissie het die beginsel van 'n gelyke getal kiesers vir elke kiesafdeling aanvaar, maar dit het die groter digtheid van bevolking in die noordelike en sentrale gebied laat batesaansê deur hierdie gebiede waar nodig te belaa en die suidelike gebiede te ontlaai. 'n Mate van moeilikheid word geskep deurdat daar klein dorpsgebiede lê tussen die gebiede waarin die boerdery oorewegend uitgeoefen word, maar aangesien hierdie dorpsgebiede as boeredorpe beskryf kan word, het die Kommissie die bestaan van sulke gebiede nie as 'n faktor van belang beskou by die bepaling van die mate van belading of ontlading nie.

12. By die uitvoering van sy moeilike taak het die Kommissie die voordeel geniet van die volledige en doeltreffende referate, gesteun deur landkaarte, wat deur die verteenwoordigers van die twee politieke partye van die Gebied gelewer is. Die landkaarte en die redes wat ter toelieg van die onderskeie skemas aangevoer is, was 'n groot hulp en is deur die Kommissie hoog op prys gestel.

Elke verteenwoordiger het vermeld dat sy organisasie by die opstel van hul voorgestelde afbakening die bestaande stembestrikke inageneem het; klaarblyklik kon dié beginsel nie oral gevolg word nie, daar die bestaande twaalf kiesafdelings in agtien verdeel moes word, en die verskuiwings van 'n aantal bestaande stembestrikke het onvermydelik geword. Die skema van die Verenigde Party het die oorbek van agt bestaande stembestrikke moegering, terwyl dié van die Nasionale Party die oorbek van dertien of veertien sulke distrikte sou veroorsaak.

Die Kommissie het 'n soortgelyke beginsel gevolg en by het so ver moontlik die bestaande stembestrikke behou, maar het nie geaarsoek om bestaande stembestrikke te verontagsaam waar hy dit nodig bevind het om sulke te doen ten einde 'n behoorlike afbakening te bewerkstellig nie.

13. Aangesien die bevolking in die suide nie in dieselfde mate verander het as in die sentrale en noordelike dele sedert die jongste afbakening van die Gebied in 1931, het dit wenslik geblyk om ooreweging van die oorewegend stedelike gebiede, soos Windhoek, Keetmanshoop, Swakopmund, Walvisbaai, Lüderitzbucht, Usakos en Oranjermond uit te stel totdat die Kommissie geskikte afdelings vir die suide vasgestel het; gevolglik het die Kommissie laasgenoemde gebied eerste in oënskyn geneem.

Daar was 'n ruime mate van ooreenkomst tussen die politieke partye ten opsigte van die gebied van die voorgestelde mees suidelike afdeling, n.l. Warmbad, sowel as in die voorgestelde kiesafdelings Otjiwarongo en Gobabis. Na die Kommissie se mening was dit egter nodig om geringe wy-

minor adjustments to both the proposed divisions had to be made. These adjustments are indicated in the detailed description of the respective divisions as set forth in the second Schedule hereto.

14. Difficulty arose from the fact that none of the coastal towns on the west coast contains sufficient voters to constitute independent electoral divisions, even by grouping two together, while the combined number of voters in these coastal towns far exceeded the required quota. Grouping of these towns was therefore unavoidable and it was necessary to add rural areas in order to arrive at or near the quota. Consequently, the settlements of Lüderitzbucht and Orange Mouth were grouped together as Jikewise were the urban areas of Swakopmund and Walvis Bay. In order to arrive at a satisfactory figure, large portions of the polling districts of Aus (No. 32) and Konkpie (No. 49) were added to Lüderitzbucht and Orange Mouth, and polling district No. 23 (Nauchas) and the western portion of polling district No. 21 (Windhoek District) were added to Swakopmund and Walvis Bay.

15. Considerable difficulty was also experienced in the case of the constituency of Usakos. Practically the whole voting strength of the existing polling district is concentrated in the town itself where 639 out of 775 voters are registered but as it does not in itself contain sufficient voters to form a separate electoral division, it was found necessary, in order to obtain the requisite number of voters, to add the polling district of Karibib (No. 15), part of polling district No. 16 (Okahandja) and part of polling district No. 21 (Windhoek District).

16. The northern areas were also a source of considerable difficulty. It was common cause that Grootfontein and Tsumeb could not be separated into different divisions. The combined voters of Grootfontein (polling district No. 3) and Tsumeb (polling district No. 2) exceeded the quota, so portions of the polling district of Tsumeb (No. 2) had to be added to the proposed electoral division of Outjo. The latter division, consisting of the polling districts of Otavifontein (No. 5), Kombat (No. 4), Outjo (No. 7) and part of Tsumeb, also exceeded the quota, so it was found necessary to excise portion of polling district No. 7 (Outjo) and add the latter to the proposed division of Otjikondo. To arrive at a satisfactory figure for the Otjikondo division, it was necessary to add the polling district of Omatjette (No. 9) and part of Omaruru (polling district No. 12).

17. In the central area, it was found necessary to split up the polling district of Steinhäusen (No. 17), allocating portion to the proposed electoral division of Gobabis and portion to the proposed division of Okahandja. The remaining central area comprises the proposed division of Okahandja.

18. It was common cause that the municipal area of Windhoek should constitute three electoral divisions. The commission has attempted to divide that area, so as to give each constituency as nearly as possible the same number of votes, without splitting up the blocks indicated in the plan, but this was found to be impossible. Consequently, the proposed divisions do not have an equal number of voters, but this result is not unsatisfactory, for the division which has the lowest number of voters incidentally includes the township of Klein Windhoek, in which considerable gardening and agricultural work is practised. Different schemes were proposed by the political parties, and by the members of the Commission, but after consideration, the Commission has decided to recommend the scheme as described in the First Schedule and the map attached thereto.

19. The proposed electoral divisions (other than Windhoek) with the boundaries as determined by the Commission, as well as the names, the number of voters and percentage of loading or unloading in each division appear from the Second Schedule and the map annexed thereto.

20. *Electoral Divisions of Parliament.* The commission is directed by the Act to group three electoral divisions for the Legislative Assembly together to form one electoral division for the Union Parliament. Windhoek Town, consisting of three electoral divisions, obviously forms one electoral division for the Union Parliament.

The further suggested electoral divisions for the Union Parliament, with the local electoral divisions constituting each electoral division, are enumerated in the Third Schedule hereto.

It was suggested by the representative of the National Party — a suggestion which the Commission finds to be reasonable — that, if possible, the names of the electoral divisions for the Union Parliament should not be the same as those for the Legislative Assembly, since confusion might very well arise if the election for the two different Parliaments

14. Moëlikheid het ontstaan weens die feit dat geen een van die dorpe aan die westkus genoeg kiesers bevat om op sigself kiesafdelings uit te maak, selfs deur twee dorpe saam te groepeer, terwyl die gekombineerde getal kiesers in hierdie kusdorpe die kwota verveg oorskry het. Die groepering van hierdie dorpe was derhalwe onvermydelik en dit was nodig om landelike gebiede by te voeg teen einde by of naby die kwota te kom. Gevolglik is die nedersettings Lüderitzbucht en Oranjenmond gegroepeer, soos ook gedoen is met die stadsgebiede Swakopmund en Walvisbaai. Ten einde 'n bevredigende getal te bereik, is groot gedeeltes van die stemdistrikte Aus (No. 32) en Konkpie (No. 49) by Lüderitzbucht en Oranjenmond gevoeg; en stemdistrik No. 23 (Nauchas) en die westelike gedeelte van stemdistrik 21 (Windhoek-distrik) is by Swakopmund en Walvisbaai gevoeg.

15. Groot moëlikheid is ook ondervind in die geval van die kiesafdeling Usakos. Die hele stemkring van die bestaende stemdistrik is feitlik in die dorp self saamgetrek, waar 639 uit 775 kiesers geregistreer is, maar aangesien dit in sigself nie genoeg kiesers bevat om 'n afsonderlike kiesafdeling uit te maak nie, is dit nodig bevind, ten einde die vereiste getal kiesers te bereik, om die stemdistrik Karibib (No. 15), gedeelte van stemdistrik No. 16 (Okahandja) en gedeelte van stemdistrik No. 21 (Windhoek-distrik) by te voeg.

16. Die noordelike gebiede was ook 'n bron van heelwat moëlikheid. Dit was gemene saak dat Grootfontein en Tsumeb nie in afsonderlike kiesafdelings geplaas kon word nie. Die gesamentlike kiesers van Grootfontein (stemdistrik No. 3) en Tsumeb (stemdistrik No. 2) het die kwota oorskry; derhalwe moes gedeeltes van die stemdistrik Tsumeb (No. 2) by die voorgestelde kiesafdeling Outjo gevoeg word. Laasgenoemde kiesafdeling, bestaende uit die stemdistrikte Otavifontein (No. 5), Kombat (No. 4), Outjo (No. 7), en gedeelte van Tsumeb, het ook die kwota oorskry; daarom is dit nodig bevind om gedeelte van stemdistrik No. 7 (Outjo) weg te sny en aan die voorgestelde kiesafdeling Otjikondo toe te voeg. Om tot 'n bevredigende getal kiesers vir die Otjikondodivisie te geraak, was dit nodig om die stemdistrik Omatjette (No. 9) en gedeelte van Omaruru (stemdistrik No. 12) daaraan toe te voeg.

17. In die sentrale gebied is dit nodig bevind om die stemdistrik Steinhäusen (No. 17) op te breek, en 'n gedeelte daarvan aan die voorgestelde kiesafdeling Gobabis en 'n gedeelte aan die voorgestelde kiesafdeling Okahandja toe te voeg. Die res van die sentrale streek omvat die voorgestelde kiesafdeling Okahandja.

18. Dit was gemene saak dat die dorpsgebied Windhoek drie kiesafdelings moes uitmaak. Die Kommissie het genoemde gebied op so 'n wyse probeer indeel dat elke kiesafdeling so na moontlik oor dieselfde getal stemme sou beskik, sonder om die blokke wat op die landkaart aangedui word op te breek. Dit is egter nie moontlik bevind om dit te doen nie. Gevolglik het die voorgestelde kiesafdelings nie 'n gelyke getal kiesers nie, dog hierdie onstandigheid is nie onbevredigend nie, want die afdeling wat die kleinste getal kiesers het, sluit toevallig die dorp Klein Windhoek in, waarin daar aansienlik tuin- en landbouwerk gedoen word. Verskillende skemas is deur die politieke partye en lede van die Kommissie voorgestel, maar na oorweging van die saak het die Kommissie besluit om die skema wat in die Eerste Blylê en die landkaart daarby aangeheg, beskryf word, aan te beveel.

19. Die voorgestelde kiesafdelings (met uitsondering van Windhoek) en die grense soos deur die Kommissie vasgestel, en ook die name, die getal kiesers en die persentasie van belading of ontleding in elke afdeling, word in die Tweede Blylê en die landkaart daarby aangeheg, aangedui.

20. *Kiesafdelings van die Parlement.* Die Kommissie word kragtens die Wet opgedra om drie kiesafdelings van die Wetgewende Vergadering saam te groepeer om een kiesafdeling vir die Unie-parlement uit te maak. Die dorp Windhoek, bestaende uit drie kiesafdelings, maak klaarblyklik een kiesafdeling vir die Unie-parlement uit.

Die ander voorgestelde kiesafdelings vir die Unie-parlement, met die plaaslike kiesafdelings wat elkeen uitmaak, word in die Derde Blylê hiervan genoem.

Dit is deur die verteenwoordiger van die Nasionale Party aan die hand geloen — 'n aanbeveling wat die Kommissie redelik vind — dat die name van die kiesafdelings vir die Unie-parlement, indien moontlik, nie dieselfde moet wees as dié van die Wetgewende Vergadering nie, aangesien verwarring maklik kan ontstaan indien die verkiesing vir die

ments were held on the same day. The Commission has accepted this principle and the names of the electoral divisions are given in the Third Schedule hereto, together with the electoral divisions for the Legislative Assembly constituting each such electoral division for Parliament.

21. In conclusion the members of the Commission wish to place on record their appreciation of the assistance and facilities supplied by the Administration of the Territory as well as the assistance given by the Surveyor-General of the Territory. Furthermore, the labours of the Commission were much lightened by the Honourable the Minister of the Interior placing a military plane at the disposal of the Commission, thus enabling the Commission to visit various centres in the minimum of time and the maximum of comfort.
