VAN SY EKSELLENSIE DIE HOOGEDELE ERNEST FREDERICK WATERMEYER, LID VAN DIE MEES EERVOLLE GEHEIME RAAD VAN SY MAJESTEIT, AMPTENAAR BELAS MET DIE UITOEFENING VAN DIE UITVOERENDE GESAG VAN DIE UNIE VAN SUID-AFRIKA.

BY HIS EXCELLENCY THE RIGHT HONOURABLE ERNEST FREDERICK WATERMEYER, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, OFFICER ADMINISTERING THE GOVERNMENT OF THE UNION OF SOUTH AFRICA.

VERKIESING VAN VOLKSRAADSEDE OM SUIDWES-AFRIKA TE VERTEENWOORDIG.

ELECTION OF MEMBERS OF THE HOUSE OF ASSEMBLY TO REPRESENT SOUTH-WEST AFRICA.

NADEMAAL subartikel (2) van artikel vyf-en-dertig van die Wysigingswet op Aangeleenthede van Suidwes-Afrika 1949 (Wet No. 23 van 1949) bepaal dat die Gouveneur-generaal kragtens artikel vyf-en-dertig van die Wet tot Konsolidasie van die Kieswette, 1946, moet handel ten einde die verkiesing uit te voer van Volksraadslede wat ingevolge nagingting van eers-genoemde Wet verkies kan word om die gebied Suidwes-Afrika in die Volksraad van die Parlement te verteenwoordig;

WHEREAS by sub-section (2) of section thirty-five of the South-West Africa Affairs Amendment Act, 1949 (Act No. 23 of 1949), it is provided that the Governor-General shall act under section thirty-five of the Electoral Consolidation Act, 1946, for the purpose of carrying out the election of members of the House of Assembly authorized to be elected to represent the Territory of South-West Africa in the House of Assembly of Parliament in terms of the first-mentioned Act;

SO IS DIT dat ek, kragtens die bevoegdheid my verleë 1900s voorneld, hierby as volg verklaar:—

NOW, THEREFORE, under the powers vested in me as aforesaid, I do hereby declare as follows:—

- (1) Dat Maandag, die vier-en-twintigste dag van Julie 1950, vasgestel is as die dag waarop nominasiesitting sal hou om nominasies te ontvang van kandidate vir verkiesing as volksraadslede vir die verskillende kiesafdelings waarin die gebied Suidwes-Afrika verdeel is;
- (2) dat die plekke beskryf in die tweede kolom van bygaande Bylae onderskeidelik die plekke is waar voornelde nominasiesitting moet hou ten opsigte van sodanige kiesafdelings;
- (3) dat genoemde nominasiesitting moet hou om senuur in die voormiddag van voornelde dag;
- (4) dat ingeval 'n stemming nodig word in enige van voornelde kiesafdelings deurdat meer as een persoon wettig genomineer is by die sluiting van die sitting van voornelde nominasiesitting, bedoelde stemming moet plaasvind op Woensdag, die dertigste dag van Augustus 1950, en moet begin om senuur in die voormiddag en sluit om agtuur in die aand van gemelde dag; en

- (1) That Monday the twenty-fourth day of July, 1950, shall be the day on which nomination courts will sit to receive nominations of candidates for election as members of the House of Assembly for the several electoral divisions into which the Territory of South-West Africa has been divided;
- (2) that the places described in the second column of the Schedule annexed hereto shall be respectively the places at which the nomination courts shall sit for such electoral divisions;
- (3) that the said nomination courts shall sit at 10 o'clock in the forenoon of the aforesaid day;
- (4) that if a poll becomes necessary in any of the electoral divisions aforesaid, for the reason that more than one person shall have been duly nominated at the close of the sitting of the said nomination courts, the poll shall be taken on Wednesday, the thirtieth day of August, 1950, and shall commence at 7 o'clock in the forenoon and close at 8 o'clock in the evening of the said day; and

- (5) dat elke persoon wat in die derde kolom van bygaande Bylae genoem word, die kiesbeampte is, en hierby as sulks bevestig word, by die verkiesing in die kiesafdeling waarvan die naam verskyn in die eerste kolom van genoemde Bylae teenoor die naam van elke sodanige persoon.

NADEMAAL die Wetgewende Vergadering van die Gebied Suidwes-Afrika by Proklamasie No. 137 van 1950 (Unie) deur Sy Eksellensie die Amptenaar belas met die Uitoeffening van die Uitvoerende Gesag ingevolge sub-artikel (1) van artikel *zyf-en-dertig* van die Wysigingswet op Aangeleenthede van Suidwes-Afrika 1949 (Wet 23 van 1949) ontbind is;

EN NADEMAAL dit wenslik is om oor te gaan tot die verkiesing van lede van die genoemde Wetgewende Vergadering;

SO IS DIT dat ek, kragtens en ingevolge die mag en bevoegdheid my verleen by artikels *vier-en-dertig* en *vyf-en-dertig* van die Wet tot Konsolidasie van die Kieswette 1946 (Wet 46 van 1946) soos gewysig en op hierdie Gebied toegepas by artikel *vier-en-dertig* van die Wysigingswet op Aangeleenthede van Suidwes-Afrika 1949 (Wet 23 van 1949) hierby verklaar:—

PROCLAMATION

WHEREAS the Legislative Assembly of South West Africa has been dissolved by Proclamation No. 137 of 1950 (Union) issued by His Excellency the Officer Administering the Government in terms of sub-section (1) of section *thirty-five* of the South West Africa Affairs Amendment Act, 1949 (Act 23 of 1949);

AND WHEREAS it is expedient to proceed to the election of members of the said Legislative Assembly;

NOW THEREFORE, under and by virtue of the powers and authority vested in me by sections *thirty-four* and *thirty-five* of the Electoral Consolidation Act, 1946 (Act 46 of 1946), as amended, and applied to this Territory by section *thirty-four* of the South West Africa Affairs Amendment Act, 1949 (Act 23 of 1949), I do hereby declare as follows:—

- (1) Dat Maandag die vier-en-twintigste dag van Julie 1950 die dag is waarop 'n nominasiehof in elke kiesafdeling sitting sal hou om benoemings van kandidate te ontvang vir die verkiesing van lede van die Wetgewende Vergadering van Suidwes-Afrika vir die verskillende kiesafdelings waarin die Gebied by Proklamasie 105 van 1950 (Unie) ingedeel is;
- (2) dat die plekke omskryf in die tweede kolom van die bylae hiervan onderskeidelik die plekke is waarop die nominasie-hoe soos voormeld vir sodanige afdelings sitting moet hou;
- (3) dat die genoemde nominasiehoeve om tienuur in die oggend op die voormelde dag sitting moet hou;
- (4) dat, indien daar in enige voormelde kiesafdeling 'n stemming nodig blyk omdat meer as een persoon by sluiting van die genoemde nominasiehoeve in sodanige kiesafdelings behoortlik benoent is, die stemming op Woensdag die derdigste dag van Augustus 1950 plaas moet vind, en die stemming moet begin om sewenuur in die oggend, en sluit om agtuur in die aand van die genoemde dag;
- (5) dat elke magistraat, bykomende magistraat, assistentmagistraat en elkeen genoem in die derde kolom van die bylae hiervan, of enig iemand anders wat wettig namens hom optree, hierby as kiesbeampte aangestel word, en kiesbeampte is, by die verkiesing in die kiesafdeling waarvan die naam aangedui word in die eerste kolom van genoemde bylae teenoor die beskrywing of naam van elke genoemde magistraat, bykomende magistraat, assistentmagistraat en die bedoelde iemand anders wat wettig namens hom optree.

- (1) That Monday the twenty-fourth day of July, 1950, shall be the day on which a nomination court will sit in each Electoral Division to receive nominations of candidates for election of members of the Legislative Assembly of South West Africa for the several electoral divisions into which the Territory has been divided by Proclamation No. 105 of 1950 (Union);
- (2) that the places described in the second column of the schedule annexed hereto shall be respectively the places at which the nomination courts shall sit, as aforesaid, for such divisions;
- (3) that the said nomination courts shall sit at 10 o'clock in the forenoon of the aforesaid day;
- (4) that if a poll becomes necessary in any of the electoral divisions aforesaid, for the reason that more than one person shall have been duly nominated at the close of the sitting of the said nomination courts in such divisions, the poll shall be taken on Wednesday the thirtieth day of August, 1950, and shall commence at 7 o'clock in the forenoon and close at 8 o'clock in the evening of the said day;
- (5) that each magistrate, additional magistrate, assistant magistrate and other person mentioned in the third column of the schedule annexed hereto or other person lawfully acting for him, shall be and is hereby appointed to be the returning officer at the election in the electoral division, the name of which is set forth in the first column of the said schedule opposite to the description or name of each said magistrate, additional magistrate, assistant magistrate and the said other person.
