CUSTOMS ACT, NO. 35 OF 1944.

TEMPORARY REDUCTION OF DUTY ON MOTOR CARS
IMPORTED INTO THE UNION.

I, Nicolaas Christiaan Havenga, Minister of Finance, in terms of section eighty-one of the Customs Act, No. 35 of 1944, hereby —

(1) reduce until further notice, the duties provided for in paragraphs (a), (b) and (c) of item 129 of the Customs Tariff in respect of motor cars imported into the Union, by substitution for paragraphs (a), (b) and (c) the following:—

GENERAL NOTICE TO IMPORTERS.
