#### PROTECTION OF GAME.

#### BESKERMING VAN WILD.

The Administrator has been pleased in terms of the provisions of Section 5 of the Game Preservation Ordinance, 1951 (Ordinance No. 11 of 1951), as amended:—

Dit het die Administrateur behaag om, ooreenkomstig die bepaling van Artikel 5 van die Ordonnansie op Wildbeskerming 1951 (Ordonnansie 11 van 1951), soos gewysig:—

- A. To prescribe that the close season within which it shall not be lawful to hunt all game, other than protected game, shall be from the 1st August, 1952, to 31st March, 1953, save as in this Notice is excepted;
- B. To add Duiker to the category of Protected Game in respect of the whole Territory;
- C. To withdraw Namaqua partridges, wild duck and geese from the category of game in respect of the whole Territory;
- D. (1) In respect of the District of BETHANIE:—
  - (a) To prescribe that the period of the close season within which it shall not be lawful to hunt Gemsbuck and Kudu shall be 1st April, 1952, to 31st March, 1953: Provided that it shall be lawful for an owner or occupier of land to hunt not more than 4 Gemsbuck and 4 Kudu during the period 1st April, 1952, to 31st July, 1952;
  - (b) To limit the number of springbuck which may be hunted by an owner (other than an owner to whom section 10 (5) of Ordinance No. 11 of 1951 applies) or occupier of land to 16 per head during the period 1st April, 1952, to 31st July, 1952;
  - (c) To limit the number of springbuck which may be hunted under a small game licence to 4 in respect of every £1 licence fee payable.

- A. Te voorskryf dat die geslote tyd waarin dit onwettig sal wees om op enige wild, ander dan beskermde wild, te jag sal vanaf 1/8/52 tot 31/3/53 wees, behoudens die uitsonderings in hierdie Kennisgewing;

- (b) To limit the number of springbuck which may be hunted under a small game licence (including renewal thereof) to 4 during the period 1st April, 1952, to 31st July, 1952.

## (16) In respect of the District of WINDHOEK:—

- (a) To prescribe that the period of the close season within which it shall not be lawful to hunt gemsbuck shall be 1st April, 1952, to 31st March, 1953: Provided that it shall be lawful for an owner or occupier of land to hunt gemsbuck during the period 1st April, 1952, to 31st July, 1952.
- (b) To limit the number of springbuck which may be hunted under a small game licence to 3 in respect of every £1 licence fee payable.

E. This Notice shall take effect from 1st April, 1952.

F. Government Notice No. 218 of the 19th April, 1951, is hereby cancelled as from 1st April, 1952.

(EXPLANATORY NOTE: The effect of this notice is that the open season for the year 1952 for all game, other than protected game, is the period from 1st April, 1952, to 31st July, 1952, both dates inclusive.)
