## PROCLAMATION

BY HIS EXCELLENCY THE HONOURABLE ERNEST GEORGE JANSEN, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

No. 86 of 1952 (Union).]

GRANT OF FURTHER CONCESSIONS IN CUSTOMS TARIFF RATES UNDER SECTION SIX OF THE GENEVA GENERAL AGREEMENT ON TARIFFS AND TRADE ACT, 1948 (ACT No. 29 OF 1948).

WHEREAS the Government of the Union of South Africa have agreed to grant further concessions in customs tariff rates in respect of specified goods produced or manufactured in the territory of the Federal Republic of Germany on their importation into the Union, in consideration of equivalent privileges in respect of goods imported from the Union into the said territory:

AND WHEREAS the said further concessions in customs tariff rates are provided for in Schedule XVIII annexed to the First Protocol of Supplementary Concessions to the General Agreement on Tariffs and Trade;

AND WHEREAS the Governments of the Union of South Africa and the Federal Republic of Germany signed the said Protocol on the 25th April, 1952;

VERGUNNING VAN VERDERE TOEGEWINGS IN DOECANETARIEWE INGEVOLGE ARTIKEL SES VAN DIE WET OP DIE GENEEFSE ALGEMENE OOREENKOMS OOR TARIIEWE EN HANDEL (WET No. 29 VAN 1948).

NADEMAAL die Regering van die Unie van Suid-Afrika toegestem het om verdere doecanetarietoegeewings ten opsigte van gespesifiseerde goedere geproduseer of vervaardig in die gebied van die Federale Republiek Duitsland, toe te staan by hulle invoer in die Unie as teenprestasie vir gelykwaardige voorregte ten opsigte van goedere wat uit die Unie in genoemde gebied ingevoer word;

EN NADEMAAL voorsiening vir genoemde verdere doecanetarietoegeewings in Lys XVIII, vervat in die bylae van die Eerste Protokol van Bykomende Konsessies tot die Algemene Ooreenkoms oor Tariewe en Handel, gemaak word;

EN NADEMAAL die Regerings van die Unie van Suid-Afrika en die Federale Republiek Duitsland genoemde Protokol op 25 April 1952 onderteken het;

NOW THEREFORE, under and by virtue of the powers vested in me by section six of the Geneva General Agreement on Tariffs and Trade Act, 1948 (Act No. 29 of 1948), I hereby declare that the further concessions in customs tariff rates set forth in Schedule XVIII annexed to the First Protocol of Supplementary Concessions to the General Agreement on Tariffs and Trade shall with effect from the 25th May, 1952, be applied provisionally in relation to the territories of parties to the General Agreement on Tariffs and Trade set out in the Schedule to Proclamation No. 119 of 1948, as amended from time to time.
