POWERS CONFERRED UPON THE COMMISSION
APPOINTED TO ENQUIRE INTO A LONG-TERM
MARKETING SCHEME FOR MEAT AT WALVIS BAY.

NADEMAAL dit wenslik is om sekere magte aan die
Kommissie te verleen wat deur die Administrateur benoem
is om ondersoek in te stel na 'n langtermyn bemerkings-
skema van vleis te Walvisbaai;

WHEREAS it is desirable to confer certain powers
upon the Commission appointed by the Administrator to
enquire into a long-term marketing scheme for meat at
Walvis Bay;

SO IS DIT dat ek, kragtens die bevoegdheid my
verleen by artikel een van die Magte van Kommissies
Ordonnansie, 1927 (Ordonnansie 6 van 1927), hierby soos
volg proklameer, verklaar en bekendmaak:—

NOW THEREFORE, under and by virtue of the powers

Ordinance, 1927 (Ordinance 6 of 1927), I do hereby pro-
claim, declare and make known as follows:—

leen aan genoemde Kommissie.

The powers, jurisdiction and privileges set forth in sec-
tions three to seven of the Commissions' Powers Ordinance,
1927 (Ordinance No. 6 of 1927), are hereby conferred
upon the said Commission.

KOMMISSIE OM ONDERSOEK IN TE STEL NA 'N LANGTERMYN BEWARKINGSKEMA VAN VLEIS TE WALVISBAAI.

Hierby word vir algemene inligting bekend gemaak dat dit Sy Edelle die Administrateur behaag het om 'n kommissie aan te stel bestaande uit:—

Dr. A. C. Kirkpatrick, Elandsfontein Spoor, Transvaal (Voorsitter),

Mnr. R. Hirzel, Tegniese Adviseur, Departement Landbou, Pretoria,

Mnr. A. Webster, L.V., Nungubais, Outjo,

Mnr. E. R. Wadsworth, Algemene Bestuurder, Southern Rhodesia Cold Storage Commission, Bulawayo, Suid-Rhodesië, en

Mnr. H. K. Muller, Afdeling Landbou, Windhoek (Sekretaris),

met die volgende terme van opdrag:—

- (i) In hoeverre die huidige inrigting te Walvisbaai (wat behoort aan die Imperial Cold Storage) doeltreffend sal wees om Suidwes-Afrika se totale opbrengs van slagvee (gedurende 12 maande van die jaar) te slag.
- (ii) 'n Beraming moet gemaak word (deur 'n deskundige) om vas te stel wat die waarde van die huidige inrigting is, sowel as die koste verbonde aan enige verdere veranderings wat nodig mag wees, om minstens 3.000 slagvee per week te hanteer. Dit sal moet insluit—
 - (a) die oprigting van 'n fabriek vir die inmaak van minderwaardige vleis;
 - (b) die bewerking van neweprodukte en huide;
 - (c) beraming van nodige bedryfskapitaal.
- (iii) Teen watter bedrag die inrigting te Walvisbaai van die Imperial Cold Storage gekoop kan word.
- (iv) Teen watter tariewe die vleis, sowel as produkte, van die onderneming per boot (op die vernaamste sentrums) langs die kus van die Unie gelewer kan word.
- (v) Of daar reëlins getref moet word met die Unie-oewerhede om Walvisbaai as 'n distribusiesentrum te erken en vleis v.o.s. of v.o.b. oor te neem te Walvisbaai (soos voorrade beskikbaar is).

COMMISSION TO ENQUIRE INTO A LONG-TERM MARKETING SCHEME FOR MEAT AT WALVIS BAY.

It is hereby notified for general information that the Honourable the Administrator has been pleased to appoint a Commission consisting of—

Dr. A. C. Kirkpatrick, Elandsfontein Rail, Transvaal (Chairman),

Mr. R. Hirzel, Technical Adviser, Department of Agriculture, Pretoria,

Mr. A. Webster, M.P., Nungubais, Outjo,

Mr. E. R. Wadsworth, General Manager, Southern Rhodesia Cold Storage Commission, Bulawayo, Southern Rhodesia, and

Mr. H. K. Muller, Agricultural Branch, Windhoek (Secretary),

with the following terms of reference—

- (i) to what extent the existing establishment at Walvis Bay (owned by Imperial Cold Storage) will succeed in slaughtering all of South West Africa's slaughterstock during 12 months of the year;
- (ii) an estimate must be made by a technician to determine the value of the present establishment as well as the cost involved in effecting such alterations as may be necessary to enable the establishment to handle at least 3,000 slaughter animals per week. Such estimates should include also—
 - (a) the erection of a factory for the canning of inferior meat;
 - (b) the processing of by-products and hides;
 - (c) an estimation of the necessary working capital.
- (iii) the amount for which the establishment at Walvis Bay can be purchased from Imperial Cold Storage;
- (iv) the rates at which the undertaking's meat and allied products can be distributed by boat to the main ports of the Union;
- (v) whether arrangements must be made with the Union authorities to recognise Walvis Bay as a distribution centre and to take over meat l.o.r. or f.o.b. at Walvis Bay (as supplies become available).

FABRIEKSKAASMEELKPRYSE.

2. Niemand mag kaasmeelk verkry of verhandel nie buiten teen—

sewentien en 'n half pennies per gelling.

FACTORY CREAM PHICES.

1. No person shall acquire, sell or dispose of factory cream otherwise than on the basis of its butterfat content at a price other than—
 - (a) two shillings and nine and a half pence per pound choise grade butterfat contained therein;
 - (b) two shillings and seven and a half pence per pound table grade butterfat contained therein;
 - (c) two shillings and five and a half pence per pound household grade butterfat contained therein.

FACTORY CHEESE MILK PRICES.

2. No person shall acquire, sell or dispose of cheese milk at a price other than—

seventeen and a half pence per gallon.

FABRIEKSBOTTERPRYSE.

1. (1) Elke bottervervaardiger mag fabrieksbotter verkoop slegs teen—
 - (a) twee sjielings en nege pennies per pond in die geval van keurbotter; of
 - (b) twee sjielings en sewe pennies per pond in die geval van tafelbotter; of
 - (c) twee sjielings en vyf pennies per pond in die geval van huisbotter.
- (2) Elkeen buiten 'n bottervervaardiger mag fabrieksbotter verkoop slegs teen—
 - (a) twee sjielings en elf pennies per pond in die geval van keurbotter; of
 - (b) twee sjielings en nege pennies per pond in die geval van tafelbotter; of
 - (c) twee sjielings en sewe pennies per pond in die geval van huisbotter.

Met dien verstande dat—

 - (a) Op plekke geleë buite 'n straal van 10 myl vanaf 'n bottervervaardiger die werklike koste van vervoer van sodanige botter, bereken tot op die naaste halfpennie bo sodanige prys; bygevoeg mag word;
 - (b) op plekke verder as 50 myl vanaf die naaste spoorwegstasie of -halte, nog een pennie per pond by die vasgestelde pryse gevoeg mag word.

FABRIEKSKAASPRYSE.

2. (1) Elke kaasvervaardiger mag kaas van die tipe Cheddar of Soetmelk slegs verkoop teen—

twee sjielings per pond.

Met dien verstande dat by die verkoping van hele, ongesnyde tipe Cheddar kase ligter as twaalf pond stuk en van die tipe Soetmelk ligter as twee pond stuk, 'n bedrag gelyk aan een pennie per pond by die vasgestelde pryse gevoeg mag word.
- (2) Elkeen buiten 'n kaasvervaardiger mag kaas van die tipe Cheddar of Soetmelk slegs verkoop teen—

twee sjielings en vier pennies per pond.

PHICES OF DAIRY PHODUCE.

In terms of section *eight* of the Dairy Industry Control Ordinance, 1931 (Ordinance No. 16 of 1931), as amended, I, ALBERTUS JOHANNES ROUX VAN IIIIJJN, Administrator of South West Africa, do hereby make known that the Dairy Industry Control Board has, in terms of paragraph (o) of sub-section (1) of section *eight* of the said Ordinance, with my approval, fixed the prices of dairy produce to be those set out in the Schedule hereto, with effect from the First day of July, 1952.

Government Notice No. 87 of the 1st April, 1952, is hereby withdrawn.

SCHEDULE.

CREAMERY BUTTER PRICES.

1. (1) No butter manufacturer shall sell creamery butter at a price other than—
 - (a) two shillings and nine pence per pound in the case of choice butter; or
 - (b) two shillings and seven pence per pound in the case of table butter; or
 - (c) two shillings and five pence per pound in the case of household butter.
- (2) No person other than a butter manufacturer shall sell creamery butter at a price other than—
 - (a) two shillings and eleven pence per pound in the case of choice butter; or
 - (b) two shillings and nine pence per pound in the case of table butter; or
 - (c) two shillings and seven pence per pound in the case of household butter.

Provided that—

 - (a) at places which are situated beyond a radius of ten miles from a butter manufacturer the actual cost of transport of such butter may be added calculated to the nearest half-penny greater than such price;
 - (b) at places which are more than fifty miles from the nearest railway station or siding a further one penny per pound may be added to the prices fixed.

FACTORY CHEESE PRICES.

2. (1) No cheese manufacturer shall sell cheese of the Cheddar or Sweet-Milk type at a price other than—

two shillings per pound;

provided that in the case of whole uncut cheeses of the Cheddar type, weighing less than twelve pounds each, and of the Sweet-Milk type, weighing less than two pounds each an amount of one penny per pound may be added to the prices fixed.
- (2) No person other than a cheese manufacturer shall sell cheese of the Cheddar or Sweet-Milk type at a price other than—

two shillings and four pennies per pound.

LEVIES ON CREAMERY BUTTER AND FACTORY CHEESE. [3rd July, 1952.]

In terms of section *eleven* of the Dairy Industry Control Ordinance, 1931 (Ordinance No. 16 of 1931), as amended, I, ALBERTUS JOHANNES ROUX VAN RIJN, Administrator of South West Africa, do hereby make known that the Dairy Industry Control Board has, in terms of paragraphs (e) and (d) of sub-section (1) of section *eight* of the said Ordinance, with my approval, fixed the levies on creamery butter and factory cheese to be those set out in the schedule hereto, with effect from the second day of June, 1952.

Government Notice No. 459 of the 19th November, 1951, is hereby withdrawn.

SCHEDULE.

CREAMERY BUTTER.

1. There is hereby imposed a levy on creamery butter at the rate of—
one halfpenny per pound.

FACTORY CHEESE.

2. There is hereby imposed a levy on factory cheese at the rate of—
two pence per pound.
