His Excellency the Governor-General has been pleased, under the powers vested in him by Section *ten* of the Police Act, 1912 (Act No. 14 of 1912), to approve of the following amendment to the Regulations for the South African Police promulgated under Government Notice No. 3250 of 1951, as amended:—

*Regulation 32 (1) (a).* — Delete the words “and is at least 21 years of age” in the second line.

## WYSIGING VAN ONDERWYSREGULASIES.

Die Administrateur behaag om kragtens en ingevolge die bevoegdheid hoon verleent by sub-artikel (2) van artikel eenhonderd een-en-twintig van die Onderwys Proklamasie 1926 (Proklamasie 16 van 1926), soos gewysig, die onderstaande wysings aan die regulasies, afgekondig by Goewermentskennisgewing 63 van 23 Maart 1936, soos gewysig by Goewermentskennisgewings 188 van 1931 en 491 van 1951, goed te keur met ingang van 1 April 1952.

1. Regulasie 1 word hierby geskrap en met die onderstaande nuwe regulasie vervang:

1. Geen toelae word verleen nie, tensy die Direkteur oortuig is—

- (i) dat daar minstens vyftien leerlinge ingeskryf is op die tydstip van die aansoek om 'n hulptoelae;
- (ii) dat die akkommodasie wat gebruik gaan word, voldoende is;
- (iii) dat die onderwyser wat in diens geneem gaan word, geskik is.

3. Regulasie 4 word hierby gewysig deur na die woord „ses” die onderstaande woorde by te voeg:—

„Die toelae kan tot en met die sesde standerd betaal word as daar meer as een onderwyser in die personeel is en die leerlinge in standerd vyf en standerd ses slegs deur 'n behoorlik gekwalifiseerde onderwyser onderrig word.”

## AMENDMENT OF EDUCATION REGULATIONS.

The Administrator has been pleased, under and by virtue of the powers vested in him by sub-section (2) of section one hundred and twenty-one of the Education Proclamation, 1926 (Proclamation No. 16 of 1926), as amended, to make the following amendments to the regulations published under Government Notice No. 63 of the 23rd March, 1936, as amended by Government Notices Nos. 188 of 1931 and 491 of 1951 with effect from the 1st of April, 1952:—

1. Regulation 1 is hereby deleted and the following new regulation substituted therefor:—

1. A grant shall not be made unless the Director is satisfied—

- (i) that at least fifteen pupils are enrolled at the time when the application for a grant-in-aid is made;
- (ii) that the accommodation to be utilised is adequate;
- (iii) that the teacher to be employed is suitable.

2. Regulation 2 is hereby amended by the deletion of the word "six" wherever it occurs therein and by the substitution thereof of the word "fifteen".

3. Regulation 4 is hereby amended by the addition after the word "sixteen" of the following words:—

"The grant may be paid up to and including the sixth standard if there is more than one teacher on the staff and the pupils in standards five and six are taught only by a suitably qualified teacher."

**PRICE CONTROL.****MAXIMUM PRICES OF CLOCKS AND WATCHES.**

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 202 of 1st July, 1952 (Maximum Prices of Clocks and Watches), by—

(1) the substitution of the following new subparagraph 1 (2) (a) for the corresponding subparagraph thereof:—

“1. (2) (a) At which any striking and/or chiming clock (excluding an alarm clock that does not also strike or chime) or any clock or watch of seven jewels or more with lever movement (other than a pin pallet lever movement) may be sold to any person by any person other than the importer thereof at the cost of such clock or watch to the seller plus 70 per cent. thereof.”;

(2) the substitution of the following new subparagraph 1 (3) (a) for the corresponding subparagraph thereof:—

“1.
