CONTROL OF EXPORTS.

I, ERIC HENDRIK LOUW, Minister of Economic Affairs, acting under and by virtue of the powers vested in me by War Measure No. 146 of 1942, as amended, read with War Measure No. 75 of 1945, do hereby order as follows:—

1. As from the date of publication of this notice, none of the goods listed in Schedules A and B hereto shall be exported from the Union to any country outside the Union, unless such goods are covered by an export permit issued under the authority of the

UITVOERBEHEER.

Ek, ERIC HENDRIK LOUW, Minister van Ekonomiese Sake, handelende kragtens die bevoegdheid my verleen by Oorlogsmaatreël No. 146 van 1942, soos gewysig, gelees met Oorlogsmaatreël No. 75 van 1945, gelas hierby soos volg:—

1. Met ingang van die datum van publikasie van hierdie kennisgewing mag geen goedere wat in bygaande Bylaes A en B aangegee is, uit die Unie uitgevoer word na enige land buite die Unie nie tensy sodanige goedere gedek is deur 'n uitvoerpermit

Secretary for Commerce and Industries, provided that—

- (a) in respect of the goods listed in Schedule A no export permit shall be required when such goods are exported to Basutoland, Swaziland and the Bechuanaland Protectorate;
- (b) in respect of the goods listed in Schedule B no export permit shall be required when such goods are exported to the United Kingdom of Great Britain and Northern Ireland, or any British Dominion, Colony (except Hong Kong), Possession, Protectorate or Mandated Territory or to the United States of America; and
- (c) no permit in terms of this notice shall be required in respect of the export of goods listed in Schedule C hereto.

2. Applications for export permits shall be completed by the applicant in the form of Schedule D hereto and shall be submitted in the manner indicated therein. When applications are submitted in respect of goods which will be exported in more than one consignment, applicants should endorse the application forms accordingly in order that continuation sheets as per Schedule F may be attached. Particulars of exports against the relative permit will be recorded on the continuation sheets by the Customs. (Application forms for export permits may be obtained from any Customs House or from the Secretary for Commerce and Industries.)

3. Export permits are not transferable and the goods mentioned therein may be exported only by the person or firm named therein as consignor to the person or firm named therein as consignee: Provided that where the consignee is not known at the time of application for a permit, the Secretary for Commerce and Industries in his discretion may authorise the issue of a permit omitting the name of the consignee.

4. Export permits shall be valid for a maximum period of 180 days, but the period of validity may be extended for one further period of not more than ninety days on written application to the Secretary for Commerce and Industries to the ContROLLER concerned: provided the application for extension is made *before* the permit has lapsed otherwise a fresh application for a new permit will be required. Applications for extension of permits must be accompanied by the relative export permits.

5. Export permits may be withdrawn at any time without notice and without stating reasons for such withdrawal.

6. In this notice and in the Schedules hereto, "Union" means the Union of South Africa and includes the Territory of South West Africa and the port and settlement of Walvis Bay.

#### SCHEDULE A.

#### SECRETARY FOR AGRICULTURE.

- (1) Animal protein (fishmeal and meatmeal).
- (2) Bonemeal for feeding livestock.
- (3) Bones, except skeletons.
- (4) Feedstuffs, protein rich (oilcakes and meal).
- (5) Feedstuffs (excluding oyster shell and shell grit) for stock, poultry and pets.

wat met die magtiging van die Sekretaris van Handel en Nywerheid uitgereik is, met dien verstande dat—

- (a) in die geval van die goedere in Bylae A genoem, geen uitvoerpermit nodig is nie waar sodanige goedere na Basoetoland, Swaziland en die Betsjocanaland-protectoraat uitgevoer word;
- (b) in die geval van die goedere in Bylae B genoem, geen uitvoerpermit nodig is nie waar sodanige goedere na die Verenigde Koninkryk van Groot-Brittanje en Noord-Ierland, of enige Britse dominium, kolonie (uitgesonderd Hongkong), besitting, protectoraat of mandaatgebied of na die Verenigde State van Amerika uitgevoer word; en
- (c) geen permit ingevolge hierdie kennisgewing ten opsigte van die uitvoer van goedere in Bylae C hiervan genoem, nodig is nie.

2. Aansoek om uitvoerpermities moet deur die applikant in die vorm van Bylae D hiervan ingevul word en moet op die wyse daarin aangedui ingedien word. Wanneer aansoek ingedien word ten opsigte van goedere wat in meer as een versending uitgevoer sal word, moet applikante aantekening daarvan op die aansoekvorms maak sodat vervolgvle ooreenkomstig Bylae F aangeheg kan word. Besonderhede van uitvoere kragtens die betrokke permit sal deur die Doecan op die vervolgstade aangeteken word. (Aansoekvorms vir uitvoerpermities is by enige Doeanekantoor of by die Sekretaris van Handel en Nywerheid verkrygbaar.)

3. Uitvoerpermities is nie oordraagbaar nie en die goedere daarin vermeld mag alleen deur die persoon of firma daarin genoem as die afsender uitgevoer word na die persoon of firma daarin genoem as die geadresseerde: Met dien verstande dat waar die geadresseerde nie bekend is wanneer daar aansoek om 'n permit gedoen word nie, die Sekretaris van Handel en Nywerheid na goeëddunke magtiging kan verleen tot die uitreiking van 'n permit sonder die naam van die geadresseerde.

4. Uitvoerpermities is vir 'n maksimum tydperk van 180 dae geldig, maar die geldigheidstydperk kan vir een verdere tydperk van hoogstens negentig dae verleng word as aansoek skriftelik by die Sekretaris van Handel en Nywerheid of die betrokke kontroleur gedoen word, mits die aansoek om verlenging voorgelê word *voordat* die permit verval het, anders sal 'n nuwe aansoek om 'n nuwe permit nodig wees. Aansoek om verlenging moet van die betrokke uitvoerpermities vergesel gaan.

5. Uitvoerpermities kan te eniger tyd sonder kennisgewing en sonder vermelding van redes ingetrek word.

6. In hierdie kennisgewing en in die Bylaes hiervan beteken „Union" die Unie van Suid-Afrika met inbegrip van die gebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai.

#### SEKRETARIS VAN LANDBOU.

- (1) Dierlike proteïen (vismeele en vleismeele).
- (2) Beenmeel vir veevoer.
- (3) Bone, met uitsondering van skelette.
- (4) Voersoorle, ryk aan proteïen (oliekoeke en -meel).
- (5) Voersoorle (met uitsondering van oesterskulp en skulpgruis) vir vee, pluimvee en troeteldiere.

- (6) Fertilizers.
- (7) Livestock and poultry, excluding horses, donkeys and mules.
- (8) Fodder, namely lucerne, oats and teff.

CONTROLLER OF BUILDING MATERIALS.

- (1) Asbestos, unmanufactured.
- (2) Cement, building.
- (3) (a) Unmanufactured softwood and hardwood, excluding Kamassi (*Gonioma kamassi*) and Cape Box (*Buxus macowani*).
- (b) Ceiling and flooring boards, planed, tongued, grooved and parquet flooring.
- (4) All animal hair and bristles, prepared and not prepared, but excluding mohair and rabbit hair.

SECRETARY FOR NUTRITION.

All articles of food and drink, including such as are used as ingredients or materials in the manufacture, processing and preserving of food, excepting bush tea (Rooibos and all other bush teas from indigenous plants).

NOTE.—For oils and fats see under Soap and Oils; for animal feedstuffs see under Secretary for Agriculture.

The exportation of sugar is subject to the conditions prescribed in Government Notice No. 1813 of 26th November, 1937, and any amendments thereof, and the exportation of crawfish and crawfish tails are subject to the conditions prescribed in section two of the Crawfish Export Act, No. 9 of 1944, and Government Notice No. 1866, dated 30th August, 1946. These notices are administered by the Department of Commerce and Industries and enquiries should be addressed to the Secretary for Commerce and Industries, Private Bag 84, Pretoria.

CONTROLLER OF INDUSTRIAL CHEMICALS.

- (1) Sulphur.
- (2) Sulphuric acid.

CONTROLLER OF IRON AND STEEL.

- (1) (a) Angle, channel, joist, tee, piling section and other structural sectional material, worked and unworked.
- (b) Billet, bloom, ingot, bar and slab.
- (c) Drill steel, worked and unworked.
- (d) Fencing standards, posts and droppers.
- (e) Ferro-alloys.
- (f) Forgings, finished or unfinished.
- (g) Hoop and strip.
- (h) Iron and steel scrap.
- (i) Pig iron.
- (j) Plate, worked and unworked.
- (k) Rails, worked and unworked, steel sleepers and accessories.
- (l) Round rod, square, hexagonal and flat bars, and other sections or shapes (hot rolled, cold rolled, bright drawn or turned and polished), worked and unworked.
- (m) Sheet and galvanised sheet, flat and corrugated, worked and unworked.
- (n) Spring steel, worked and unworked.
- (o) Tool steel, worked and unworked.
- (p) Tubes, casings and pipes, worked and unworked and fittings therefor; cast iron pipes and fittings.
- (q) Wire rod, wire rope, wire (plain, barbed and galvanised), worked and unworked.

- (6) Misstowwe.

KONTROLEUR VAN BOUMATERIAAL.

- (1) Asbes, onverwerkte.
- (2) Bousement.
- (3) (a) Onverwerkte sagte- en hardhoutsoorte, met uitsondering van Kamassi (*Conioma kamassi*) en Kaapse bukhout (*Buxus macowani*).
- (b) Plafon- en vloerplanke, geskaaf, met veer en groef, en houtvloerblokkies.
- (4) Alle dierlike haar en steekhaar, bewerk of onbewerk (uitgesonderd bokhaar en konynhaar).

SEKRETARIS VAN VOEDING.

Alle soorte voedsel en drank, met inbegrip van dié wat as bestanddele of materiaal by die vervaardiging, verwerking en preservering van voedsel gebruik word, met uitsondering van bossiestee (rooibos en alle ander bossiestee van inheemse plante gemaak).

OPMERKING.—Vir olie en vet, kyk onder Saep en Olies; vir dieervoersoorte kyk onder Sekretaris van Landbou.

Die uitvoer van suiker is onderworpe aan die voorwaardes voorgeskryf in Goewermentskennisgewing No. 1813 van 26 November 1937, en wysigings daarvan, en die uitvoer van kreef en kreefsterte is onderworpe aan die voorwaardes voorgeskryf in artikel twee van die Wet op die Uitvoer van Kreef, No. 9 van 1944, en Goewermentskennisgewing No. 1866 van 30 Augustus 1946. KONTROLEUR VAN YSTER EN STAAL.

- (1) (a) Hoek-, U-, balk-, T- en paalyster en ander bouprofiel materiaal, verwerk en onverwerk.
- (b) Knuppel, voorblok, gietblok, staaf en platstuk.
- (c) Boorstaal, verwerk en onverwerk.
- (d) Heiningpale, hoekpale en hangpaalijies.
- (e) Ysterlegerings.
- (f) Sneestukke, afgewerk of onafgewerk.
- (g) Hoepel en band.
- (h) Yster- en staalfval.
- (i) Ru-yster.
- (j) Plaat, verwerk en onverwerk.
- (k) Spoorstawe, verwerk en onverwerk, staaldwarsleërs en toebehoere.
- (l) Ronde stang, vierkantige, seskantige en plat stawe en ander profiele of fatsoene (warm gewals, koud gewals, blinkgetrek of gedraai, en gepoleer) verwerk en onverwerk.
- (m) Plaat en gegalvaniseerde plaat, plat en gegolf, verwerk en onverwerk.
- (n) Veerstaal, verwerk en onverwerk.
- (o) Gereedskapstaal, verwerk en onverwerk.
- (p) Buise, bekledingsbuise en pype, verwerk en onverwerk, en toebehoere daarvoor, gietystertype en toebehoere.
- (q) Draadstang, draadrou, draad (gladde, doring- en gegalvaniseerde), verwerk en onverwerk.

- (r) Tinplate and terneplate, worked and unworked, including tinplate and terneplate scrap and empty containers consisting wholly or partly of tinplate or terneplate.

NOTE A.—Before ordering materials for fabricating goods for export or commencing to manufacture against export orders, the prior consent of the Controller of Iron and Steel must be obtained.

NOTE B.—Applications for export permits must clearly and fully define and describe the article(s) which are to be exported and must also clearly specify what percentage(s) by weight of each of the material(s) mentioned above were incorporated in the article(s) manufactured.

- (2) All iron and steel manufactured or semi-manufactured articles containing 50 per cent or more by weight of any of the items mentioned under (1) above, but specifically excluding the following:—
- (i) Air compressors and spares; pneumatic operated drills and spares therefor but excluding cutting and drilling tools.
  - (ii) Bicycles, commercial tricycles, motor cycles and aircraft and spares and components therefor.
  - (iii) Diamond drilling and water boring machines and spares therefor.
  - (iv) Engines, petrol, oil and steam and spares therefor.
  - (v) Generators, electric motors and starters and spares therefor.
  - (vi) Machine tools for metal, stone and wood working and spares therefor; bench and hand tools.
  - (vii) Medical, dental, laboratory, photographic and veterinary apparatus, equipment and instruments.
  - (viii) Sewing machines, domestic and industrial and components and spares therefor.
  - (ix) Spares for motor vehicles.
  - (x) Typewriters, duplicators, dictaphones, addressing, adding and calculating machines, cash registers and their spares and components.
  - (xi) Second-hand farming implements and equipment, the property of persons leaving the Union permanently (excluding tractors and motor vehicles).
  - (xii) Spares and components for tractors, bulldozers, mechanical excavators and self-propelled road-making machinery.
  - (xiii) Surveying instruments and components and spares therefor.
  - (xiv) Broadcast receivers and radiograms, both of the domestic type.

#### CONTROLLER OF JUTE GOODS.

- (1) Jute products whether in the piece or manufactured: bags, woolpacks and pockets whether new or second-hand made from jute, cotton, linen or any other fibre and suitable as containers for the conveyance of grain or grain products, wool, fruit, vegetables, fertilizers or coal; sewing and binder twine; paper-lined jute or fibre material.
- (2) Any of the commodities mentioned above, whilst goods for export are contained, wrapped or packed therein, except woolpacks as containers for wool and mohair.

#### LIVESTOCK AND MEAT INDUSTRIES CONTROL BOARD.

- (1) Hide and skin pieces, whether unprocessed, processed or partly processed.
- (2) Leather, all types but excluding leather manufactures.

NOTE.—Hides and skins are now controlled under Government Notice No. 1903 (*Government Gazette* No. 4910), dated 22nd August, 1952, by the Livestock and Meat Industries Control Board.

- (r) Tinplaat en verlude plaat, verwerk en onverwerk, met inbegrip van tinplaat- en verlude plaatafval, en leë houers wat geheel en al of gedeeltelik uit tinplaat of verlude plaat bestaan.

OPMERKING A.—Voordat bestellings vir materiaal vir die vervaardiging van goedere vir uitvoer geplaas word, of voordat daar met die vervaardiging van goedere ten opsigte van uitvoerbestellings 'n aanvang gemaak word, moet die toestemming van die Kontroleur van Yster en Staal verkry word.

OPMERKING B.—Aansoek om uitvoerpermitte moet die artikel(s), wat uitgevoer sal word, duidelik en volledig beskryf, en moet ook duidelik spesifiseer watter persentasie(s) aan gewig van elkeen van die stof (stowwe) hierbo vermeld, die vervaardigde artikel(s) bevat.

- (2) Alle vervaardigde of gedeeltelik vervaardigde yster- en staalartikels wat 50 persent of meer aan gewig van enigeen van die items onder (1) hierbo vermeld bevat, maar met die bepaalde uitsondering van die volgende:—
- (i) Lugkompressors en reserwedele; druklugbore en toebehoere daarvoor, maar uitgesonderd sny- en boorgereedskap.
  - (ii) Trapfietsse, handelsdriewiele, motorfietsse en vliegtuie, en reserwe- en onderdele daarvoor.
  - (iii) Diamantboor- en waterboormasjiene en reserwedele daarvoor.
  - (iv) Petrol-, olie- en stoommotore en reserwedele daarvoor.
  - (v) Generators, elektriese motore en aansitters, en reserwedele daarvoor.
  - (vi) Masjiengereedskap vir die verwerking van metaal, klip en hout, en reserwedele daarvoor; werkbank- en handgereedskap.
  - (vii) Mediese, tandheelkundige, laboratorium-, fotografiese en veerartsenykundige apparaat, uitrusting en instrumente.
  - (viii) Naaimasjiene, huishoudelike en industriële, en reserwe- en onderdele daarvoor.
  - (ix) Reserwedele vir motorvoertuie.
  - (x) Tikmasjiene, afromasjiene, diktafoons, adres-, optel-, en rekenmasjiene, kasregisters, en hul reserwe- en onderdele.
  - (xi) Tweedehandse plaaswerktuie en uitrusting (met uitsondering van trekkers en motorvoertuie) wat die eiendom is van persone wat die Unie permanent verlaat.
  - (xii) Reserwe- en onderdele vir trekkers, olifantskrappers, masjiengrawe, en selfaangedrewe padmaakmasjinerie.
  - (xiii) Landmetersinstrumente en onder- en reserwedele daarvoor.
  - (xiv) Radio-ontvangtoestelle en radiogramme, albei van die huishoudelike tipe.

#### KONTROLEUR VAN JUTEGOEDERE.

- (1) Juteprodukte, hetsy in die stuk of verwerk; sakke, wolsakke en sakkies, hetsy nuut of tweedehands, gemaak van jute, katoen, linne of enige ander vesel en geskik vir gebruik as houers vir die vervoer van graan of graanprodukte, wol, vrugte, groente, mistowwe of steenkool; naai- en bindtoe; jute- en vesel-materiaal met papier uitgevoer.
- (2) Enigeen van bogenoemde artikels as goedere vir uitvoer daarin of daarin toegedraai of gepak is, met uitsondering van wolsakke as houers vir wol en bokhaar.

#### RAAD VAN BEHEER OOR DIE VEE- EN VLEIS- NYWERHEDE.

- (1) Huid- en velstukke, hetsy onverwerk, verwerk of gedeeltelik verwerk.
- (2) Leer, alle tipes, maar uitgesonderd leerfabrikate.

OPMERKING.—Huide en velle word nou kragtens Goewernementskennisgewing No. 1903 (*Saatskoerant* No. 4910) van 22 Augustus 1952, deur die Raad van Beheer oor die Vee- en Vleisnywerheede beheer.

**CONTROLLER OF MEDICAL REQUISITES.**

- (1) Aureomycin.
- (2) Chloromycetin.
- (3) Terramycin.
- (4) Cortisone (Cortone).

**CONTROLLER OF MOTOR VEHICLES.**

- (1) Automotive vehicles, or chassis, in which power may be applied to all wheels; and specialised components therefor.
- (2) Tractors, bulldozers, self-propelled mechanical excavators and self-propelled roadmaking machinery.
- (3) Passenger or commercial motor vehicles other than motor cycles and motor cycle and side-car combinations, subject to the following conditions:—
  - (a) No permit shall be required in respect of any motor vehicle which is exported by the owner thereof for a period of not more than three months in connection with the temporary departure of the owner thereof from the Union; provided such owner has, before his departure from the Union, handed in to the proper officer of customs at the point of exit, a notification to the Secretary in the form of the Annexure E to this notice, of the point of entry through which the motor vehicle will be returned to the Union.
  - (b) The owner of any motor vehicle which has been exported from the Union in terms of paragraph (a) above shall return the motor vehicle to the Union through the point of entry specified in the notification within a period of three months after it has been so exported.
  - (c) The Secretary may permit the temporary export of motor vehicles for any period on the following conditions:—
    - (i) Application for export shall be made on Form C.I. 100X as indicated in Schedule D to this notice.
    - (ii) The owner of the motor vehicle shall notify the Secretary in the form of the Annexure E to this notice, of the point of entry through which the motor vehicle will be returned to the Union.
  - (d) The owner of any motor vehicle which has been exported from the Union under any such permit, shall return the motor vehicle to the Union through the point of entry specified in the notification within the period stated in the permit.

**CONTROLLER OF NON-FERROUS MATERIALS.**

- (1) (a) Aluminium in any form, including scrap, residues, ashes, powder or dust.
- (b) Antimony and its alloys and ores.
- (c) Brass, bronze, gunmetal and copper in any form, including scrap, webbings, turnings, cuttings, swarf, sweepings, drosses, ashes, skimmings, slag and copper ore.
- (d) Chrome and its ores and alloys.
- (e) Cobalt in any form, including cobalt oxides and salts.
- (f) Graphite, artificial graphite, and amorphous carbon (excluding charcoal) in any form, including scrap residues and off-cuts.
- (g) Lead in any form, including lead scrap, scrap battery plates, drosses and skimmings from lead, and lead ores.
- (h) Magnesium and its alloys and ores.
- (i) Manganese and its ores and alloys.
- (j) Molybdenum in any form, including ores and concentrates and ferro-molybdenum, molybdic acid and molybdenum salts (including calcium molybdate and molybdic oxide).

- (1) Aurcomisien.
- (2) Chloromisetien.
- (3) Terramisien.
- (4) Kortisoon (Kortoon).

**KONTROLEUR VAN MOTORVOERTUIE.**

- (1) Motorvoertuie, of onderstelle, waarvan al vier wiele aangedryf kan word; en gespesialiseerde onderdele daarvoor.
- (2) Trekkers, olifantskrapers, selfaangedrewe masjien-grawe en selfaangedrewe padmaakmasjiene.
- (3) Passasiers- of kommersiële motorvoertuie, uitgesonderd motorfietse en motorfiets met sypspanwaens, behoudens die volgende voorwaardes:—
