Ek, ALBERTUS JOHANNES ROUX VAN RHIJN, Administrateur van Suidwes-Afrika, gee hiermee kennis kragtens sub-artikel (2) van artikel drie van die Verbode Gebiede Proklamasie, 1928 (Proklamasie 26 van 1928), dat die Eerste Bylae tot genoemde Proklamasie, soos gewysig, hierby verder gewysig word deur—

NOTICE IN TERMS OF SECTION 3 (2) OF THE PROHIBITED AREAS PROCLAMATION, 1928 (PROCLAMATION No. 26 OF 1928).

I, ALBERTUS JOHANNES ROUX VAN RHIJN, Administrator of South West Africa, give notice in terms of sub-section (2) of section three of the Prohibited Areas Proclamation, 1928 (Proclamation No. 26 of 1928), that the First Schedule to that Proclamation, as amended, is hereby further amended by:—

(a) The deletion of the words—

“thence eastwards in a straight line to the western corner beacon of the farm Kakatswa Onguati No. 236; thence north-westwards and north-eastwards continuing along the boundaries of the farms Kakatswa Onguati No. 236, Katemba Autsab No. 210 and Farm No. 241 to the north-eastern beacon of the last-mentioned farm; thence north-westwards, westwards and northwards along the boundaries of the farms Kamanjab Nord No. 212 and Weissbrunn No. 192 to the north-western beacon of the last-mentioned farm; thence eastwards, southwards and eastwards along the boundaries of the farms Weissbrunn No. 192 and Kamanjab Nord No. 212 to the north-eastern beacon of the last-mentioned farm; thence north-eastwards in a straight line to a point one kilometre north of the Waterhole Gogarus, the aforegoing all being in the District of Outjo; thence in a straight line to the south-western extremity of the Etosha Pan;”

where they occur therein, and the substitution thereof of the following words:—

“thence north-westwards continuing along the south-western boundary of the last-mentioned farm to its western corner beacon; thence generally northwards continuing along the western boundaries of the following farms, in the Registration Division A: Grootberg No. 191, Farm No. 620, Farm No. 621, Farm No. 624, Farm No. 638, Farm No. 641 and Farm No. 642, to the north-western corner beacon of the last-mentioned farm; thence generally eastwards continuing along the northern boundaries of the following farms: Farm No. 642, Farm No. 643, Farm No. 644, Farm No. 645, Farm No. 646, Farm No. 647, Farm No. 648, Farm No. 649, Farm No. 652, Farm No. 655, Farm No. 656, Farm No. 659, Farm No. 660, Farm No. 662 and Safari No. 663, to the north-eastern corner beacon of the last-mentioned farm; thence southwards continuing along the eastern boundary of the farm Safari No. 663, to the south-eastern corner beacon of the said farm; thence generally eastwards continuing along the northern boundaries of the following farms: Moesamoeroep No. 421, Farm No. 424, Farm No. 427 and Eindpaal No. 429, to the most northern beacon of the last-mentioned farm, thence east by northwards continuing in a straight line to a point one kilometre due north of the Police Station Okaukuejo, thence northwestwards continuing in a straight line to a point where the southwestern extremity of the Etosha Pan is intersected by the meridian of longitude 16° East;”

(b) By the deletion of the words—

“Guntas No. 272 to the northeastern beacon of the last-mentioned farm; thence due north in a straight line to a point on this line where it is intersected by a line of Latitude 19° South; thence due east along this line of Latitude to a point on this line, where it is intersected by a line of Longitude 19° East of Greenwich; thence due south along this line of Longitude to a point on this line where it intersects the northern boundary of the Otjituo Native Reserve No. 235;”

where they occur therein, and the substitution thereof of the following words:—

“to the northwestern corner beacon of the last-mentioned farm; thence generally eastwards continuing along the northern boundaries of the following farms: Guiganab Ost No. 273, Guntas No. 272, Leeunes No. 895, Langlaagte No. 896, Ontevrede No. 898, Geduld No. 899, Nuwejaar No. 900, Soverby No. 901, Moedhou No. 902, Sonop No. 903 and Maanlig No. 904, to the northeastern corner beacon of the last-mentioned farm;
