PROCLAMATION

BY HIS EXCELLENCY THE HONOURABLE ERNEST
GEORGE JANSEN, DOCTOR OF LAWS, GOVERNOR-
GENERAL OF THE UNION OF SOUTH AFRICA.

PROCLAMATION OF THE ADMINISTRATION OF
NATIVE AFFAIRS IN SOUTH WEST AFRICA, 1955.

1. Under and by virtue of the powers vested in me
by sub-sections (2) and (3) of section three of the South-
West Africa Native Affairs Administration Act, 1954 (Act
No. 56 of 1954), I do hereby declare that the provisions
set out in the Schedule to this Proclamation shall apply
for the purpose of the application of the laws referred to
in sub-section (1) of that section.

2. This Proclamation shall be called the South West
Africa Native Affairs Administration Proclamation, 1955,
and shall come into operation on the first day of April,
1955.

1. Krugens die bevoegdheid my verleen by subartikels
(2) en (3) van artikel drie van die Wet op die Adminis-
trasie van Naturellesake in Suidwes-Afrika, 1954 (Wet
56 van 1954), verklaar ek hierby dat die bepalings
in die Bylae van hierdie Proklamasie uiteengesit, geld vir
die doel van die toepassing van die wette genoem in sub-
artikel (1) van daardie artikel.

2. Hierdie Proklamasie heet die Proklamasie op die
Administrasie van Naturellesake in Suidwes-Afrika, 1955,
en tree in werking op die eerste dag van April 1955.

SCHEDULE.

1. (1) The Provisions of paragraph (a) to and including (f) of sub-section (1) of section three of the South-West Native Affairs Administration Act, 1954 (hereunder called the Act), shall not apply for the purpose of the application of the laws mentioned in the first column of Annexure A hereto.

(2) In the application of such law, a reference therein to an expression mentioned in the second column of the said Annexure opposite such law shall be construed as a reference to the expression mentioned in the third column of that Annexure opposite that law.

2. The powers and functions conferred on or assigned to the Governor-General by virtue of sub-section (1) of section three of the Act, except the powers and functions under the laws referred to in Annexure B, are hereby delegated to the Minister of Native Affairs.

BYLAE.

1. (1) Die bepalings van paragrafe (a) tot en met (f) van subartikel (1) van artikel drie van die Wet op die Administrasie van Naturesake in Suidwes-Afrika, 1954 (hieronder die Wet genoem), geld nie vir die doel van die toepassing van die wette wat in die eerste kolom van Aanhangel A hiervan vermeld word nie.

(2) By die toepassing van so 'n wet word 'n verwysing daarin na in uitdrukking genoem in die tweede kolom van genoemde Aanhangel teenoor so 'n wet beskou as 'n verwysing na die uitdrukking genoem in die derde kolom van daardie Aanhangel teenoor daardie wet.

2. Die bevoegdhede en funksies ingevolge subartikel (1) van artikel drie van die Wet aan die Goewerneur-generaal verleen of toegewys, uitgesonderd die bevoegdhede en funksies ingevolge die wette in Aanhangel B vermeld word hierby aan die Minister van Naturesake oorgedra.
