PROTECTION OF GAME.

The Administrator has been pleased in terms of the provisions of Section 5 of the Game Preservation Ordinance, 1951 (Ordinance No. 11 of 1951), as amended:—

- A. To prescribe that the close season within which it shall not be lawful to hunt all game, other than protected game, shall be from the 1st August, 1955, to 30th April, 1956, save as in this Notice is excepted:
- B. To prescribe that it shall be lawful for an owner of land, other than an owner mentioned in Section 10(5) of the Ordinance, to hunt any number of Springbuck during the period 1st May, 1955, to 31st July, 1955.
- C. To withdraw Namakapita partridges from the category of game in respect of the whole Territory for the period 1st May, 1955, to 30th April, 1956.
- D. To prescribe that it shall be lawful to hunt wild duck and geese from 1st May, 1955, to 30th November, 1955.
- E. To add gemsbuck, hartebeest and tsessebe to the category of protected game for the period 1st May, 1955, to 30th April, 1956.
 - (a) To prescribe that it shall be lawful for an owner or occupier of ground in the districts of Outjo, Oijiwongo, Tsumeb, Grootfontein and Okahandja to hunt duiker during the period 1st November, 1955, to 30th April, 1956.
 - (b) To prescribe that only in the districts of Outjo, Oijiwongo, Tsumeb, Grootfontein and Okahandja may duiker be hunted during the period 1st May, 1955, to 31st July, 1955.

BESKERMING VAN WILD.

- B. Voor te skryf dat dit wettig sal wees vir 'n eienaar van grond, buiten 'n eienaar genoem in artikel 10(5) van die Ordonnansie, om enige getal springbokke gedurende die tydperk 1 Mei 1955 tot 31 Julie 1955 te jag;
- C. Namakwaputrys van die lys van wildsoorte vir die tydperk 1 Mei 1955 tot 30 April 1956 ten opsigte van die hele Gebied te verwyder;
- D. Voor te skryf dat dit wettig sal wees om wildeende en gansie gedurende die tydperk 1 Mei 1955 tot 30 November 1955 te jag;
- E. Gem-bokke, hartebeeste en tsessebe by die lys van beskernde wild vir die tydperk 1 Mei 1955 tot 30 April 1956 te voeg:
 - (a) Voor te skryf dat dit wettig sal wees vir 'n eienaar of bewoner van grond om gedurende die tydperk 1 November 1955 tot 30 April 1956 duikers in die distrikte Outjo, Oijiwongo, Tsumeb, Grootfontein en Okahandja te jag;

- G. To prescribe that birds of prey, which are classified as game, and which do damage on a farmyard may be hunted without licence during the period 1st May, 1955, to 30th April, 1956.
